1 Strike everything after the enacting clause and insert the 2 following:

3 "Sec. 1. RCW 28A.655.061 and 2004 c 19 s 101 are each amended to 4 read as follows:

(1) The high school assessment system shall include but ((need)) 5 6 not be limited to the Washington assessment of student learning, 7 opportunities for a student to retake the content areas of the 8 assessment in which the student was not successful, and if approved by 9 the legislature pursuant to subsection (11) of this section, one or 10 more objective alternative assessments for a student to demonstrate 11 achievement of state academic standards. The objective alternative 12 assessments for each content area shall be comparable in rigor to the skills and knowledge that the student must demonstrate on 13 the Washington assessment of student learning for each content area. 14

15 (2) Subject to the conditions in this section, a certificate of 16 academic achievement ((shall be obtained by most students at about the age of sixteen, and)) is evidence that the students have successfully 17 18 the state standard in the content areas included in the met certificate. ((With the exception of students satisfying the 19 20 provisions of RCW 28A.155.045, acquisition of the certificate is 21 required for graduation from a public high school but is not the only 22 requirement for graduation.))

23 (3) Beginning with the graduating class of 2008, with the exception of students satisfying the provisions of RCW 28A.155.045, a student who 24 meets the state standards on the reading, writing, and mathematics 25 26 content areas of the high school Washington assessment of student learning shall earn a certificate of academic achievement. 27 If a student does not successfully meet the state standards in one or more 28 29 content areas required for the certificate of academic achievement, then the student may retake the assessment in the content area up to 30

four times at no cost to the student. If the student successfully 1 2 meets the state standards on a retake of the assessment then the student shall earn a certificate of academic achievement. 3 Once objective alternative assessments are authorized pursuant to subsection 4 5 (11) of this section, a student may use the objective alternative assessments to demonstrate that the student successfully meets the 6 state standards for that content area if the student has retaken the 7 Washington assessment of student learning at least once. 8 If the student successfully meets the state standards on the objective 9 10 alternative assessments then the student shall earn a certificate of academic achievement. The student's transcript shall note whether the 11 certificate of academic achievement was acquired by means of the 12 13 Washington assessment of student learning or by an alternative 14 assessment.

15 (4) Beginning with the graduating class of 2010, a student must 16 meet the state standards in science in addition to the other content 17 areas required under subsection (3) of this section on the Washington 18 assessment of student learning or the objective alternative assessments 19 in order to earn a certificate of academic achievement.

(5) The state board of education may not require the acquisition of the certificate of academic achievement for students in home-based instruction under chapter 28A.200 RCW, for students enrolled in private schools under chapter 28A.195 RCW, or for students satisfying the provisions of RCW 28A.155.045.

(6) A student may retain and use the highest result from each
 successfully completed content area of the high school assessment.

27 (7) Beginning with the graduating class of 2006, the highest scale score and level achieved in each content area on the high school 28 Washington assessment of student learning shall be displayed on a 29 student's transcript. In addition, beginning with the graduating class 30 of 2008, each student shall receive a scholar's designation on his or 31 32 her transcript for each content area in which the student achieves level four the first time the student takes that content area 33 assessment. 34

35 (8) Beginning in 2006, school districts must make available to 36 students the following options:

37 (a) To retake the Washington assessment of student learning up to

1 four times in the content areas in which the student did not meet the 2 state standards if the student is enrolled in a public school; or

3 (b) To retake the Washington assessment of student learning up to 4 four times in the content areas in which the student did not meet the 5 state standards if the student is enrolled in a high school completion 6 program at a community or technical college. The superintendent of 7 public instruction and the state board for community and technical 8 colleges shall jointly identify means by which students in these 9 programs can be assessed.

10 (9) Students who achieve the standard in a content area of the high 11 school assessment but who wish to improve their results shall pay for 12 retaking the assessment, using a uniform cost determined by the 13 superintendent of public instruction.

(10) Subject to available funding, the superintendent shall pilot opportunities for retaking the high school assessment beginning in the 2004-05 school year. Beginning no later than September 2006, opportunities to retake the assessment at least twice a year shall be available to each school district.

(11) The office of the superintendent of public instruction shall 19 develop options for implementing objective alternative assessments, 20 21 which may include an appeals process, for students to demonstrate 22 achievement of the state academic standards. The objective alternative assessments shall be comparable in rigor to the skills and knowledge 23 24 that the student must demonstrate on the Washington assessment of student learning and be objective in its determination of student 25 achievement of the state standards. Before any objective alternative 26 27 assessments are used by a student to demonstrate that the student has met the state standards in a content area required to obtain a 28 certificate, the legislature shall formally approve the use of any 29 objective alternative assessments through the omnibus appropriations 30 act or by statute or concurrent resolution. 31

32 (12) By December 15, 2004, the house of representatives and senate 33 education committees shall obtain information and conclusions from 34 recognized, independent, national assessment experts regarding the 35 validity and reliability of the high school Washington assessment of 36 student learning for making individual student high school graduation 37 determinations. 1 (13) To help assure continued progress in academic achievement as 2 a foundation for high school graduation and to assure that students are 3 on track for high school graduation, each school district shall prepare 4 plans for students as provided in this subsection (13).

5 (a) Student learning plans are required for eighth through twelfth grade students who were not successful on any or all of the content 6 7 areas of the Washington assessment for student learning during the The plan shall 8 previous school year. include the courses, competencies, and other steps needed to be taken by the student to meet 9 state academic standards and stay on track for graduation. 10 This requirement shall be phased in as follows: 11

(i) Beginning no later than the 2004-05 school year ninth gradestudents as described in this subsection (13)(a) shall have a plan.

(ii) Beginning no later than the 2005-06 school year and every year thereafter eighth grade students as described in this subsection (13)(a) shall have a plan.

(iii) The parent or guardian shall be notified, preferably through a parent conference, of the student's results on the Washington assessment of student learning, actions the school intends to take to improve the student's skills in any content area in which the student was unsuccessful, strategies to help them improve their student's skills, and the content of the student's plan.

(iv) Progress made on the student plan shall be reported to the student's parents or guardian at least annually and adjustments to the plan made as necessary.

(b) Beginning with the 2005-06 school year and every year thereafter, all fifth grade students who were not successful in one or more of the content areas of the fourth grade Washington assessment of student learning shall have a student learning plan.

30 (i) The parent or guardian of a student described in this 31 subsection (13)(b) shall be notified, preferably through a parent 32 conference, of the student's results on the Washington assessment of 33 student learning, actions the school intends to take to improve the 34 student's skills in any content area in which the student was 35 unsuccessful, and provide strategies to help them improve their 36 student's skills.

37 (ii) Progress made on the student plan shall be reported to the

student's parents or guardian at least annually and adjustments to the plan made as necessary.

3 Sec. 2. RCW 28A.155.045 and 2004 c 19 s 104 are each amended to 4 read as follows:

Beginning with the graduating class of 2008, students served under 5 6 this chapter, who are not appropriately assessed by the high school 7 Washington assessment system as defined in RCW 28A.655.061, even with accommodations, may earn a certificate of individual achievement. 8 The 9 certificate may be earned using multiple ways to demonstrate skills and 10 abilities commensurate with their individual education programs. The 11 determination of whether the high school assessment system is appropriate shall be made by the student's individual education program 12 team. ((For these students, the certificate of individual achievement 13 is required for graduation from a public high school, but need not be 14 15 the only requirement for graduation.)) When measures other than the 16 high school assessment system as defined in RCW 28A.655.061 are used, 17 the measures shall be in agreement with the appropriate educational opportunity provided for the student as required by this chapter. 18 The superintendent of public instruction shall develop the guidelines for 19 20 determining which students should not be required to participate in the 21 high school assessment system and which types of assessments are 22 appropriate to use.

When measures other than the high school assessment system as defined in RCW 28A.655.061 are used for high school graduation purposes, the student's high school transcript shall note whether that student has earned a certificate of individual achievement.

Nothing in this section shall be construed to deny a student the right to participation in the high school assessment system as defined in RCW 28A.655.061, and, upon successfully meeting the high school standard, receipt of the certificate of academic achievement.

31 **Sec. 3.** RCW 28A.230.090 and 2005 c 205 s 3 are each amended to 32 read as follows:

(1) The state board of education shall establish high schoolgraduation requirements or equivalencies for students.

35 (a) Any course in Washington state history and government used to

1 fulfill high school graduation requirements shall consider including 2 information on the culture, history, and government of the American 3 Indian peoples who were the first inhabitants of the state.

4 (b) ((The certificate of academic achievement requirements under
5 RCW 28A.655.061 or the certificate of individual achievement
6 requirements under RCW 28A.155.045 are required for graduation from a
7 public high school but are not the only requirements for graduation.

8 (c)) Any decision on whether a student has met the state board's 9 high school graduation requirements for a high school and beyond plan 10 shall remain at the local level.

11 (2) In recognition of the statutory authority of the state board of 12 education to establish and enforce minimum high school graduation 13 requirements, the state board shall periodically reevaluate the 14 graduation requirements and shall report such findings to the 15 legislature in a timely manner as determined by the state board.

16 (3) Pursuant to any requirement for instruction in languages other 17 than English established by the state board of education or a local 18 school district, or both, for purposes of high school graduation, 19 students who receive instruction in American sign language or one or 20 more American Indian languages shall be considered to have satisfied 21 the state or local school district graduation requirement for 22 instruction in one or more languages other than English.

(4) If requested by the student and his or her family, a student who has completed high school courses before attending high school shall be given high school credit which shall be applied to fulfilling high school graduation requirements if:

(a) The course was taken with high school students, if the academic
level of the course exceeds the requirements for seventh and eighth
grade classes, and the student has successfully passed by completing
the same course requirements and examinations as the high school
students enrolled in the class; or

32 (b) The academic level of the course exceeds the requirements for 33 seventh and eighth grade classes and the course would qualify for high 34 school credit, because the course is similar or equivalent to a course 35 offered at a high school in the district as determined by the school 36 district board of directors.

37 (5) Students who have taken and successfully completed high school

1 courses under the circumstances in subsection (4) of this section shall 2 not be required to take an additional competency examination or perform 3 any other additional assignment to receive credit.

4 (6) At the college or university level, five quarter or three
5 semester hours equals one high school credit."
