- Strike everything after the enacting clause and insert the following:
- 3 "NEW SECTION. Sec. 1. A new section is added to chapter 41.45 RCW 4 to read as follows:
- 5 The pension funding stabilization account is created in the state 6 treasury. Moneys in the account may be spent only after appropriation.
- 7 Expenditures from the account may be used only for payment of state
- 8 government employer contributions for members of the public employees'
- 9 retirement system, the teachers' retirement system, the school
- 10 employees' retirement system, and the public safety employees'
- 11 retirement system. The account may not be used to pay for any new
- 12 benefit or for any benefit increase that takes effect after July 1,

- NEW SECTION. Sec. 2. A new section is added to chapter 41.45 RCW to read as follows:
- (1) The state investment board has the full power to invest, reinvest, manage, contract, sell, or exchange investment moneys in the pension funding stabilization account. The pension funding stabilization account shall be considered to be a public pension or
- 27 retirement fund within the meaning of Article XXIX, section 1 of the
- 28 state Constitution, for the purpose of determining eligible investments
- 29 and deposits of the moneys therein. All investment and operating costs

- associated with the investment of money shall be paid pursuant to RCW 43.33A.160 and 43.84.160. With the exception of these expenses, the earnings from the investment of the money shall be retained by the account.
 - (2) All investments made by the state investment board shall be made with the exercise of that degree of judgment and care pursuant to RCW 43.33A.140 and the investment policies established by the state investment board.
- 9 (3) As deemed appropriate by the state investment board, moneys in 10 the account may be commingled for investment with other funds subject 11 to investment by the board.
- NEW SECTION. Sec. 3. A new section is added to chapter 41.45 RCW to read as follows:
 - (1) It is the intent of the legislature to provide for the systematic funding of the plan 1 unfunded accrued actuarial liabilities in a manner that promotes contribution rate adequacy and stability for the affected systems. The rates established in this section shall be collected in addition to the rates established pursuant to RCW 41.45.062.
 - (2) Beginning September 1, 2006, a 1.29 percent contribution is established as part of the basic state and employer contribution rate for the teachers' retirement system, to be used for the sole purpose of amortizing the unfunded accrued actuarial liability in the teachers' retirement system plan 1.
 - (3) Beginning September 1, 2006, a 0.87 percent contribution is established as part of the basic state and employer contribution rate for the school employees' retirement system, to be used for the sole purpose of amortizing the unfunded accrued actuarial liability in the public employees' retirement system plan 1.
 - (4) Beginning January 1, 2007, a 1.77 percent contribution is established as part of the basic state and employer contribution rate for the public employees' retirement system and the public safety employees' retirement system, to be used for the sole purpose of amortizing the unfunded accrued actuarial liability in the public employees' retirement system plan 1.
 - (5) The contribution rates in this section shall be collected through June 30, 2007, for the public employees' retirement system and the public safety employees' retirement system and August 31, 2007, for

- the teachers' retirement system and the school employees' retirement system.
- (6) Upon completion of the 2005 actuarial valuation, the pension 3 funding council and the state actuary shall review the contribution 4 rates for the plan 1 unfunded actuarial accrued liability for fiscal 5 6 year 2008 and fiscal year 2009 and by September 30, 2006, the pension funding council shall adopt contribution rates to complete the three-7 year phase-in schedule, adjusted for any material changes in benefits 8 or actuarial assumptions, methods, and experience. The expected 9 present value of projected contributions during the three-year phase-in 10 period shall be the same as the expected present value of projected 11 contributions that would have been collected without the phase-in, as 12 determined by the state actuary and adjusted for any material changes 13
- NEW SECTION. Sec. 4. The sum of three hundred fifty million dollars is appropriated for the fiscal year ending June 30, 2006, from the general fund to the pension funding stabilization account for the purposes of section 1 of this act.

in benefits or actuarial assumptions, methods, or experience.

- NEW SECTION. Sec. 5. The sum of two hundred million dollars is appropriated for the fiscal year ending June 30, 2006, from the general fund to the health services account for the purposes of providing fiscal stability for the account.
- NEW SECTION. Sec. 6. The sum of two hundred seventy-five million dollars is appropriated for the fiscal year ending June 30, 2006, from the general fund to the student achievement fund for the purposes of providing fiscal stability for the fund.
- 27 **Sec. 7.** RCW 43.135.025 and 2000 2nd sp.s. c 2 s 1 are each amended to read as follows:
 - (1) The state shall not expend from the general fund during any fiscal year state moneys in excess of the state expenditure limit established under this chapter.
- (2) Except pursuant to a declaration of emergency under RCW 43.135.035 or pursuant to an appropriation under RCW 43.135.045(4)(b), the state treasurer shall not issue or redeem any check, warrant, or voucher that will result in a state general fund expenditure for any

- fiscal year in excess of the state expenditure limit established under this chapter. A violation of this subsection constitutes a violation of RCW 43.88.290 and shall subject the state treasurer to the penalties provided in RCW 43.88.300.
 - (3) The state expenditure limit for any fiscal year shall be the previous fiscal year's state expenditure limit increased by a percentage rate that equals the fiscal growth factor.
 - (4) For purposes of computing the state expenditure limit for the fiscal year beginning July 1, 1995, the phrase "the previous fiscal year's state expenditure limit" means the total state expenditures from the state general fund, not including federal funds, for the fiscal year beginning July 1, 1989, plus the fiscal growth factor. This calculation is then computed for the state expenditure limit for fiscal years 1992, 1993, 1994, and 1995, and as required under RCW 43.135.035(4).
 - (5) A state expenditure limit committee is established for the purpose of determining and adjusting the state expenditure limit as provided in this chapter. The members of the state expenditure limit committee are the director of financial management, the attorney general or the attorney general's designee, and the chairs of the senate committee on ways and means and the house of representatives committee on appropriations. All actions of the state expenditure limit committee taken pursuant to this chapter require an affirmative vote of at least three members.
- 25 (6) Each November, the state expenditure limit committee shall 26 adjust the expenditure limit for the preceding fiscal year based on actual expenditures and known changes in the fiscal growth factor and 27 then project an expenditure limit for the next two fiscal years. 28 29 calculating the expenditure limit for fiscal year 2006, the calculation shall be the expenditure limit established by the state expenditure 30 31 limit committee in November 2005 adjusted as provided by this chapter and adjusted to include the fiscal year 2006 state general fund 32 appropriations to the pension funding stabilization account, the health 33 services account, and the student achievement fund in chapter . . ., 34 Laws of 2006 (this act). If, by November 30th, the state expenditure 35 36 limit committee has not adopted the expenditure limit adjustment and projected expenditure limit as provided in subsection (5) of this 37 section, the attorney general or his or her designee shall adjust or 38 39 project the expenditure limit, as necessary.

- (8) "Inflation" means the percentage change in the implicit price deflator for the United States for each fiscal year as published by the federal bureau of labor statistics.
- (9) "Population change" means the percentage change in state population for each fiscal year as reported by the office of financial management.
- 10 **Sec. 8.** RCW 43.135.035 and 2005 c 72 s 2 are each amended to read 11 as follows:
- (1) After July 1, 1995, any action or combination of actions by the 12 13 legislature that raises state revenue or requires revenue-neutral tax shifts may be taken only if approved by a two-thirds vote of each 14 15 house, and then only if state expenditures in any fiscal year, 16 including the new revenue, will not exceed the state expenditure limits established under this chapter. However, for legislation enacted 17 between the effective date of this 2005 act and June 30, 2007, any 18 action or combination of actions by the legislature that raises state 19 20 revenue or requires revenue-neutral tax shifts may be taken with the approval of a majority of members elected to each house, so long as 21 state expenditures in any fiscal year, including the new revenue, will 22 not exceed the state expenditure limits established under this chapter. 23
 - (2)(a) If the legislative action under subsection (1) of this section will result in expenditures in excess of the state expenditure limit, then the action of the legislature shall not take effect until approved by a vote of the people at a November general election. The state expenditure limit committee shall adjust the state expenditure limit by the amount of additional revenue approved by the voters under this section. This adjustment shall not exceed the amount of revenue generated by the legislative action during the first full fiscal year in which it is in effect. The state expenditure limit shall be adjusted downward upon expiration or repeal of the legislative action.
 - (b) The ballot title for any vote of the people required under this section shall be substantially as follows:
- "Shall taxes be imposed on in order to allow a spending increase above last year's authorized spending adjusted for inflation and population increases?"

- (3)(a) The state expenditure limit may be exceeded upon declaration of an emergency for a period not to exceed twenty-four months by a law approved by a two-thirds vote of each house of the legislature and signed by the governor. The law shall set forth the nature of the emergency, which is limited to natural disasters that require immediate government action to alleviate human suffering and provide humanitarian assistance. The state expenditure limit may be exceeded for no more than twenty-four months following the declaration of the emergency and only for the purposes contained in the emergency declaration.
- (b) Additional taxes required for an emergency under this section may be imposed only until thirty days following the next general election, unless an extension is approved at that general election. The additional taxes shall expire upon expiration of the declaration of emergency. The legislature shall not impose additional taxes for emergency purposes under this subsection unless funds in the education construction fund have been exhausted.
- (c) The state or any political subdivision of the state shall not impose any tax on intangible property listed in RCW 84.36.070 as that statute exists on January 1, 1993.
- (4) If the cost of any state program or function is shifted from 20 21 the state general fund on or after January 1, 1993, to another source of funding, or if moneys are transferred from the state general fund to 22 another fund or account, the state expenditure limit committee, acting 23 24 pursuant to RCW 43.135.025(5), shall lower the state expenditure limit 25 to reflect the shift. For purposes of this section, expenditures from the pension funding stabilization account shall not be considered a 26 state program cost shift from the state general fund to another 27 28 account. For the purposes of this section, a transfer of money from 29 the state general fund to another fund or account includes any state legislative action taken that has the effect of reducing revenues from 30 31 a particular source, where such revenues would otherwise be deposited 32 into the state general fund, while increasing the revenues from that particular source to another state or local government account. 33 34 subsection does not apply to the dedication or use of lottery revenues 35 under RCW 67.70.240(3) or property taxes under RCW 84.52.068, in 36 support of education or education expenditures.
 - (5) If the cost of any state program or function is shifted to the state general fund on or after January 1, 2000, from another source of funding, or if moneys are transferred to the state general fund from

- - (1) All earnings of investments of surplus balances in the state treasury shall be deposited to the treasury income account, which account is hereby established in the state treasury.
 - (2) The treasury income account shall be utilized to pay or receive funds associated with federal programs as required by the federal cash management improvement act of 1990. The treasury income account is subject in all respects to chapter 43.88 RCW, but no appropriation is required for refunds or allocations of interest earnings required by the cash management improvement act. Refunds of interest to the federal treasury required under the cash management improvement act fall under RCW 43.88.180 and shall not require appropriation. The office of financial management shall determine the amounts due to or from the federal government pursuant to the cash management improvement act. The office of financial management may direct transfers of funds between accounts as deemed necessary to implement the provisions of the cash management improvement act, and this subsection.  - (3) Except for the provisions of RCW 43.84.160, the treasury income account may be utilized for the payment of purchased banking services on behalf of treasury funds including, but not limited to, depository, safekeeping, and disbursement functions for the state treasury and affected state agencies. The treasury income account is subject in all respects to chapter 43.88 RCW, but no appropriation is required for payments to financial institutions. Payments shall occur prior to distribution of earnings set forth in subsection (4) of this section.
 - (4) Monthly, the state treasurer shall distribute the earnings credited to the treasury income account. The state treasurer shall credit the general fund with all the earnings credited to the treasury income account except:
 - (a) The following accounts and funds shall receive their proportionate share of earnings based upon each account's and fund's
