Background:

Washington operates on a biennial budget cycle. The Legislature authorizes expenditures for capital needs in the Capital Budget for a two-year period, and authorizes bond sales through passage of a bond bill associated with the Capital Budget to fund a portion of these expenditures. The current Capital Budget covers the period from July 1, 2005, through June 30, 2007.

House Bill Report - 1 - ESSB 6384

Summary of Amended Bill:

Supplemental Capital Budget appropriations of \$296.4 million are made for the 2005-07 biennium. (See budget highlights.) The Supplemental Capital Budget appropriates \$122.8 million for new projects from state general obligation bonds. Of this amount, \$91.8 million requires the passage of a bond bill.

Amended Bill Compared to Engrossed Substitute Bill:

The amended bill makes a variety of changes to the engrossed substitute bill. (See budget highlights.)

Appropriation: The sum of \$296.4 million in new appropriations.

Fiscal Note: Not requested.

Effective Date of Amended Bill: The bill contains an emergency clause and takes effect immediately.
