1            AN ACT Relating to session law publication; amending RCW 44.20.030  
2 and 44.20.050; adding a new section to chapter 40.04 RCW; and repealing  
3 RCW 40.04.035 and 40.04.040.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5            **Sec. 1.** RCW 44.20.030 and 1982 1st ex.s. c 32 s 3 are each amended  
6 to read as follows:

7            The statute law committee, after ~~((each and))~~ every legislative  
8 session, whether regular or ~~((extraordinary))~~ special, shall ~~((cause to~~  
9 ~~be reproduced or printed))~~ have available, on demand, for temporary use  
10 separate copies of each act filed in the office of secretary of state  
11 within ten days after the filing thereof.

12            ~~((The committee shall cause to be reproduced or printed three~~  
13 ~~thousand copies or such additional number as may be necessary of~~  
14 ~~temporary bound sets of all acts filed in the office of secretary of~~  
15 ~~state within seventy five days after the final adjournment of the~~  
16 ~~legislature for that year.))~~

17            **Sec. 2.** RCW 44.20.050 and 1982 1st ex.s. c 32 s 4 are each amended  
18 to read as follows:

1       When all of the acts of any session of the legislature and  
2 initiative measures enacted by the people since the next preceding  
3 session have been certified to the statute law committee, the code  
4 reviser employed by the statute law committee shall make the proper  
5 headings and index of such acts or laws and, after such work has been  
6 completed, the statute law committee shall have published and bound  
7 (~~in good buckram at least six hundred copies or such additional~~)  
8 within seventy-five days after final adjournment of the legislature for  
9 that year as many copies as (~~may be~~) necessary of such acts and laws,  
10 with such headings and indexes, and such other matter as may be deemed  
11 essential, including a title page showing the session at which such  
12 acts were passed, the date of convening and adjournment of the session,  
13 and any other matter deemed proper, including a certificate by the  
14 secretary of state of such referendum measures as may have been enacted  
15 by the people since the next preceding session.

16       NEW SECTION.   **Sec. 3.** A new section is added to chapter 40.04 RCW  
17 to read as follows:

18       The statute law committee, after each legislative session, shall  
19 distribute, sell, or exchange session laws as required under this  
20 section.

21       (1) One set shall be given to the following: The United States  
22 supreme court library; each state adult correctional institution; each  
23 state mental institution; the state historical society; the state bar  
24 association; the Olympia press corps library; the University of  
25 Washington library; the library of each of the regional universities;  
26 The Evergreen State College library; the Washington State University  
27 library; each county law library; and the municipal reference branch of  
28 the Seattle public library.

29       (2) One set shall be given to the following upon their request:  
30 Each member of the legislature; each state agency and its divisions;  
31 each state commission, committee, board, and council; each community  
32 college; each assistant attorney general; each member of the United  
33 States senate and house of representatives from this state; each state  
34 official whose office is created by the Constitution; each prosecuting  
35 attorney; and each public library in cities of the first class.

36       (3) Two sets shall be given to the following: The administrator

1 for the courts; the library of congress; the law libraries of any  
2 accredited law schools established in this state; and the governor.

3 (4) Two sets shall be given to the following upon their request:  
4 Each United States district court in the state; and each office and  
5 branch office of the United States district attorneys in this state.

6 (5) Three sets shall be given to the library of the circuit court  
7 of appeals of the ninth circuit, upon its request.

8 (6) The following may request, and receive at no charge, as many  
9 sets as are needed for their official business: The senate and house  
10 of representatives; each county auditor, who shall receive and  
11 distribute sets for use by his or her county's officials; the office of  
12 the code reviser; the secretary of the senate; the chief clerk of the  
13 house of representatives; the supreme court; each court of appeals in  
14 the state; the superior courts; the state library; and the state law  
15 library.

16 (7) Surplus copies of the session laws shall be sold and delivered  
17 by the statute law committee, in which case the price of the bound  
18 volumes shall be sufficient to cover costs. All money received from  
19 the sale of the session law sets shall be paid into the state treasury  
20 for the general fund.

21 (8) The statute law committee may exchange session law sets for  
22 similar laws or legal materials of other states, territories, and  
23 governments, and make such other distribution of the sets as in its  
24 judgment seems proper.

25 NEW SECTION. **Sec. 4.** The following acts or parts of acts are each  
26 repealed:

27 (1) RCW 40.04.035 (Temporary edition of session laws--Distribution  
28 and sale) and 1995 c 24 s 2 & 1982 1st ex.s. c 32 s 5; and

29 (2) RCW 40.04.040 (Permanent edition of session laws--Distribution,  
30 sale, exchange--Sale of surplus copies) and 1995 c 24 s 3, 1982 1st  
31 ex.s. c 32 s 1, 1981 c 162 s 1, 1977 ex.s. c 169 s 94, 1973 c 33 s 1,  
32 1969 c 6 s 8, & 1941 c 150 s 4.
