A society or organization which is registered with the secretary of state or the federal internal revenue service as a 17 nonprofit organization ((may)) shall submit such registration, upon 18 request, as proof that it is a not-for-profit group. 19
- 20 Sec. 2. RCW 66.28.010 and 2006 c 330 s 28, 2006 c 92 s 1, and 2006 c 43 s 1 are each reenacted and amended to read as follows: 21
- 22 (1)(a) No manufacturer, importer, distributor, or authorized representative, or person financially interested, directly or 23 indirectly, in such business; whether resident or nonresident, shall 24 25 have any financial interest, direct or indirect, in any licensed retail 26 business, unless the retail business is owned by a corporation in which a manufacturer or importer has no direct stock ownership and there are 27 28 no interlocking officers and directors, the retail license is held by 29 a corporation that is not owned directly or indirectly by a

manufacturer or importer, the sales of liquor are incidental to the 1 2 primary activity of operating the property as a hotel, alcoholic beverages produced by the manufacturer or importer or 3 subsidiaries are not sold at the licensed premises, and the board 4 reviews the ownership and proposed method of operation of all involved 5 entities and determines that there will not be an unacceptable level of 6 7 control or undue influence over the operation or the retail licensee; nor shall any manufacturer, importer, distributor, or authorized 8 representative own any of the property upon which such licensed persons 9 10 conduct their business; nor shall any such licensed person, under any arrangement whatsoever, conduct his or her business upon property in 11 12 any manufacturer, importer, distributor, or authorized 13 representative has any interest unless title to that property is owned by a corporation in which a manufacturer has no direct stock ownership 14 and there are no interlocking officers or directors, the retail license 15 is held by a corporation that is not owned directly or indirectly by 16 the manufacturer, the sales of liquor are incidental to the primary 17 activity of operating the property either as a hotel or as an 18 amphitheater offering live musical and similar live entertainment 19 activities to the public, alcoholic beverages produced by the 20 21 manufacturer or any of its subsidiaries are not sold at the licensed 22 premises, and the board reviews the ownership and proposed method of operation of all involved entities and determines that there will not 23 24 be an unacceptable level of control or undue influence over the operation of the retail licensee. Except as provided in subsection (3) 25 of this section, no manufacturer, importer, distributor, or authorized 26 27 representative shall advance moneys or moneys' worth to a licensed person under an arrangement, nor shall such licensed person receive, 28 under an arrangement, an advance of moneys or moneys' worth. "Person" 29 as used in this section only shall not include those state or federally 30 chartered banks, state or federally chartered savings and loan 31 associations, state or federally chartered mutual savings banks, or 32 institutional investors which are not controlled directly or indirectly 33 by a manufacturer, importer, distributor, or authorized representative 34 35 as long as the bank, savings and loan association, or institutional 36 investor does not influence or attempt to influence the purchasing 37 practices of the retailer with respect to alcoholic beverages. Except as otherwise provided in this section, no manufacturer, importer, 38

distributor, or authorized representative shall be eligible to receive or hold a retail license under this title, nor shall such manufacturer, importer, distributor, or authorized representative sell at retail any liquor as herein defined. A corporation granted an exemption under this subsection may use debt instruments issued in connection with financing construction or operations of its facilities.

- (b) Nothing in this section shall prohibit a licensed domestic brewery or microbrewery from being licensed as a retailer pursuant to chapter 66.24 RCW for the purpose of selling beer or wine at retail on the brewery premises and at one additional off-site retail only location and nothing in this section shall prohibit a domestic winery from being licensed as a retailer pursuant to chapter 66.24 RCW for the purpose of selling beer or wine at retail on the winery premises. Such beer and wine so sold at retail shall be subject to the taxes imposed by RCW 66.24.290 and 66.24.210 and to reporting and bonding requirements as prescribed by regulations adopted by the board pursuant to chapter 34.05 RCW, and beer and wine that is not produced by the brewery or winery shall be purchased from a licensed beer or wine distributor.
- (c) Nothing in this section shall prohibit a licensed distiller, domestic brewery, microbrewery, domestic winery, or a lessee of a licensed domestic brewer, microbrewery, or domestic winery, from being licensed as a spirits, beer, and wine restaurant pursuant to chapter 66.24 RCW for the purpose of selling liquor at a spirits, beer, and wine restaurant premises on the property on which the primary manufacturing facility of the licensed distiller, domestic brewer, microbrewery, or domestic winery is located or on contiguous property leased by the licensed distiller, domestic brewer, microbrewery, or domestic winery as prescribed by rules adopted by the board pursuant to chapter 34.05 RCW. This section does not prohibit a brewery or microbrewery holding a spirits, beer, and wine restaurant license or a beer and/or wine license under chapter 66.24 RCW operated on the premises of the brewery or microbrewery from holding a second retail only license at a location separate from the premises of the brewery or microbrewery.
- 36 (d) Nothing in this section prohibits retail licensees with a 37 caterer's endorsement issued under RCW 66.24.320 or 66.24.420 from 38 operating on a domestic winery premises.

(e) Nothing in this section prohibits an organization qualifying under RCW 66.24.375 formed for the purpose of constructing and operating a facility to promote Washington wines from holding retail licenses on the facility property or leasing all or any portion of such facility property to a retail licensee on the facility property if the members of the board of directors or officers of the board for the organization include officers, directors, owners, or employees of a licensed domestic winery. Financing for the construction of the facility must include both public and private money.

- (f) Nothing in this section prohibits a bona fide charitable nonprofit society or association registered ((as a)) under section 501(c)(3) ((under)) of the internal revenue code, or a local wine industry association registered under section 501(c)(6) of the internal revenue code as it exists on the effective date of this section, and having an officer, director, owner, or employee of a licensed domestic winery or a wine certificate of approval holder on its board of directors from holding a special occasion license under RCW 66.24.380.
- (g) Nothing in this section prohibits domestic wineries and retailers licensed under chapter 66.24 RCW from jointly producing brochures and materials promoting tourism in Washington state which contain information regarding retail licensees, domestic wineries, and their products.
- (h) Nothing in this section prohibits domestic wineries and retail licensees from identifying the wineries on private labels authorized under RCW 66.24.400, 66.24.425, and 66.24.450.
- (i) Until July 1, 2007, nothing in this section prohibits a nonprofit statewide organization of microbreweries formed for the purpose of promoting Washington's craft beer industry as a trade association registered as a 501(c) with the internal revenue service from holding a special occasion license to conduct up to six beer festivals.
- (2) Financial interest, direct or indirect, as used in this section, shall include any interest, whether by stock ownership, mortgage, lien, or through interlocking directors, or otherwise. Pursuant to rules promulgated by the board in accordance with chapter 34.05 RCW manufacturers, distributors, and importers may perform, and retailers may accept the service of building, rotating and restocking case displays and stock room inventories; rotating and rearranging can

- (3)(a) This section does not prohibit a manufacturer, importer, or 5 distributor from providing services to a special occasion licensee for: 6 7 (i) Installation of draft beer dispensing equipment or advertising, (ii) advertising, pouring, or dispensing of beer or wine at a beer or 8 wine tasting exhibition or judging event, or (iii) a special occasion 9 licensee from receiving any such services as may be provided by a 10 manufacturer, importer, or distributor. - (3) The board shall have discretion to issue spirits, beer, and wine restaurant licenses outside of cities and towns in the state of Washington. The purpose of this subsection is to enable the board, in its discretion, to license in areas outside of cities and towns and other communities, establishments which are operated and maintained primarily for the benefit of tourists, vacationers and travelers, and also golf and country clubs, and common carriers operating dining, club and buffet cars, or boats.
- (4) The total number of spirits, beer, and wine restaurant licenses issued in the state of Washington by the board, not including spirits, beer, and wine private club licenses, shall not in the aggregate at any time exceed one license for each one thousand ((four)) three hundred ((fifty)) of population in the state, determined according to the yearly population determination developed by the office of financial management pursuant to RCW 43.62.030.

- (7) Licensees under this section that hold a caterer's endorsement are allowed to use this endorsement on a domestic winery premises or on the premises of a passenger vessel <u>and may store liquor at such premises under conditions established by the board</u> under the following conditions:
- (a) Agreements between the domestic winery or passenger vessel, as

- the case may be, and the retail licensee shall be in writing, contain no exclusivity clauses regarding the ((alcohol)) alcoholic beverages to be served, and be filed with the board; and

There shall be a beer and/or wine restaurant license to sell beer, including strong beer, or wine, or both, at retail, for consumption on the premises. A patron of the licensee may remove from the premises, recorked or recapped in its original container, any portion of wine that was purchased for consumption with a meal.

- (1) The annual fee shall be two hundred dollars for the beer license, two hundred dollars for the wine license, or four hundred dollars for a combination beer and wine license.
- (2)(a) The board may issue a caterer's endorsement to this license to allow the licensee to remove from the liquor stocks at the licensed premises, only those types of liquor that are authorized under the onpremises license privileges for sale and service at event locations at a specified date and, except as provided in subsection (3) of this section, place not currently licensed by the board. - (1) "Alcohol" is that substance known as ethyl alcohol, hydrated oxide of ethyl, or spirit of wine, which is commonly produced by the fermentation or distillation of grain, starch, molasses, or sugar, or other substances including all dilutions and mixtures of this The term "alcohol" does not include alcohol in the substance. possession of a manufacturer or distiller of alcohol fuel, as described in RCW 66.12.130, which is intended to be denatured and used as a fuel for use in motor vehicles, farm implements, and machines or implements of husbandry.
 - (2) "Authorized representative" means a person who:
- (a) Is required to have a federal basic permit issued pursuant to 14 the federal alcohol administration act, 27 U.S.C. Sec. 204; 15
 - (b) Has its business located in the United States outside of the state of Washington;

Liquor does not include confections or food products that contain one percent or less of alcohol by weight.

- (25) "Malt beverage" or "malt liquor" means any beverage such as beer, ale, lager beer, stout, and porter obtained by the alcoholic fermentation of an infusion or decoction of pure hops, or pure extract of hops and pure barley malt or other wholesome grain or cereal in pure water containing not more than eight percent of alcohol by weight, and not less than one-half of one percent of alcohol by volume. For the purposes of this title, any such beverage containing more than eight percent of alcohol by weight shall be referred to as "strong beer."

- 30 (g) Place in guest rooms at check-in, a complimentary bottle of 31 beer, including strong beer, or wine in a manufacturer-sealed 32 container, and make a reference to this service in promotional 33 material.

entertainment, or conventions, or a combination thereof, with more than 1 2 one place where liquor is to be dispensed and sold, such license shall be issued upon the payment of the annual fee, which shall be a master 3 license and shall permit such sale within and from one such place. 4 Such license may be extended to additional places on the premises at 5 the discretion of the board and a duplicate license may be issued for 6 each such additional place. The holder of a master license for a 7 dining place at such a publicly or privately owned civic or convention 8 center must maintain in a substantial manner at least one place on the 9 premises for preparing, cooking, and serving of complete meals, and 10 food service shall be available on request in other licensed places on 11 12 the premises. An additional license fee of ten dollars shall be 13 required for such duplicate licenses.

((e) Where the license shall be issued to any corporation, association or person operating more than one building containing dining places at privately owned facilities which are open to the public and where there is a continuity of ownership of all adjacent property, such license shall be issued upon the payment of an annual fee which shall be a master license and shall permit such sale within and from one such place. Such license may be extended to the additional dining places on the property or, in the case of a spirits, beer, and wine restaurant licensed hotel, property owned or controlled by leasehold interest by that hotel for use as a conference or convention center or banquet facility open to the general public for special events in the same metropolitan area, at the discretion of the board and a duplicate license may be issued for each additional place. The holder of the master license for the dining place shall not offer alcoholic beverages for sale, service, and consumption at the additional place unless food service is available at both the location of the master license and the duplicate license. An additional license fee of twenty dollars shall be required for such duplicate licenses.))

(2) The board, so far as in its judgment is reasonably possible, shall confine spirits, beer, and wine restaurant licenses to the business districts of cities and towns and other communities, and not grant such licenses in residential districts, nor within the immediate vicinity of schools, without being limited in the administration of this subsection to any specific distance requirements.

(3) The board shall have discretion to issue spirits, beer, and wine restaurant licenses outside of cities and towns in the state of Washington. The purpose of this subsection is to enable the board, in its discretion, to license in areas outside of cities and towns and other communities, establishments which are operated and maintained primarily for the benefit of tourists, vacationers and travelers, and also golf and country clubs, and common carriers operating dining, club and buffet cars, or boats.

- (4) The total number of spirits, beer, and wine restaurant licenses issued in the state of Washington by the board, not including spirits, beer, and wine private club licenses, shall not in the aggregate at any time exceed one license for each one thousand four hundred fifty of population in the state, determined according to the yearly population determination developed by the office of financial management pursuant to RCW 43.62.030.
- (5) Notwithstanding the provisions of subsection (4) of this section, the board shall refuse a spirits, beer, and wine restaurant license to any applicant if in the opinion of the board the spirits, beer, and wine restaurant licenses already granted for the particular locality are adequate for the reasonable needs of the community.
- (6)(a) The board may issue a caterer's endorsement to this license to allow the licensee to remove the liquor stocks at the licensed premises, for use as liquor for sale and service at event locations at a specified date and, except as provided in subsection (7) of this section, place not currently licensed by the board. If the event is open to the public, it must be sponsored by a society or organization as defined by RCW 66.24.375. If attendance at the event is limited to members or invited guests of the sponsoring individual, society, or organization, the requirement that the sponsor must be a society or organization as defined by RCW 66.24.375 is waived. Cost of the endorsement is three hundred fifty dollars.
- (b) The holder of this license with catering endorsement shall, if requested by the board, notify the board or its designee of the date, time, place, and location of any catered event. Upon request, the licensee shall provide to the board all necessary or requested information concerning the society or organization that will be holding the function at which the endorsed license will be utilized.

- 1 (7) Licensees under this section that hold a caterer's endorsement 2 are allowed to use this endorsement on a domestic winery premises or on 3 the premises of a passenger vessel under the following conditions:
- 4 (a) Agreements between the domestic winery or passenger vessel, as 5 the case may be, and the retail licensee shall be in writing, contain 6 no exclusivity clauses regarding the alcohol beverages to be served, 7 and be filed with the board; and
- 8 (b) The domestic winery or passenger vessel, as the case may be, 9 and the retail licensee shall be separately contracted and compensated 10 by the persons sponsoring the event for their respective services.
- 11 **Sec. 20.** RCW 66.24.440 and 1998 c 126 s 8 are each amended to read 12 as follows:
- Each spirits, beer, and wine restaurant, spirits, beer, and wine private club, <u>hotel</u>, and sports entertainment facility licensee shall be entitled to purchase any spirituous liquor items salable under such license from the board at a discount of not less than fifteen percent from the retail price fixed by the board, together with all taxes.
