ESHB 1052 - S AMD 403

1 Strike everything after the enacting clause and insert the 2 following:

- "NEW SECTION. Sec. 1. The legislature finds that the legislative 3 4 youth advisory council provides a unique opportunity for middle and 5 high school students to be actively involved in government. Council 6 members not only learn about, but exercise, the core values and 7 democratic principles of our state and nation, along with the rights 8 and responsibilities of citizenship and democratic civic involvement. 9 As such, they are engaged in authentic practice of the essential academic learning requirements in civics. In the short time since its 10 11 creation, the legislative youth advisory council has studied, debated, 12 and begun to formulate positions and recommendations on such important topics as education reform, school finance, public school learning 13 environments, health and fitness education, and standardized testing. 14 15 The legislature continues to stress the importance of civics education 16 and support the type of civic involvement by students exemplified by the legislative youth advisory council. 17
- 18 **Sec. 2.** RCW 28A.300.801 and 2005 c 355 s 1 are each amended to 19 read as follows:
 - (1) The legislative youth advisory council is established to examine issues of importance to youth, including but not limited to education, employment, strategies to increase youth participation in state and municipal government, safe environments for youth, substance abuse, emotional and physical health, foster care, poverty, homelessness, and youth access to services on a statewide and municipal basis.
- 27 (2) The council consists of twenty-two members as provided in this 28 subsection who, at the time of appointment, are aged fourteen to 29 eighteen. The council shall select a chair from among its members.

- 1 ((a) Five members shall be selected by each of the two major 2 caucuses in the senate, appointed by the secretary of the senate.
 - (b) Five members shall be selected by each of the two major caucuses in the house of representatives, appointed by the chief clerk of the house of representatives.
 - (c) The governor shall appoint two members.))

- (3) Except for initial members, members shall serve two-year terms, and if eligible, may be reappointed for subsequent two-year terms. One-half of the initial members shall be appointed to one-year terms, and these appointments shall be made in such a way as to preserve overall representation on the committee.
- (4)(a) By July 2, 2007, and annually thereafter, students may apply to be considered for participation in the program by completing an online application form and submitting the application to the legislative youth advisory council. The council may develop selection criteria and an application review process. The council shall recommend candidates whose names will be submitted to the office of the lieutenant governor shall notify all applicants of the final selections.
- 20 <u>(b) The office of the lieutenant governor shall make the</u> 21 <u>application available on the lieutenant governor's web site.</u>
 - (5) The council shall have the following duties:
 - (a) Advising the legislature on proposed and pending legislation, including state budget expenditures and policy matters relating to youth;
 - (b) Advising the standing committees of the legislature and study commissions, committees, and task forces regarding issues relating to youth;
 - (c) Conducting periodic seminars for its members regarding leadership, government, and the legislature; ((and))
- 31 (d) <u>Accepting grants and donations from public and private sources</u> 32 to support the activities of the council; and
 - (e) Reporting annually by December $1\underline{st}$ to the legislature on its activities, including proposed legislation that implements recommendations of the council.
- $((\frac{(5)}{)})$ (6) In carrying out its duties under $(\frac{\text{subsection }(4) \text{ of}}{)}$ this section, the council may meet at least three times but not more than six times per year($(\frac{\text{including not more than two public hearings}}{)}$

- on issues of importance to youth)). The council shall consider 1 conducting at least some of the meetings via the K-20 2 telecommunications network. Councils are encouraged to invite local 3 state legislators to participate in the meetings. The council is 4 encouraged to poll other students in order to get a broad perspective 5 on the various issues. The council is encouraged to use technology to 6 conduct the polling, including the council's web site, if the council 7 has a web site. 8

- $((\frac{7}{1}))$ (8) The office of superintendent of public instruction shall provide administration, coordination, and facilitation assistance to the council. The senate and house of representatives may provide policy and fiscal briefings and assistance with drafting proposed legislation. The senate and the house of representatives shall each develop internal policies relating to staff assistance provided to the council. Such policies may include applicable internal personnel and quidelines, resource use practices and expense reimbursement quidelines, and applicable ethics mandates. Provision of funds, resources, and staff, as well as the assignment and direction of staff, remains at all times within the sole discretion of the chamber making the provision.
 - ((+8)) (9) The office of the lieutenant governor, the office of superintendent of public instruction, the legislature, any agency of the legislature, and any official or employee of such office or agency are immune from liability for any injury that is incurred by or caused by a member of the youth advisory council and that occurs while the member of the council is performing duties of the council or is otherwise engaged in activities or receiving services for which reimbursement is allowed under subsection ((+6)) (7) of this section. The immunity provided by this subsection does not apply to an injury intentionally caused by the act or omission of an employee or official of the superintendent of public instruction or the legislature or any agency of the legislature.
- 35 $((\frac{9}{10}))$ (10) This section expires June 30, $((\frac{2007}{10}))$ 2009.
- 36 <u>NEW SECTION.</u> Sec. 3. This act is necessary for the immediate

- 1 preservation of the public peace, health, or safety, or support of the
- 2 state government and its existing public institutions, and takes effect
- 3 immediately."
