3 "Sec. 1. RCW 74.09.510 and 2001 2nd sp.s. c 15 s 3 and 2001 1st 4 sp.s. c 4 s 1 are each reenacted and amended to read as follows:

5 Medical assistance may be provided in accordance with eligibility 6 requirements established by the department, as defined in the social 7 security Title XIX state plan for mandatory categorically needy persons 8 and:

9 (1) Individuals who would be eligible for cash assistance except 10 for their institutional status;

11 (2) <u>Individuals who are under twenty-one years of age</u>, who would be 12 eligible for medicaid, but do not qualify as dependent children and who 13 are in (a) foster care, (b) subsidized adoption, (c) a nursing facility 14 or an intermediate care facility for ((the)) persons who are mentally 15 retarded, or (d) inpatient psychiatric facilities;

16 17 (3) ((the)) Individuals who:

<u>(a) Are under twenty-one years of age;</u>

18 (b) Were in foster care in the state of Washington on or after the 19 effective date of this act; and

20 (c) Were in foster care in the state of Washington on their
21 eighteenth birthday;

22 (4) Persons who are aged, blind, ((and)) or disabled who: (a)
23 Receive only a state supplement, or (b) would not be eligible for cash
24 assistance if they were not institutionalized;

25 (((4))) (5) Categorically eligible individuals who meet the income 26 and resource requirements of the cash assistance programs;

27 (((5))) <u>(6) I</u>ndividuals who are enrolled in managed health care 28 systems, who have otherwise lost eligibility for medical assistance, 29 but who have not completed a current six-month enrollment in a managed health care system, and who are eligible for federal financial
 participation under Title XIX of the social security act;

3 ((((6)))) <u>(7)</u> Children and pregnant women allowed by federal statute
4 for whom funding is appropriated;

5 (((7))) (8) Working individuals with disabilities authorized under 6 section 1902(a)(10)(A)(ii) of the social security act for whom funding 7 is appropriated;

8 (((8))) <u>(9) O</u>ther individuals eligible for medical services under 9 RCW 74.09.035 and 74.09.700 for whom federal financial participation is 10 available under Title XIX of the social security act;

11 (((9))) <u>(10) P</u>ersons allowed by section 1931 of the social security 12 act for whom funding is appropriated; and

13 ((((10))) <u>(11) Women who:</u> (a) Are under sixty-five years of age; (b) have been screened for breast and cervical cancer under the 14 breast and cervical cancer early detection program 15 national administered by the department of health or tribal entity and have been 16 17 identified as needing treatment for breast or cervical cancer; and (c) are not otherwise covered by health insurance. Medical assistance 18 provided under this subsection is limited to the period during which 19 the woman requires treatment for breast or cervical cancer, and is 20 21 subject to any conditions or limitations specified in the omnibus 22 appropriations act.

23 **Sec. 2.** RCW 74.09.530 and 2000 c 218 s 2 are each amended to read 24 as follows:

(1) The amount and nature of medical assistance and the 25 26 determination of eligibility of recipients for medical assistance shall be the responsibility of the department of social and health services. 27 The department shall establish reasonable standards of assistance and 28 resource and income exemptions which shall be consistent with the 29 provisions of the Social Security Act and with the regulations of the 30 31 secretary of health, education and welfare for determining eligibility of individuals for medical assistance and the extent of such assistance 32 to the extent that funds are available from the state and federal 33 34 government. The department shall not consider resources in determining 35 continuing eligibility for recipients eligible under section 1931 of 36 the social security act.

(2) Individuals eligible for medical assistance under RCW 1 2 74.09.510(3) shall be transitioned into coverage under that subsection immediately upon their termination from coverage under RCW 3 74.09.510(2)(a). The department shall use income eligibility standards 4 and eligibility determinations applicable to children placed in foster 5 care. The department, in consultation with the health care authority, б 7 shall provide information regarding basic health plan enrollment and shall offer assistance with the application and enrollment process to 8 individuals covered under RCW 74.09.510(3) who are approaching their 9 twenty-first birthday. 10

11 NEW SECTION. Sec. 3. If any part of this act is found to be in 12 conflict with federal requirements that are a prescribed condition to the allocation of federal funds to the state, the conflicting part of 13 this act is inoperative solely to the extent of the conflict and with 14 respect to the agencies directly affected, and this finding does not 15 16 affect the operation of the remainder of this act in its application to 17 the agencies concerned. Rules adopted under this act must meet federal requirements that are a necessary condition to the receipt of federal 18 funds by the state." 19
