3 "<u>NEW SECTION.</u> Sec. 1. A new section is added to chapter 82.04 RCW 4 to read as follows:

5 (1) This chapter does not apply to any:

6 (a) Person performing custom farming services for a farmer, when 7 the person performing the custom farming services is: (i) An eligible 8 farmer; or (ii) at least fifty percent owned by an eligible farmer; or

9 (b) Person performing farm management services, contract labor 10 services, services provided with respect to animals that are agricultural products, or any combination of these services, for a 11 12 farmer or for a person performing custom farming services, when the 13 person performing the farm management services, contract labor services, services with respect to animals, or any combination of these 14 15 services, and the farmer or person performing custom farming services 16 are related.

17 (2) The definitions in this subsection apply throughout this 18 section.

(a) "Custom farming services" means the performance of specific 19 farming operations through the use of any farm machinery or equipment, 20 21 farm implement, or draft animal, together with an operator, when: (i) 22 The specific farming operation consists of activities directly related 23 to the growing, raising, or producing of any agricultural product to be 24 sold or consumed by a farmer; and (ii) the performance of the specific farming operation is for, and under a contract with, or the direction 25 or supervision of, a farmer. "Custom farming services" does not 26 27 include the custom application of fertilizers, chemicals, or 28 biologicals.

For the purposes of this subsection (2)(a), "specific farming operation" includes specific planting, cultivating, or harvesting 1 activities, or similar specific farming operations. The term does not 2 include veterinary services as defined in RCW 18.92.010; farrier, 3 boarding, training, or appraisal services; artificial insemination or 4 stud services, agricultural consulting services; packing or processing 5 of agricultural products; or pumping or other waste disposal services.

6 (b) "Eligible farmer" means a person who is eligible for an 7 exemption certificate under RCW 82.08.855 at the time that the custom 8 farming services are rendered, or was previously eligible for such an 9 exemption certificate, regardless of whether the person has applied for 10 an exemption certificate under RCW 82.08.855.

(c) "Farm management services" means the consultative decisions 11 made for the operations of the farm including, but not limited to, 12 determining which crops to plant, the choice and timing of application 13 of fertilizers and chemicals, the horticultural practices to apply, the 14 marketing of crops and livestock, and the care and feeding of animals. 15 (d) "Related" means having any of the relationships specifically 16 17 described in section 267(b) (1) through (13) of the internal revenue code, as amended or renumbered as of January 1, 2007. 18

19 <u>NEW SECTION.</u> Sec. 2. A new section is added to chapter 82.16 RCW 20 to read as follows:

(1) This chapter shall not apply to any person hauling agricultural products or farm machinery or equipment for a farmer or for a person performing custom farming services, when the person providing the hauling and the farmer or person performing custom farming services are related.

(2) The exemption provided by this section shall not apply to the hauling of any substances or articles manufactured from agricultural products. For the purposes of this subsection, "manufactured" has the same meaning as "to manufacture" in RCW 82.04.120.

30 (3) The definitions in RCW 82.04.213 and section 1 of this act 31 apply to this section.

32 <u>NEW SECTION.</u> Sec. 3. This act takes effect August 1, 2007.

33 <u>NEW SECTION.</u> Sec. 4. This act expires December 31, 2020."
