# HOUSE BILL REPORT HB 1065

### As Amended by the Senate

Title: An act relating to veterans' scoring criteria in examinations.

Brief Description: Revising veterans' scoring criteria in examinations.

## **Brief Summary of Bill**

• Clarifies that agencies or private companies contracted to administer competitive examinations for public employment are included in the entities that must give a scoring criteria status, or preference, to all veterans who sit for competitive examinations.

#### **Background:**

State law provides that honorably discharged veterans receive preference in public employment. Some public employment positions require applicants to take a competitive examination. In those cases, preference is given to veterans by adding a certain percentage to

the passing mark, grade, or rating of an examination. When scoring competitive exams, the state, including all of its political subdivisions and municipal corporations, must give the scoring criteria status (preference), as provided for in statute, to qualified veterans.

## **Summary of Bill:**

Clarifies that agencies or private companies who are contracted to administer competitive examinations for public employment are included in the list of entities that must give veterans who take a competitive examination the statutory scoring preference.

# **EFFECT OF SENATE AMENDMENT(S):**

For veterans returning to state employment after more than one year of active military service, five percentage points will be added to the score of every promotional examination until the veteran's first promotion rather than to only one promotional examination.

Appropriation: None.

Fiscal Note: Not requested.

**Effective Date:** The bill takes effect 90 days after adjournment of session in which bill is passed.

## **Staff Summary of Public Testimony:**

(In support) As a member of the Army Reserves I know that serving is an incredible burden on families and anything that the state can do to help with employment upon return is so important. The clarification will hold contractors to the same requirement as the state.
