## **Brief Summary of Bill**

- Changes the definition of "election cycle" to mean the period beginning on January 1 after the date of the last general election and ending on December 31 after the next election for office.
- Changes the definition of "election cycle" in the case of a special election to fill a vacancy in office to mean the period beginning the day the vacancy occurs and ending on December 31 after the special election.

### **Background:**

Chapter 42.17 RCW governs campaign financing, lobbyist reporting, political advertising and electioneering communications, reporting of public officials' financial affairs, and campaign contribution limits.

# **Summary of Bill:**

"Election cycle" is defined as the period beginning on January 1 after the date of the last previous general election for the office that the candidate seeks and ending on December 31 after the next election for the office. The contribution is considered to be for the following election, regardless of the intent of the contributor.
