## **Background:**

So long as they meet certain requirements, state employees may request payroll deductions for the following:

- credit union payments;
- parking fee payments;

This analysis was prepared by non-partisan legislative staff for the use of legislative members in their deliberations. This analysis is not a part of the legislation nor does it constitute a statement of legislative intent.

- U.S. savings bond payments;
- deductions for board, lodging, or uniforms, when furnished by the state;
- membership dues and other fees to professional organizations;
- insurance contributions for payment of premiums under contracts authorized by the state Health Care Authority;
- deductions to a bank, savings bank, or savings and loan association; and
- contributions to the Washington State Combined Fund Drive.

Deductions for labor or employee organization dues and voluntary employee contributions to any funds, committees, or subsidiary organizations maintained by labor or employee organizations may be made if a payroll deduction is not provided under a collective bargaining agreement.

## Summary of Bill:

Deductions for retiree organization dues and voluntary contributions to any funds, committees, or subsidiary organizations maintained by retiree organizations may be made if a payroll deduction is not provided under a collective bargaining agreement.

**Effective Date:** The bill takes effect 90 days after adjournment of session in which bill is passed.

# **Staff Summary of Public Testimony:**
