Background:

House Bill Report - 1 - ESHB 2687

This analysis was prepared by non-partisan legislative staff for the use of legislative members in their deliberations. This analysis is not a part of the legislation nor does it constitute a statement of legislative intent.

The state government operates on a fiscal biennium that begins July 1 of each odd-numbered year. The 2007-09 biennial operating budget appropriated \$29.6 billion from the State General Fund for a variety of purposes. The State General Fund and several other accounts, referred to as Near General Fund, had appropriations of \$33.4 billion. The total budgeted amount, which includes state and federal funds, was \$56.8 billion.

Summary of Engrossed Substitute Bill:

Appropriations are modified for the 2007-09 biennium. This bill increases State General Fund appropriations by \$233.9 million. Near General Fund accounts, which include both the State General Fund and several other accounts, increase by \$297.4 million. Total budgeted funds are increased by \$429.3 million.

EFFECT OF SENATE AMENDMENT(S):

The Senate amendment makes numerous changes to the House 2008 Supplemental Operating Budget appropriations.
