1 WHEREAS, Those seeking visas and trade documents now face the 2 inconvenience of traveling to San Francisco to obtain consular 3 assistance;

 NOW, THEREFORE, Your Memorialists respectfully pray that President Gloria Macapagal-Arroyo support Resolution 1452 introduced by Congressman Rodolfo Valencia and Congressman Antonio Cuenco, calling for the establishment of a consulate in the Western United States; and, that should such a consulate be established, the location would be in Seattle, Washington.
