AN ACT Relating to adding porphyria to the list of disabilities for special parking privileges; amending RCW 46.16.381; providing an effective date; and declaring an emergency.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 46.16.381 and 2006 c 357 s 2 are each amended to read 6 as follows:

7 (1) The director shall grant special parking privileges to any 8 person who has a disability that limits or impairs the ability to walk 9 <u>or involves acute sensitivity to light</u> and meets one of the following 10 criteria, as determined by a licensed physician or an advanced 11 registered nurse practitioner licensed under chapter 18.79 RCW:

12 (a) Cannot walk two hundred feet without stopping to rest;

(b) Is severely limited in ability to walk due to arthritic,neurological, or orthopedic condition;

15 (c) Has such a severe disability, that the person cannot walk 16 without the use of or assistance from a brace, cane, another person, 17 prosthetic device, wheelchair, or other assistive device;

18 (d) Uses portable oxygen;

1 (e) Is restricted by lung disease to such an extent that forced 2 expiratory respiratory volume, when measured by spirometry is less than 3 one liter per second or the arterial oxygen tension is less than sixty 4 mm/hg on room air at rest;

5 (f) Impairment by cardiovascular disease or cardiac condition to 6 the extent that the person's functional limitations are classified as 7 class III or IV under standards accepted by the American Heart 8 Association;

9 (g) Has a disability resulting from an acute sensitivity to 10 automobile emissions which limits or impairs the ability to walk. The 11 personal physician or advanced registered nurse practitioner of the 12 applicant shall document that the disability is comparable in severity 13 to the others listed in this subsection; ((or))

(h) Is legally blind and has limited mobility; or

15 (i) Is restricted by a form of porphyria to the extent that the 16 applicant would significantly benefit from a decrease in exposure to 17 light.

(2) applications for parking permits for persons with 18 The 19 disabilities and parking permits for persons with temporary disabilities are official state documents. Knowingly providing false 20 21 information in conjunction with the application is a gross misdemeanor 22 punishable under chapter 9A.20 RCW. The following statement must appear on each application form immediately below the physician's or 23 24 advanced registered nurse practitioner's signature and immediately 25 below the applicant's signature: "A parking permit for a person with disabilities may be issued only for a medical necessity that severely 26 27 affects mobility or involves acute sensitivity to light (RCW 46.16.381). Knowingly providing false information on this application 28 29 is a gross misdemeanor. The penalty is up to one year in jail and a fine of up to \$5,000 or both." 30

31 (3) Persons who qualify for special parking privileges are entitled 32 to receive from the department of licensing a removable windshield placard bearing the international symbol of access and an individual 33 serial number, along with a special identification card bearing the 34 name and date of birth of the person to whom the placard is issued, and 35 the placard's serial number. The special identification card shall be 36 37 issued to all persons who are issued parking placards, including those 38 issued for temporary disabilities, and special parking license plates

for persons with disabilities. The department shall design the placard 1 2 to be displayed when the vehicle is parked by suspending it from the rearview mirror, or in the absence of a rearview mirror the card may be 3 displayed on the dashboard of any vehicle used to transport the person 4 with disabilities. Instead of regular motor vehicle license plates, 5 persons with disabilities are entitled to receive special license 6 plates under this section or RCW 46.16.385 bearing the international 7 symbol of access for one vehicle registered in the name of the person 8 with disabilities. Persons with disabilities who are not issued the 9 10 special license plates are entitled to receive a second special placard upon submitting a written request to the department. Persons who have 11 12 been issued the parking privileges and who are using a vehicle or are 13 riding in a vehicle displaying the placard or special license plates issued under this section or RCW 46.16.385 may park in places reserved 14 for persons with physical disabilities. The director shall adopt rules 15 providing for the issuance of special placards and license plates to 16 public transportation authorities, nursing homes licensed under chapter 17 18.51 RCW, boarding homes licensed under chapter 18.20 RCW, senior 18 citizen centers, private nonprofit agencies as defined in chapter 24.03 19 RCW, and vehicles registered with the department as cabulances that 20 21 regularly transport persons with disabilities who have been determined 22 eligible for special parking privileges provided under this section. The director may issue special license plates for a vehicle registered 23 24 in the name of the public transportation authority, nursing home, 25 boarding home, senior citizen center, private nonprofit agency, or cabulance service if the vehicle is primarily used to transport persons 26 27 with disabilities described in this section. Public transportation authorities, nursing homes, boarding homes, senior citizen centers, 28 private nonprofit agencies, and cabulance services are responsible for 29 insuring that the special placards and license plates are not used 30 31 improperly and are responsible for all fines and penalties for improper 32 use.

33 (4) Whenever the person with disabilities transfers or assigns his 34 or her interest in the vehicle, the special license plates shall be 35 removed from the motor vehicle. If another vehicle is acquired by the 36 person with disabilities and the vehicle owner qualifies for a special 37 plate, the plate shall be attached to the vehicle, and the director

1 shall be immediately notified of the transfer of the plate. If another 2 vehicle is not acquired by the person with disabilities, the removed 3 plate shall be immediately surrendered to the director.

(5) The special license plate shall be renewed in the same manner 4 and at the time required for the renewal of regular motor vehicle 5 license plates under this chapter. No special license plate may be б 7 issued to a person who is temporarily disabled. A person who has a condition expected to improve within six months may be issued a 8 temporary placard for a period not to exceed six months. If the 9 condition exists after six months a new temporary placard shall be 10 issued upon receipt of a new certification from the person's physician. 11 12 The permanent parking placard and identification card of a person with 13 disabilities shall be renewed at least every five years, as required by 14 the director, by satisfactory proof of the right to continued use of the privileges. In the event of the permit holder's death, the parking 15 16 placard and identification card must be immediately surrendered to the 17 department. The department shall match and purge its data base of parking permits issued to persons with disabilities with available 18 death record information at least every twelve months. 19

20 (6) Additional fees shall not be charged for the issuance of the 21 special placards or the identification cards. No additional fee may be 22 charged for the issuance of the special license plates except the 23 regular motor vehicle registration fee and any other fees and taxes 24 required to be paid upon registration of a motor vehicle.

(7) Any unauthorized use of the special placard, special license plate issued under this section or RCW 46.16.385, or identification card is a traffic infraction with a monetary penalty of two hundred fifty dollars.

(8) It is a parking infraction, with a monetary penalty of two hundred fifty dollars for a person to make inaccessible the access aisle located next to a space reserved for persons with physical disabilities. The clerk of the court shall report all violations related to this subsection to the department.

(9) It is a parking infraction, with a monetary penalty of two hundred fifty dollars for any person to park a vehicle in a parking place provided on private property without charge or on public property reserved for persons with physical disabilities without a placard or special license plate issued under this section or RCW 46.16.385. If

a person is charged with a violation, the person shall not be 1 2 determined to have committed an infraction if the person produces in court or before the court appearance the placard or special license 3 plate issued under this section or RCW 46.16.385 required under this 4 5 section. A local jurisdiction providing nonmetered, on-street parking places reserved for persons with physical disabilities may impose by б 7 ordinance time restrictions of no less than four hours on the use of these parking places. A local jurisdiction may impose by ordinance 8 time restrictions of no less than four hours on the use of nonreserved, 9 on-street parking spaces by vehicles displaying the special parking 10 placards or special license plates issued under this section or RCW 11 12 46.16.385. All time restrictions must be clearly posted.

(10) The penalties imposed under subsections (8) and (9) of this section shall be used by that local jurisdiction exclusively for law enforcement. The court may also impose an additional penalty sufficient to reimburse the local jurisdiction for any costs it may have incurred in removal and storage of the improperly parked vehicle.

18 (11) Except as provided by subsection (2) of this section, it is a 19 traffic infraction with a monetary penalty of two hundred fifty dollars 20 for any person willfully to obtain a special license plate issued under 21 this section or RCW 46.16.385, placard, or identification card in a 22 manner other than that established under this section.

(12)(a) A law enforcement agency authorized to enforce parking laws may appoint volunteers, with a limited commission, to issue notices of infractions for violations of this section or RCW 46.61.581. Volunteers must be at least twenty-one years of age. The law enforcement agency appointing volunteers may establish any other qualifications the agency deems desirable.

(b) An agency appointing volunteers under this section must provide training to the volunteers before authorizing them to issue notices of infractions.

32 (c) A notice of infraction issued by a volunteer appointed under 33 this subsection has the same force and effect as a notice of infraction 34 issued by a police officer for the same offense.

35 (d) A police officer or a volunteer may request a person to show 36 the person's identification card or special parking placard when 37 investigating the possibility of a violation of this section. If the request is refused, the person in charge of the vehicle may be issued
 a notice of infraction for a violation of this section.

3 (13) For second or subsequent violations of this section, in 4 addition to a monetary fine, the violator must complete a minimum of 5 forty hours of:

6 (a) Community restitution for a nonprofit organization that serves
7 persons having disabilities or disabling diseases; or

8 (b) Any other community restitution that may sensitize the violator 9 to the needs and obstacles faced by persons who have disabilities.

10 (14) The court may not suspend more than one-half of any fine 11 imposed under subsection (7), (8), (9), or (11) of this section.

12 (15) For the purposes of this section, "legally blind" means a 13 person who: (a) Has no vision or whose vision with corrective lenses 14 is so limited that the individual requires alternative methods or 15 skills to do efficiently those things that are ordinarily done with 16 sight by individuals with normal vision; or (b) has an eye condition of 17 a progressive nature which may lead to blindness.

18 <u>NEW SECTION.</u> Sec. 2. This act is necessary for the immediate 19 preservation of the public peace, health, or safety, or support of the 20 state government and its existing public institutions, and takes effect 21 July 1, 2007.
