1 AN ACT Relating to raffles conducted by state employees; amending 2 RCW 9.46.0209; and adding a new section to chapter 42.52 RCW.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 9.46.0209 and 2000 c 233 s 1 are each amended to read 5 as follows:

6 (1)(a) "Bona fide charitable or nonprofit organization," as used in
 7 this chapter, means: (((1)))

8 (i) Any organization duly existing under the provisions of chapter 24.12, 24.20, or 24.28 RCW, any agricultural fair authorized under the 9 10 provisions of chapters 15.76 or 36.37 RCW, or any nonprofit corporation duly existing under the provisions of chapter 24.03 RCW for charitable, 11 12 benevolent, eleemosynary, educational, civic, patriotic, political, 13 social, fraternal, athletic or agricultural purposes only, or any 14 nonprofit organization, whether incorporated or otherwise, when found 15 by the commission to be organized and operating for one or more of the aforesaid purposes only, all of which in the opinion of the commission 16 have been organized and are operated primarily for purposes other than 17 18 the operation of gambling activities authorized under this chapter; or 19 ((+2))

(ii) Any corporation which has been incorporated under Title 36 U.S.C. and whose principal purposes are to furnish volunteer aid to members of the armed forces of the United States and also to carry on a system of national and international relief and to apply the same in mitigating the sufferings caused by pestilence, famine, fire, floods, and other national calamities and to devise and carry on measures for preventing the same. ((Such))

(b) An organization defined under (a) of this subsection must:

9 <u>(i) Have been organized and continuously operating for at least</u> 10 twelve calendar months immediately preceding making application for any 11 license to operate a gambling activity, or the operation of any 12 gambling activity authorized by this chapter for which no license is 13 required((. It must));

14 (ii) Have not less than fifteen bona fide active members each with 15 the right to an equal vote in the election of the officers, or board 16 members, if any, who determine the policies of the organization in 17 order to receive a gambling license((. An organization must)); and

(iii) Demonstrate to the commission that it has made significant 18 progress toward the accomplishment of the purposes of the organization 19 during the twelve consecutive month period preceding the date of 20 21 application for a license or license renewal. The fact that 22 contributions to an organization do not qualify for charitable contribution deduction purposes or that the organization is not 23 24 otherwise exempt from payment of federal income taxes pursuant to the internal revenue code of 1954, as amended, shall constitute prima facie 25 evidence that the organization is not a bona fide charitable or 26 27 nonprofit organization for the purposes of this section.

(c) Any person, association or organization which pays its 28 employees, including members, compensation other than is reasonable 29 therefor under the local prevailing wage scale shall be deemed paying 30 31 compensation based in part or whole upon receipts relating to gambling 32 activities authorized under this chapter and shall not be a bona fide charitable or nonprofit organization for the purposes of this chapter. 33 (2) For the purposes of RCW 9.46.0315 and 9.46.110, a bona fide 34 35 nonprofit organization also includes:

36 (a) A credit union organized and operating under state or federal
 37 law. All revenue less prizes and expenses received from raffles

1 conducted by credit unions must be devoted to purposes authorized under 2 this section for charitable and nonprofit organizations; and

(b) A group of executive branch state employees that:

4 (i) Has requested and received revocable approval from the agency's
5 chief executive official, or such official's designee, to conduct one
6 or more raffles in compliance with this section;

(ii) Conducts a raffle solely to raise funds for either the state 7 combined fund drive, created under RCW 41.04.033; an entity approved to 8 receive funds from the state combined fund drive; or a charitable or 9 benevolent entity, including but not limited to a person or family in 10 need, as determined by a majority vote of the approved group of 11 12 employees. No person or other entity may receive compensation in any 13 form from the group for services rendered in support of this purpose; (iii) Promptly provides such information about the group's 14 receipts, expenditures, and other activities as the agency's chief 15

15 receipts, expenditures, and other activities as the agency's chief 16 executive official or designee may periodically require, and otherwise 17 complies with this section and RCW 9.46.0315; and

18 (iv) Limits the participation in the raffle such that raffle
19 tickets are sold only to, and winners are determined only from, the
20 employees of the agency.

21 <u>NEW SECTION.</u> Sec. 2. A new section is added to chapter 42.52 RCW 22 to read as follows:

23 (1) When soliciting gifts, grants, or donations solely to support 24 the charitable activities of executive branch state employees conducted pursuant to RCW 9.46.0209, the executive branch state officers and 25 26 executive branch state employees are presumed not to be in violation of 27 the solicitation and receipt of gift provisions in RCW 42.52.140. However, the gifts, grants, or donations must only be solicited from 28 state employees or businesses and organizations that have no business 29 dealings with the soliciting employee's agency. For the purposes of 30 31 this subsection, "business dealings" includes being subject to regulation by the agency, having a contractual relationship with the 32 33 agency, and purchasing goods or services from the agency.

34 (2) For purposes of this section, activities are deemed to be
 35 charitable if the activities are devoted to the purposes authorized
 36 under RCW 9.46.0209 for charitable and nonprofit organizations listed

in that section, or are in support of the activities of those
 charitable or nonprofit organizations.
