House Bills

HB 2378-S by House Committee on Transportation (originally sponsored by Representatives Flannigan, Jarrett, Clibborn, Eddy, Seaquist, and Roberts)

Expediting new vessel construction for Washington state ferries.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Finds that the Washington state ferry system has an excellent safety record and has commenced a long-term vessel procurement plan to ensure the replacement of older and outdated ferry vessels. The legislature further finds that the current vessel procurement process must move forward with all due speed, balancing the interests of both the taxpayers and shipyards. The commencement of construction of new vessels is important not only for safety reasons, but also to keep skilled marine construction jobs in the Puget Sound region and to sustain the capacity of the region to meet the ongoing preservation needs of the ferry system fleet of vessels.

Finds that the balancing of interests described in this act may necessitate the department of transportation to consider in the department's current new 144--auto ferries request for proposals a single proposal submitted jointly by the current best-qualified proposers. The department may, therefore, consider and accept or reject in the department's discretion such a single proposal, and the current bestqualified proposers may meet and confer to discuss matters that are reasonably necessary to determine whether to submit such a single proposal and to implement a single final contract if the proposal is accepted by the department.

Provides that, to further facilitate the balancing of interests described in this act, the department of transportation may, in its discretion, make revisions to the request for proposals that the department deems necessary or appropriate to balance such interests.

Provides that, if at any point there is only a single best-qualified proposer participating in the competitive design-build procurement process prior to the submission of bids in phase three, or if there is only a single responsive and responsible bid submitted in phase three, or if the current best-qualified proposers elect to jointly submit a single proposal, the department may negotiate a fair-value contract with the proposer or joint proposers.

HB 2401 by Representatives B. Sullivan, Strow, Dunshee, Roberts, and Santos

Imposing a fee on professional athletes to fund community outdoor athletic facilities.

Provides that, for the privilege of performing before paying audiences in publicly financed facilities, a fee is imposed on each member of a professional athletic team and each member of a sports entertainment business, for each duty day that occurs in the state of Washington. The fee is fifty dollars per member per duty day.

Provides that the revenue from fees collected under this act must be deposited into the youth athletic facility account created in RCW 43.99N.060.

Senate Bills

SB 5080-S by Senate Committee on Transportation (originally sponsored by Senators Marr, Swecker, Murray, Weinstein, Kauffman, Rasmussen, Hatfield, Hobbs, Berkey, Pridemore, Regala, Tom, McCaslin, Oemig, Jacobsen, and Rockefeller)

Extending tire replacement fees.

(AŠ OF SÊNATE 2ND READING 4/4/2007)

Extends the time period for waste tire removal fees and revises the disposition of the fees.

Restates the goal to fully clean up unauthorized waste tire piles in Washington state in an expeditious fashion. In partnership with local governments and the private sector, the legislature encourages ongoing efforts to prevent the creation of future unauthorized waste tire piles. The legislature notes a positive trend in tire recycling in recent years and encourages all parties to continue these strong recycling efforts.

Provides that, on September first of even-numbered years, the department of ecology shall provide a report to the house and senate transportation committees on the progress being made on the cleanup of unauthorized waste tire piles in the state and efforts underway to prevent the formation of future unauthorized waste tire piles. The report should detail any additional unauthorized waste tire piles discovered since the last report and present a plan to clean up these new unauthorized waste fire piles if they have not already done so, as well as include a listing of authorized waste tire piles and transporters. The report shall also include the status of funds available to the program and a needs assessment of the program. On September 1, 2008, the department shall also make recommendations to the committees for an ongoing program to prevent the formation of future unauthorized waste tire piles. Such a program, if required, must include joint efforts with local governments and the tire industry.

SB 5498 by Senators Regala, Clements, Morton, Brandland, Pridemore, Delvin, Prentice, Hatfield, and Rasmussen

Revising voter-approved funding sources for local taxing districts.

(AS OF SENATE 2ND READING 4/2/2007)

Revises voter-approved funding sources for local taxing districts.

Declares that, for purposes of this act, existing funds means the actual operating expenditures for the calendar year in which the ballot measure is approved by voters. Actual operating expenditures excludes lost federal funds, lost or expired state grants or loans, extraordinary events not likely to reoccur, changes in contract provisions beyond the control of the county or city receiving the services, and major nonrecurring capital expenditures.

SB 5905-S by Senate Committee on Ways & Means (originally sponsored by Senators Franklin, Pflug, Keiser, Tom, Zarelli, Marr, and Carrell)

Concerning certificate of capital authorization.

(AS OF SENATE 2ND READING 4/2/2007)

Declares that, in processing and approving certificates of capital authorization, priority shall be given to construction or major renovation of existing facilities or replacement facilities. Those existing or replacement facilities with the greatest length of time between its last major renovation or construction shall be given first priority. A certificate of capital authorization is only required for capital expenditures exceeding the expenditure minimum as defined in RCW 70.38.025.

Provides that certificates of capital authorization for new facilities shall receive last priority and be assigned on a first-come, first-served basis.

Requires that certificate of capital authorization applications be filed with the department by the end of the previous state fiscal year to be considered for priority assignment in the following state fiscal year beginning July 1st.

Provides that projects shall be considered on an emergency basis if the construction or renovation must be completed as soon as possible to: (1) Retain a facility's license or certification;

(2) Protect the health or safety of the facility's residents; or

(3) Avoid closure.

Resolves, that a joint select committee on the state liquor laws be established to review liquor licensing and tied house laws to determine whether they should be continued in their present form or reformulated to decrease the number of bills introduced in the legislature each year.

Resolves, that the committee report its findings and recommendations to the legislature at the regular session held in 2008.
