- 4 Sec. 1. RCW 43.79A.040 and 2008 c 239 s 9, 2008 c 208 s 9, 2008 c 128 s 20, and 2008 c 122 s 24 are each reenacted and amended to read as follows:
 - (1) Money in the treasurer's trust fund may be deposited, invested, and reinvested by the state treasurer in accordance with RCW 43.84.080 in the same manner and to the same extent as if the money were in the state treasury.
- 11 (2) All income received from investment of the treasurer's trust 12 fund shall be set aside in an account in the treasury trust fund to be 13 known as the investment income account.
- 14 (3) The investment income account may be utilized for the payment 15 of purchased banking services on behalf of treasurer's trust funds 16 but limited to, depository, safekeeping, including, not 17 disbursement functions for the state treasurer or affected state 18 agencies.
