- 21 business or organization e-mail address, if any. If the business or
- 22 organization is operated out of a residence, the residence shall be
- 23 considered the main office for the purposes of this subsection;
- 24 (c) The full name of the business owner or owners or the members
- 25 of the governing body of an organization and any assumed names;
- 26 (d) A signature of the business owner or owners or the members
- 27 of the governing body of the organization;

- 1 (e) A signed statement attesting that the business owner or
- 2 owners or members of the governing body of the organization:
- 3 (i) Have not been convicted of a criminal offense involving fraud,
- 4 forgery, or identification theft within the past five years; (ii)
- 5 have not been convicted of a crime under chapter 29A.84 RCW, or its
- 6 equivalent in another jurisdiction, in the past five years; (iii)
- 7 have not been found in violation of elections law under chapter
- 8 29A.84 RCW, or its equivalent in another jurisdiction, in the past
- 9 five years; and
- 10 (iv) are not convicted sex offenders;
- 11 (f)A signed statement acknowledging the business owner or owners
- 12 or members of the governing body of the organization have read and
- 13 understand Washington law applicable to voter registration;
- 14 (g) Evidence indicating that the business owner or owners or
- 15 members of the governing body of the organization completed the
- 16 training required under section 7 of this act; and
- 17 (j) A conventional photograph showing the paid signature
- 18 gatherer's head, neck, and shoulders, and is appropriate for copying
- 19 and processing by the commission."
