1 AN ACT Relating to issuing firearms certificates to retired law 2 enforcement officers; and amending RCW 36.28A.090.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 Sec. 1. RCW 36.28A.090 and 2006 c 40 s 1 are each amended to read 5 as follows:

(1) The purpose of this section is to establish a process for
issuing firearms certificates to residents of Washington who are
<u>otherwise</u> qualified retired law enforcement officers <u>under the federal</u>
<u>law enforcement officers safety act of 2004 (118 Stat. 865; 18 U.S.C.</u>
<u>Sec. 926B and 926C)</u> for the purpose of satisfying the certification
requirements contained in ((the federal law enforcement officers safety
<u>act of 2004 (118 Stat. 865; 18 U.S.C. Sec. 926B and 926C)</u>)) that act.

13 (2) <u>A retired law enforcement officer satisfies the federal</u> 14 <u>certification requirements if he or she possesses a valid firearms</u> 15 <u>qualification certificate that:</u>

16 (a) Uses the model certificate created under subsection (4) of this 17 section;

(b) Provides that either a law enforcement agency or an individual
 or entity certified to provide firearms training acknowledges that the

bearer has been found qualified or otherwise found to meet the 1 standards established by the criminal justice training commission for 2 firearms qualification for the basic law enforcement training academy 3 in the state; and 4 (c) Complies with the time restrictions provided under subsection 5 б (3) of this section. 7 (3) The firearms certificate is valid for a period of one year from the date that the law enforcement agency or individual or entity 8 certified to provide firearms training determines that the bearer has 9 been found qualified or otherwise found to meet the standards 10 established by the criminal justice training commission for firearms 11 qualification for the basic law enforcement training academy in the 12 state, and the certificate shall state the date the determination was 13 14 made.

15 (4) The Washington association of sheriffs and police chiefs shall develop a model certificate that shall serve as the required firearms 16 qualification certificate ((form to be used by local law enforcement 17 agencies when issuing firearms certificates to retired law enforcement 18 officers under this section)) once the certificate is valid pursuant to 19 20 subsection (2) of this section. The association shall make the model certificate accessible on its web site. The model certificate shall 21 state that the retired law enforcement officer bearing the certificate 22 has been qualified or otherwise found to meet the standards established 23 24 by the criminal justice training commission for firearms qualification 25 for the basic law enforcement training academy in the state.

26 (((3) A retired law enforcement officer who is a resident of 27 Washington may apply for a firearms certificate with a local law 28 enforcement agency. The local law enforcement agency may issue the 29 firearms certificate to a retired law enforcement officer if the 30 officer:

31 (a) Has been qualified or otherwise found to meet the standards 32 established by the criminal justice training commission for firearms 33 qualifications for active law enforcement officers in the state; and

34 (b) Has undergone the same background check as required under RCW 35 9.41.070 and is not ineligible to possess a firearm under RCW 9.41.040 36 or 9.41.045.

(4) The qualification required under [subsection] (3)(a) of this

section may be performed by the local law enforcement agency or by an individual or entity certified to provide firearms training.

3 (5) The firearms certificate is valid for a period of one year. An 4 applicant for the firearms certificate shall pay a fee of thirty-six 5 dollars, plus additional charges imposed by the federal bureau of 6 investigation that are passed on to the applicant. The fee shall be 7 distributed in the same manner as the fee for a concealed pistol 8 license under RCW 9.41.070.))

9 <u>(5)</u> The retired law enforcement officer is ((also)) responsible for 10 paying the costs of the firearms qualification required under 11 (([subsection] (3)(a))) subsection (2) of this section.

12 (6) Nothing in this section shall be deemed to require a local law 13 enforcement agency to complete the certificate.
