AN ACT Relating to accountability for persons driving under the influence of intoxicating liquor or drugs; amending RCW 46.20.385, 46.20.391, 46.20.720, 46.61.5055, 46.20.410, 46.20.342, 46.20.740, 10.05.020, 10.05.090, and 10.05.160; adding a new section to chapter 46.61 RCW; prescribing penalties; and providing an effective date.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 **Sec. 1.** RCW 46.20.385 and 2008 c 282 s 9 are each amended to read 8 as follows:

9 (1)(a) Beginning January 1, 2009, any person licensed under this 10 chapter who is convicted of ((any offense involving the use, 11 consumption, or possession of alcohol while operating a motor vehicle in)) a violation of RCW 46.61.502 or 46.61.504((, other than vehicular 12 13 homicide or vehicular assault)) or an equivalent local or out-of-state statute or ordinance, or a violation of RCW 46.61.520(1)(a) or 14 15 46.61.522(1)(b), or who has had or will have his or her license 16 suspended, revoked, or denied under RCW 46.20.3101, may submit to the department an application for an ignition interlock driver's license. 17 18 The department, upon receipt of the prescribed fee and upon determining 1 that the petitioner is eligible to receive the license, may issue an 2 ignition interlock driver's license.

3 (b) A person may apply for an ignition interlock driver's license
4 anytime, including immediately after receiving the notices under RCW
5 46.20.308 or after his or her license is suspended, revoked, or denied.
6 A person receiving an ignition interlock driver's license waives his or
7 her right to a hearing or appeal under RCW 46.20.308.

8 (c) An applicant under this subsection shall provide proof to the 9 satisfaction of the department that a functioning ignition interlock 10 device has been installed on all vehicles operated by the person.

11 (i) The department shall require the person to maintain the device 12 on all vehicles operated by the person and shall restrict the person to operating only vehicles equipped with the device, for the remainder of 13 the period of suspension, revocation, or denial. The installation of 14 an ignition interlock device is not necessary on vehicles owned, 15 leased, or rented by a person's employer and on those vehicles whose 16 17 care and/or maintenance is the temporary responsibility of the employer, and driven at the direction of a person's employer as a 18 19 requirement of employment during working hours. The person must provide the department with a declaration pursuant to RCW 9A.72.085 20 21 from his or her employer stating that the person's employment requires 22 the person to operate a vehicle owned by the employer or other persons 23 during working hours.

24 (ii) Subject to any periodic renewal requirements established by the department under this section and subject to any applicable 25 26 compliance requirements under this chapter or other law, an ignition interlock driver's license granted upon a suspension or revocation 27 under RCW 46.61.5055 or 46.20.3101 extends through the remaining 28 29 portion of any concurrent or consecutive suspension or revocation that 30 may be imposed as the result of administrative action and criminal conviction arising out of the same incident. 31

32 (iii) The time period during which the person is licensed under 33 this section shall apply on a day-for-day basis toward satisfying the 34 period of time the ignition interlock device restriction is required 35 under RCW 46.20.720 and 46.61.5055.

36 (2) An applicant for an ignition interlock driver's license who 37 qualifies under subsection (1) of this section is eligible to receive 38 a license only if((÷

1 (a) Within seven years immediately preceding the date of the 2 offense that gave rise to the present conviction or incident, the 3 applicant has not committed vehicular homicide under RCW 46.61.520 or 4 vehicular assault under RCW 46.61.522; and

5 (b)) <u>the</u> applicant files satisfactory proof of financial
6 responsibility under chapter 46.29 RCW.

7 (3) Upon receipt of evidence that a holder of an ignition interlock 8 driver's license granted under this subsection no longer has a 9 functioning ignition interlock device installed on all vehicles operated by the driver, the director shall give written notice by 10 11 first-class mail to the driver that the ignition interlock driver's 12 license shall be canceled. ((The effective date of cancellation shall 13 be fifteen days from the date of mailing the notice.)) If at any time before the cancellation goes into effect the driver submits evidence 14 15 that a functioning ignition interlock device has been installed on all vehicles operated by the driver, the cancellation shall be stayed. 16 Ιf the cancellation becomes effective, the driver may obtain, at no 17 additional charge, a new ignition interlock driver's license upon 18 19 submittal of evidence that a functioning ignition interlock device has 20 been installed on all vehicles operated by the driver.

(4) A person aggrieved by the decision of the department on the application for an ignition interlock driver's license may request a hearing as provided by rule of the department.

24 (5) The director shall cancel an ignition interlock driver's license ((upon receipt of)) after receiving notice that the holder 25 26 thereof has been convicted of operating a motor vehicle in violation of 27 its restrictions, no longer meets the eligibility requirements, or ((of)) has been convicted of or found to have committed a separate 28 offense or any other act or omission that under this chapter would 29 30 warrant suspension or revocation of a regular driver's license. The department must give notice of the cancellation ((is effective as of 31 the date of the conviction, and continues with the same force and 32 33 effect as any suspension or revocation under this title)) as provided under RCW 46.20.245. A person whose ignition interlock driver's 34 license has been canceled under this section may reapply for a new 35 36 ignition interlock driver's license if he or she is otherwise qualified under this section and pays the fee required under RCW 46.20.380. 37

(6)(a) Unless costs are waived by the ignition interlock company or the person is indigent under RCW 10.101.010, the applicant shall pay the cost of installing, removing, and leasing the ignition interlock device and shall pay an additional fee of twenty dollars per month. Payments shall be made directly to the ignition interlock company. The company shall remit the additional twenty-dollar fee to the department.

7 (b) The department shall deposit the proceeds of the twenty-dollar 8 fee into the ignition interlock device revolving account. Expenditures 9 from the account may be used only to administer and operate the 10 ignition interlock device revolving account program. The department 11 shall adopt rules to provide monetary assistance according to greatest 12 need and when funds are available.

13 (7) The department shall adopt rules to implement ignition 14 interlock licensing. The department shall consult with the 15 administrative office of the courts, the state patrol, the Washington association of sheriffs and police chiefs, 16 ignition interlock companies, and any other organization or entity the department deems 17 18 appropriate.

19 Sec. 2. RCW 46.20.391 and 2008 c 282 s 6 are each amended to read 20 as follows:

21 (1) Any person licensed under this chapter who is convicted of an 22 offense relating to motor vehicles for which suspension or revocation 23 of the driver's license is mandatory, other than vehicular homicide, vehicular assault, driving while under the influence of intoxicating 24 25 liquor or any drug, or being in actual physical control of a motor 26 vehicle while under the influence of intoxicating liquor or any drug, 27 may submit to the department an application for a temporary restricted 28 driver's license. The department, upon receipt of the prescribed fee 29 and upon determining that the petitioner is eligible to receive the 30 license, may issue a temporary restricted driver's license and may set definite restrictions as provided in RCW 46.20.394. 31

32 (2)(a) A person licensed under this chapter whose driver's license 33 is suspended administratively due to failure to appear or pay a traffic 34 ticket under RCW 46.20.289; a violation of the financial responsibility 35 laws under chapter 46.29 RCW; or for multiple violations within a 36 specified period of time under RCW 46.20.291, may apply to the 37 department for an occupational driver's license.

1 (b) If the suspension is for failure to respond, pay, or comply 2 with a notice of traffic infraction or conviction, the applicant must 3 enter into a payment plan with the court.

4 (c) An occupational driver's license issued to an applicant 5 described in (a) of this subsection shall be valid for the period of 6 the suspension or revocation.

7 (3) An applicant for an occupational or temporary restricted
8 driver's license who qualifies under subsection (1) or (2) of this
9 section is eligible to receive such license only if:

10 (a) Within seven years immediately preceding the date of the 11 offense that gave rise to the present conviction or incident, the 12 applicant has not committed vehicular homicide under RCW 46.61.520 or 13 vehicular assault under RCW 46.61.522; and

14 (b) The applicant demonstrates that it is necessary for him or her 15 to operate a motor vehicle because he or she:

16 (i) Is engaged in an occupation or trade that makes it essential 17 that he or she operate a motor vehicle;

18 (ii) Is undergoing continuing health care or providing continuing 19 care to another who is dependent upon the applicant;

20 (iii) Is enrolled in an educational institution and pursuing a 21 course of study leading to a diploma, degree, or other certification of 22 successful educational completion;

(iv) Is undergoing substance abuse treatment or is participating in meetings of a twelve-step group such as Alcoholics Anonymous that requires the petitioner to drive to or from the treatment or meetings;

(v) Is fulfilling court-ordered community service responsibilities;
(vi) Is in a program that assists persons who are enrolled in a
WorkFirst program pursuant to chapter 74.08A RCW to become gainfully
employed and the program requires a driver's license;

30 (vii) Is in an apprenticeship, on-the-job training, or welfare-to-31 work program; or

32 (viii) Presents evidence that he or she has applied for a position 33 in an apprenticeship or on-the-job training program for which a 34 driver's license is required to begin the program, provided that a 35 license granted under this provision shall be in effect for no longer 36 than fourteen days; and

37 (c) The applicant files satisfactory proof of financial 38 responsibility under chapter 46.29 RCW; and

(d) Upon receipt of evidence that a holder of an occupational 1 2 driver's license granted under this subsection is no longer enrolled in an apprenticeship or on-the-job training program, the director shall 3 4 give written notice by first-class mail to the driver that the occupational driver's license shall be canceled. ((The effective date 5 6 of cancellation shall be fifteen days from the date of mailing the 7 notice.)) If at any time before the cancellation goes into effect the 8 driver submits evidence of continued enrollment in the program, the 9 cancellation shall be stayed. 20 The director shall cancel an occupational or temporary (5) 21 restricted driver's license ((upon receipt of)) after receiving notice 22 that the holder thereof has been convicted of operating a motor vehicle in violation of its restrictions, no longer meets the eligibility 23 24 requirements, or ((of)) has been convicted of or found to have committed a separate offense or any other act or omission that under 25 26 this chapter ((46.20 RCW)) would warrant suspension or revocation of a 27 regular driver's license. The department must give notice of the cancellation ((is effective as of the date of the conviction, and 28 continues with the same force and effect as any suspension or 29 revocation under this title)) as provided under RCW 46.20.245. A 30 person whose occupational or temporary restricted driver's license has 31 been canceled under this section may reapply for a new occupational or 32 temporary restricted driver's license if he or she is otherwise 33 qualified under this section and pays the fee required under RCW 34 35 46.20.380.

36 **Sec. 3.** RCW 46.20.720 and 2008 c 282 s 12 are each amended to read 37 as follows:

(1) The court may order that after a period of suspension, 1 2 revocation, or denial of driving privileges, and for up to as long as the court has jurisdiction, any person convicted of any offense 3 4 involving the use, consumption, or possession of alcohol while operating a motor vehicle may drive only a motor vehicle equipped with 5 a functioning ignition interlock. The court shall establish a specific 6 calibration setting at which the interlock will prevent the vehicle 7 8 from being started. The court shall also establish the period of time 9 for which interlock use will be required.

(2) Under RCW 46.61.5055((, 10.05.020, or section 18 of this act)) 10 11 and subject to the exceptions listed in that statute, the court shall 12 order any person convicted of ((an alcohol-related)) a violation of RCW 13 46.61.502 or 46.61.504 or an equivalent local ordinance ((or participating in a deferred prosecution program under RCW 10.05.020 or 14 section 18 of this act for an alcohol-related violation of RCW 15 46.61.502 or 46.61.504 or an equivalent local ordinance)) to apply for 16 an ignition interlock driver's license from the department under RCW 17 18 46.20.385 and to have a functioning ignition interlock device installed 19 on all motor vehicles operated by the person.

(3) The department shall require that, after any applicable period of suspension, revocation, or denial of driving privileges, a person may drive only a motor vehicle equipped with a functioning ignition interlock device if the person is convicted of ((an alcohol-related)) <u>a</u> violation of RCW 46.61.502 or 46.61.504 or an equivalent local <u>or</u> <u>out-of-state statute or</u> ordinance.

26 The department may waive the requirement for the use of such a 27 device if it concludes that such devices are not reasonably available in the local area. The installation of an ignition interlock device is 28 not necessary on vehicles owned, leased, or rented by a person's 29 30 employer and on those vehicles whose care and/or maintenance is the temporary responsibility of the employer, and driven at the direction 31 of a person's employer as a requirement of employment during working 32 33 The person must provide the department with a declaration hours. pursuant to RCW 9A.72.085 from his or her employer stating that the 34 35 person's employment requires the person to operate a vehicle owned by 36 the employer or other persons during working hours.

The ignition interlock device shall be calibrated to prevent the motor vehicle from being started when the breath sample provided has an

1 alcohol concentration of 0.025 or more. Subject to the provisions of 2 subsection (4) of this section, the period of time of the restriction 3 will be ((as follows)) no less than:

4 (a) For a person who has not previously been restricted under this
5 section, a period of one year;

6 (b) For a person who has previously been restricted under (a) of 7 this subsection, a period of five years;

8 (c) For a person who has previously been restricted under (b) of 9 this subsection, a period of ten years.

10 (4) A restriction imposed under subsection (3) of this section 11 shall remain in effect until the department receives a declaration from 12 the person's ignition interlock device vendor, in a form provided or 13 approved by the department, certifying that there have been none of the 14 following incidents in the four consecutive months prior to the date of 15 release:

(1) Except as provided in RCW 46.61.502(6) or 46.61.504(6), a person who is convicted of a violation of RCW 46.61.502 or 46.61.504 and who has no prior offense within seven years shall be punished as follows:

(a) In the case of a person whose alcohol concentration was less
than 0.15, or for whom for reasons other than the person's refusal to
take a test offered pursuant to RCW 46.20.308 there is no test result
indicating the person's alcohol concentration:

(i) By imprisonment for not less than one day nor more than one year. Twenty-four consecutive hours of the imprisonment may not be suspended or deferred unless the court finds that the imposition of this mandatory minimum sentence would impose a substantial risk to the offender's physical or mental well-being. Whenever the mandatory minimum sentence is suspended or deferred, the court shall state in

writing the reason for granting the suspension or deferral and the 1 2 facts upon which the suspension or deferral is based. In lieu of the mandatory minimum term of imprisonment required under this subsection 3 4 (1)(a)(i), the court may order not less than fifteen days of electronic home monitoring. The offender shall pay the cost of electronic home 5 6 monitoring. The county or municipality in which the penalty is being 7 imposed shall determine the cost. The court may also require the offender's electronic home monitoring device to include an alcohol 8 9 detection breathalyzer, and the court may restrict the amount of alcohol the offender may consume during the time the offender is on 10 11 electronic home monitoring; and

(ii) By a fine of not less than three hundred fifty dollars nor more than five thousand dollars. Three hundred fifty dollars of the fine may not be suspended or deferred unless the court finds the offender to be indigent; or

(b) In the case of a person whose alcohol concentration was at least 0.15, or for whom by reason of the person's refusal to take a test offered pursuant to RCW 46.20.308 there is no test result indicating the person's alcohol concentration:

20 (i) By imprisonment for not less than two days nor more than one 21 year. Two consecutive days of the imprisonment may not be suspended or 22 deferred unless the court finds that the imposition of this mandatory minimum sentence would impose a substantial risk to the offender's 23 24 physical or mental well-being. Whenever the mandatory minimum sentence is suspended or deferred, the court shall state in writing the reason 25 26 for granting the suspension or deferral and the facts upon which the 27 suspension or deferral is based. The county or municipality where the penalty is being imposed shall determine the 14 The court may also require the offender's electronic home 15 cost. monitoring device include an alcohol detection breathalyzer, and may 16 restrict the amount of alcohol the offender may consume during the time 17 the offender is on electronic home monitoring. 18 Thirty days of imprisonment and sixty days of electronic home monitoring may not be 19 suspended or deferred unless the court finds that the imposition of 20 21 this mandatory minimum sentence would impose a substantial risk to the 22 offender's physical or mental well-being. Whenever the mandatory minimum sentence is suspended or deferred, the court shall state in 23 writing the reason for granting the suspension or deferral and the 24 facts upon which the suspension or deferral is based; and 25

(ii) By a fine of not less than five hundred dollars nor more than five thousand dollars. Five hundred dollars of the fine may not be suspended or deferred unless the court finds the offender to be indigent; or

30 (b) In the case of a person whose alcohol concentration was at 31 least 0.15, or for whom by reason of the person's refusal to take a 32 test offered pursuant to RCW 46.20.308 there is no test result 33 indicating the person's alcohol concentration:

(i) By imprisonment for not less than forty-five days nor more than
 one year and ninety days of electronic home monitoring. The offender
 shall pay for the cost of the electronic monitoring. The county or
 municipality where the penalty is being imposed shall determine the
 cost. The court may also require the offender's electronic home

monitoring device include an alcohol detection breathalyzer, and may 1 2 restrict the amount of alcohol the offender may consume during the time the offender is on electronic home monitoring. Forty-five days of 3 4 imprisonment and ninety days of electronic home monitoring may not be suspended or deferred unless the court finds that the imposition of 5 6 this mandatory minimum sentence would impose a substantial risk to the offender's physical or mental well-being. 7 Whenever the mandatory 8 minimum sentence is suspended or deferred, the court shall state in 9 writing the reason for granting the suspension or deferral and the facts upon which the suspension or deferral is based; and 10

(ii) By a fine of not less than seven hundred fifty dollars nor more than five thousand dollars. Seven hundred fifty dollars of the fine may not be suspended or deferred unless the court finds the offender to be indigent.

15 (3) Except as provided in RCW 46.61.502(6) or 46.61.504(6), a 16 person who is convicted of a violation of RCW 46.61.502 or 46.61.504 17 and who has two or three prior offenses within seven years shall be 18 punished as follows:

(a) In the case of a person whose alcohol concentration was less than 0.15, or for whom for reasons other than the person's refusal to take a test offered pursuant to RCW 46.20.308 there is no test result indicating the person's alcohol concentration:

The offender shall pay for the cost of the electronic monitoring. 25 The 26 county or municipality where the penalty is being imposed shall determine the cost. 27 The court may also require the offender's electronic home monitoring device include an alcohol 28 detection breathalyzer, and may restrict the amount of alcohol the offender may 29 30 consume during the time the offender is on electronic home monitoring. Ninety days of imprisonment and one hundred twenty days of electronic 31 32 home monitoring may not be suspended or deferred unless the court finds 33 that the imposition of this mandatory minimum sentence would impose a substantial risk to the offender's physical or mental well-being. 34 35 Whenever the mandatory minimum sentence is suspended or deferred, the 36 court shall state in writing the reason for granting the suspension or 37 deferral and the facts upon which the suspension or deferral is based; 38 and

1 (ii) By a fine of not less than one thousand dollars nor more than 2 five thousand dollars. One thousand dollars of the fine may not be 3 suspended or deferred unless the court finds the offender to be 4 indigent; or

5 (b) In the case of a person whose alcohol concentration was at 6 least 0.15, or for whom by reason of the person's refusal to take a 7 test offered pursuant to RCW 46.20.308 there is no test result 8 indicating the person's alcohol concentration:

9 (i) By imprisonment for not less than one hundred twenty days nor more than one year and one hundred fifty days of electronic home 10 11 monitoring. The offender shall pay for the cost of the electronic 12 monitoring. The county or municipality where the penalty is being 13 imposed shall determine the cost. The court may also require the offender's electronic home monitoring device include an alcohol 14 15 detection breathalyzer, and may restrict the amount of alcohol the offender may consume during the time the offender is on electronic home 16 monitoring. One hundred twenty days of imprisonment and one hundred 17 fifty days of electronic home monitoring may not be suspended or 18 19 deferred unless the court finds that the imposition of this mandatory minimum sentence would impose a substantial risk to the offender's 20 21 physical or mental well-being. Whenever the mandatory minimum sentence 22 is suspended or deferred, the court shall state in writing the reason 23 for granting the suspension or deferral and the facts upon which the 24 suspension or deferral is based; and

(ii) By a fine of not less than one thousand five hundred dollars nor more than five thousand dollars. One thousand five hundred dollars of the fine may not be suspended or deferred unless the court finds the offender to be indigent.

(4) A person who is convicted of a violation of RCW 46.61.502 or 29 46.61.504 shall be punished under chapter 9.94A RCW if: (a) The person 30 has four or more prior offenses within ten years; or (b) the person has 31 ever previously been convicted of: (i) A violation of RCW 46.61.520 32 committed while under the influence of intoxicating liquor or any drug; 33 (ii) a violation of RCW 46.61.522 committed while under the influence 34 35 of intoxicating liquor or any drug; or (iii) an out-of-state offense 36 comparable to the offense specified in (b)(i) or (ii) of this 37 subsection.

1 (5)(a) The court shall require any person convicted of ((an 2 alcohol-related)) <u>a</u> violation of RCW 46.61.502 or 46.61.504 <u>or an</u> 3 <u>equivalent local ordinance</u> to apply for an ignition interlock driver's 4 license from the department ((under RCW 46.20.385)) and to have a 5 functioning ignition interlock device installed on all motor vehicles 6 operated by the person.

The person shall pay for the cost of the monitoring. The county or municipality where the penalty is being imposed shall 11 12 determine the cost.

13 (((f))) <u>(g)</u> The period of time for which ignition interlock use or 14 alcohol monitoring is required will be as follows:

(i) For a person who has not previously been restricted under thissection, a period of one year;

11 If a petitioner, who has been accepted for a deferred prosecution, 12 fails or neglects to carry out and fulfill any term or condition of the petitioner's treatment plan or any term or condition imposed in 13 connection with the installation of an interlock or other device under 14 RCW 46.20.720 ((or 46.20.385)), the facility, center, institution, or 15 agency administering the treatment or the entity administering the use 16 17 of the device, shall immediately report such breach to the court, the 18 prosecutor, and the petitioner or petitioner's attorney of record, together with its recommendation. The court upon receiving such a 19 20 report shall hold a hearing to determine whether the petitioner should 21 be removed from the deferred prosecution program. ((If the petitioner's noncompliance is based on a violation of a term or condition imposed in 27 28 connection with the installation of an ignition interlock device under 29 RCW 46.20.385, the court shall either order that the petitioner comply 30 with the term or condition or be removed from deferred prosecution.)) If removed from deferred prosecution, the court shall enter judgment 31 pursuant to RCW 10.05.020 and, if the charge for which the deferred 32 prosecution was granted was a misdemeanor or gross misdemeanor under 33 34 Title 46 RCW, shall notify the department of licensing of the removal 35 and entry of judgment.

1 **Sec. 11.** RCW 10.05.160 and 2008 c 282 s 19 are each amended to 2 read as follows:

3 The prosecutor may appeal an order granting deferred prosecution on 4 any or all of the following grounds:

5

(1) Prior deferred prosecution has been granted to the defendant;

6 (2) Failure of the court to obtain proof of insurance or a 7 treatment plan conforming to the requirements of this chapter;

8 (3) Failure of the court to comply with the requirements of RCW9 10.05.100;

10 (4) Failure of the evaluation facility to provide the information 11 required in RCW 10.05.040 and 10.05.050, if the defendant has been 12 referred to the facility for treatment. If an appeal on such basis is 13 successful, the trial court may consider the use of another treatment 14 program;

(5) Failure of the court to order the installation of an ignition interlock or other device under RCW ((46.20.720 or 46.20.385)) 17 <u>10.05.140</u>.
