1 AN ACT Relating to performance-based contracts for the provision of
2 child welfare services; amending RCW 74.13.020, 74.15.010, 74.15.020,

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

8 NEW SECTION. **Sec. 1.** A new section is added to chapter 74.13 RCW
9 to read as follows:

10 The legislature declares that the safety and well-being of children
11 and families is essential to the social and economic health of
12 Washington. It is the duty of the state to provide children at risk of
13 out-of-home placement and their families with reasonable opportunities
14 to access supportive services that enhance their safety and well-being.
15 The legislature intends the new programmatic and administrative changes
16 required in this act to be accomplished in conformance with this
17 foregoing principle.

18 The legislature finds that research in the area of child safety and
19 well-being supports the conclusion that a restructuring of the
20 administration and delivery of child welfare services through the use
21 of performance-based contracts can enhance safety and well-being, when
22 done so in a careful, well-planned and collaborative manner.

23 The legislature intends that the execution of performance-based
24 contracts which transfer the delivery of child welfare services to
25 entities other than the department be done without restricting who may
26 seek to participate in the procurement process of the contracts. The
27 legislature intends that the department shall retain those positions
28 necessary to provide child protective and investigative services and to
29 administer performance-based contracts.

30 The legislature, in creating the committee in section 7 of this
31 act, is establishing the mechanism to design, in collaboration with the
32 department, the transition to performance-based contracts in the
33 delivery of out-of-home care and case management services.

34 **Sec. 2.** RCW 74.13.020 and 1999 c 267 s 7 are each amended to read
35 as follows:

1 ((As used in Title 74 RCW, child welfare services shall be defined
2 as public social services including adoption services which strengthen,
3 supplement, or substitute for, parental care and supervision for the
4 purpose of:

5 (1) Preventing or remedying, or assisting in the solution of
6 problems which may result in families in conflict, or the neglect,
7 abuse, exploitation, or criminal behavior of children;

8 (2) Protecting and caring for dependent or neglected children;

9 (3) Assisting children who are in conflict with their parents, and
10 assisting parents who are in conflict with their children with services
11 designed to resolve such conflicts;

12 (4) Protecting and promoting the welfare of children, including the
13 strengthening of their own homes where possible, or, where needed;

14 (5) Providing adequate care of children away from their homes in
15 foster family homes or day care or other child care agencies or
16 facilities.

17 As used in this chapter, child means a person less than eighteen
18 years of age.

19 The department's duty to provide services to homeless families with
20 children is set forth in RCW 43.20A.790 and in appropriations provided
21 by the legislature for implementation of the plan.))

22 For purposes of this chapter:

23 (1) "Case management" means those services, including permanency
24 services, to a child for whom the department has legal custody,
25 including caseworker-child visits, family visits, the convening of
26 family group conferences, the development and revision of the case
27 plan, the coordination and monitoring of services needed by the child
28 and family, and the assumption of court-related duties, including
29 preparing court reports, attending judicial hearings and permanency
30 hearings, and ensuring that the child is progressing toward permanency
31 within state and federal mandates, including the Indian child welfare
32 act.

33 (2) "Child" means a person less than eighteen years of age.

34 (3) "Child protective services" has the same meaning as in RCW
35 26.44.020.

36 (4) "Child welfare services" means social services including out-
37 of-home care, case management, and adoption services which strengthen,

1 supplement, or substitute for, parental care and supervision for the
2 purpose of:

3 (a) Preventing or remedying, or assisting in the solution of
4 problems which may result in families in conflict, or the neglect,
5 abuse, exploitation, or criminal behavior of children;

6 (b) Protecting and caring for dependent or neglected children;

7 (c) Assisting children who are in conflict with their parents, and
8 assisting parents who are in conflict with their children, with
9 services designed to resolve such conflicts;

10 (d) Protecting and promoting the welfare of children, including the
11 strengthening of their own homes where possible, or, where needed;

12 (e) Providing adequate care of children away from their homes in
13 foster family homes or day care or other child care agencies or
14 facilities.

15 "Child welfare services" does not include child protection
16 services.

17 (5) "Committee" means the child welfare transformation design
18 committee.

19 (6) "Department" means the department of social and health
20 services.

21 (7) "Outcomes" means a statistically significant change in the
22 service or services a supervising agency is assigned in a performance-
23 based contract, in time periods established in the contract.

24 (8) "Out-of-home care services" means services provided after the
25 shelter care hearing to or for children in out-of-home care, as that
26 term is defined in RCW 13.34.030, and their families, including the
27 recruitment, training, and management of foster parents, the
28 recruitment of adoptive families, and the facilitation of the adoption
29 process, family reunification, independent living, emergency shelter,
30 residential group care, and foster care, including relative placement.

31 (9) "Performance-based contracting" means the structuring of all
32 aspects of the procurement of services around the purpose of the work
33 to be performed and the desired results with the contract requirements
34 set forth in clear, specific, and objective terms with measurable
35 outcomes. Contracts shall also include provisions that link the
36 performance of the contractor to the level and timing of reimbursement.

37 (10) "Permanency services" means long-term services provided to

1 secure a child's safety, permanency, and well-being, including foster
2 care services, family reunification services, adoption services, and
3 preparation for independent living services.

4 (11) "Supervising agency" means an agency licensed by the state
5 under RCW 74.15.090, or an Indian tribe under RCW 74.15.190, that has
6 entered into a performance-based contract with the department to
7 provide child welfare services. "Supervising agency" also includes the
8 department under section 3(4) of this act.

9 NEW SECTION. Sec. 3. A new section is added to chapter 74.13 RCW
10 to read as follows:

11 (1) On and after December 1, 2010, the department shall begin to
12 convert its current contracts with child-placing agencies into
13 performance-based contracts to provide child welfare services in this
14 state.

15 (2) On and after July 1, 2014:

16 (a) All child welfare services for children for whom the department
17 has legal custody shall be provided by supervising agencies with whom
18 the department has entered into performance-based contracts; and

19 (b) Except as provided in subsection (4) of this section, and
20 notwithstanding any law to the contrary, the department may not
21 directly provide child welfare services.

22 (3) On and after July 1, 2014, the department is responsible for
23 only the following:

24 (a) Monitoring the quality of services for which the department
25 contracts under this chapter; and

26 (b) Ensuring that the services are provided in accordance with
27 federal law and the laws of this state, including the Indian child
28 welfare act.

29 (4) On and after July 1, 2014, the department may provide child
30 welfare services only in an emergency or as a provider of last resort.
31 The department shall adopt rules describing the circumstances under
32 which the department may provide those services. For purposes of this
33 section, "provider of last resort" means the department is unable to
34 contract with a private agency to provide child welfare services in a
35 particular geographic area or, after entering into a contract with a
36 private agency, either the contractor or the department precipitously
37 terminates the contract.

1 (5) For purposes of this chapter, on and after July 1, 2010,
2 performance-based contracts shall be structured to hold the supervising
3 agencies accountable for achieving the following goals in order of
4 importance: Child safety; reunification of the child with the child's
5 parents; child permanency; and child well-being.

6 NEW SECTION. **Sec. 4.** A new section is added to chapter 74.13 RCW
7 to read as follows:

8 Except for Indian tribes, performance-based contracts with private
9 nonprofit entities who otherwise meet the definition of supervising
10 agency shall be preferred.

11 NEW SECTION. **Sec. 5.** A new section is added to chapter 43.10 RCW
12 to read as follows:

13 The office of the attorney general shall provide, or cause to be
14 provided, legal services in only dependency or termination of parental
15 rights matters to supervising agencies with whom the department of
16 social and health services has entered into performance-based contracts
17 to provide child welfare services as soon as the contracts become
18 effective.

19 NEW SECTION. **Sec. 6.** A new section is added to chapter 74.13 RCW
20 to read as follows:

21 As child welfare services caseworker and staff vacancies occur due
22 to voluntary employee departures, and if the department determines
23 those positions should be filled by state workers because there are
24 insufficient supervising agency resources available in that region to
25 provide the necessary child welfare services, the department shall
26 review its current staff assignments and transfer staff with sufficient
27 child welfare services experience in other units in the region to the
28 vacant child welfare services position or positions. If this occurs,
29 the department shall determine if there are other services in the
30 region where the work could be performed by supervising agencies.

31 NEW SECTION. **Sec. 7.** A new section is added to chapter 74.13 RCW
32 to read as follows:

33 (1)(a) The child welfare transformation design committee is
34 established, with members as provided in this subsection.

1 (i) Four private agencies that, as of the effective date of this
2 section, provide child welfare services to children and families
3 referred to them by the department. Two agencies must be headquartered
4 in western Washington and two must be headquartered in eastern
5 Washington. Two agencies must have an annual budget of at least one
6 million state-contracted dollars and two must have an annual budget of
7 less than one million state-contracted dollars;

8 (ii) The assistant secretary of the children's administration in
9 the department;

10 (iii) Two regional administrators in the children's administration
11 selected by the assistant secretary, one from one of the department's
12 administrative regions one or two, and one from one of the department's
13 administrative regions three, four, five, or six;

14 (iv) The administrator for the division of licensed resources in
15 the children's administration;

16 (v) Two nationally recognized experts in performance-based
17 contracts;

18 (vi) The attorney general or his or her designee;

19 (vii) A representative of the collective bargaining unit that
20 represents the largest number of employees in the children's
21 administration;

22 (viii) A representative from the office of the family and
23 children's ombudsman;

24 (ix) Four representatives from federally recognized Indian tribes,
25 two of which operate child welfare programs;

26 (x) Two present or former superior court judges with significant
27 experience in dependency matters, selected by the superior court
28 judge's association; and

29 (xi) One representative from partners for our children affiliated
30 with the University of Washington school of social work.

31 (b) The president of the senate and the speaker of the house of
32 representatives shall jointly appoint the members under (a)(i) and (v)
33 of this subsection.

34 (c) The representatives from partners for our children shall
35 convene the initial meeting of the committee no later than June 15,
36 2009.

37 (d) The chair or cochairs of the committee shall be selected from

1 among its membership by a majority vote of those present at the initial
2 meeting.

3 (2) The committee shall establish a transition plan containing
4 recommendations to the legislature consistent with this section for the
5 provision of child welfare services by child-placing agencies pursuant
6 to section 3 of this act.

7 (3) The plan shall include the following:

8 (a) A model or framework for performance-based contracts to be used
9 by the department that clearly defines:

10 (i) The target population;

11 (ii) The contract referral and exit criteria;

12 (iii) The child welfare services including the use of evidence-
13 based services and practices to be provided by the contractor;

14 (iv) The roles and responsibilities of public and private agency
15 workers in key case decisions;

16 (v) Contract performance and outcomes;

17 (vi) How to measure whether each contractor has met the goals
18 listed in section 3(5) of this act; and

19 (vii) Incentives to meet program goals;

20 (b) A method by which the department will substantially reduce its
21 current number of contracts for child welfare services;

22 (c) A method or methods by which clients will access community-
23 based services, how private supervising agencies will engage other
24 services or form local service networks, develop subcontracts, and
25 share information and supervision of children;

26 (d) Contract monitoring and evaluation procedures that will ensure
27 that children and families are receiving timely and quality services
28 and that contract terms are being implemented;

29 (e) A method or methods by which to ensure that the children's
30 administration has sufficiently trained and experienced staff to
31 monitor and manage performance-based contracts;

32 (f) A process by which to expand the capacity of supervising and
33 other private agencies to meet the service needs of children and
34 families in a performance-based contractual arrangement;

35 (g) A method or methods by which supervising and other private
36 agencies can expand services in underserved areas of the state;

37 (h) The appropriate amounts and procedures for the reimbursement of
38 supervising agencies given the proposed services restructuring;

1 (i) A method by which to access and enhance existing data systems
2 to include contract performance information;

3 (j) A financing arrangement for the contracts that examines:

4 (i) The use of case rates or performance-based fee-for-service
5 contracts that include incentive payments or payment schedules that
6 link reimbursement to results; and

7 (ii) Ways to reduce a contractor's financial risk that could
8 jeopardize the solvency of the contractor, including the use of a risk-
9 reward corridor that limits risk of loss and potential profits or the
10 establishment of a statewide risk pool;

11 (k) A description of how the transition will impact the state's
12 ability to obtain federal funding and examine options to further
13 maximize federal funding opportunities and increased flexibility;

14 (l) A description of the costs of the transition, the initial
15 start-up costs and the mechanisms to periodically assess the overall
16 adequacy of funds and the fiscal impact of the changes, and the
17 feasibility of the plan and the impact of the plan on department
18 employees during the transition; and

19 (m) Identification of any statutory and regulatory revisions
20 necessary to accomplish the transition.

21 (4) The committee shall also prepare as part of the plan a
22 recommendation as to how to implement the changes in this chapter
23 across the state in three stages so that the full implementation of
24 this chapter is achieved no later than July 1, 2014.

25 (5) The committee shall report quarterly on its progress, beginning
26 on June 30, 2009, to the legislative children's oversight committee
27 established in RCW 44.04.220. The committee shall report on its
28 progress in meeting its duties under subsections (2) and (3) of this
29 section and on any other matters the committee or the legislative
30 children's oversight committee deems appropriate. The portion of the
31 plan required in subsection (4) of this section shall be due to the
32 legislative children's oversight committee on or before June 1, 2010.
33 The reports shall be in written form.

34 (6) The committee, by majority vote, may establish advisory
35 committees as it deems necessary.

36 (7) All state executive branch agencies shall cooperate with the
37 committee and provide timely information as the chair or cochairs may

1 request. Cooperation by the children's administration must include
2 developing and scheduling training for supervising agencies to access
3 data and information necessary to implement and monitor the contracts.

4 (8) It is expected that the administrative costs for the committee
5 will be supported through private funds.

6 (9) Staff support for the committee shall be provided jointly by
7 partners for our children and legislative staff.

8 (10) The committee is subject to chapters 42.30 (open public
9 meetings act) and 42.52 (ethics in public service) RCW.

10 (11) This section expires July 1, 2013.

11 **Sec. 8.** RCW 74.15.010 and 1995 c 302 s 2 are each amended to read
12 as follows:

13 The purpose of chapter 74.15 RCW and RCW 74.13.031 is:

14 (1) To safeguard the health, safety, and well-being of children,
15 expectant mothers and developmentally disabled persons receiving care
16 away from their own homes, which is paramount over the right of any
17 person to provide care;

18 (2) To strengthen and encourage family unity and to sustain
19 parental rights and responsibilities to the end that foster care is
20 provided only when a child's family, through the use of all available
21 resources, is unable to provide necessary care;

22 (3) To promote the development of a sufficient number and variety
23 of adequate (~~child-care~~) foster family homes and maternity-care
24 facilities, both public and private, through the cooperative efforts of
25 public and (~~voluntary~~) supervising agencies and related groups;

26 (4) To provide consultation to agencies caring for children,
27 expectant mothers or developmentally disabled persons in order to help
28 them to improve their methods of and facilities for care;

29 (5) To license agencies as defined in RCW 74.15.020 and to assure
30 the users of such agencies, their parents, the community at large and
31 the agencies themselves that adequate minimum standards are maintained
32 by all agencies caring for children, expectant mothers and
33 developmentally disabled persons.

34 **Sec. 9.** RCW 74.15.020 and 2007 c 412 s 1 are each amended to read
35 as follows:

1 For the purpose of this chapter and RCW 74.13.031, and unless
2 otherwise clearly indicated by the context thereof, the following terms
3 shall mean:

4 (1) "Agency" means any person, firm, partnership, association,
5 corporation, or facility which receives children, expectant mothers, or
6 persons with developmental disabilities for control, care, or
7 maintenance outside their own homes, or which places, arranges the
8 placement of, or assists in the placement of children, expectant
9 mothers, or persons with developmental disabilities for foster care or
10 placement of children for adoption, and shall include the following
11 irrespective of whether there is compensation to the agency or to the
12 children, expectant mothers or persons with developmental disabilities
13 for services rendered:

14 (a) "Child-placing agency" means an agency which places a child or
15 children for temporary care, continued care, or for adoption;

16 (b) "Community facility" means a group care facility operated for
17 the care of juveniles committed to the department under RCW 13.40.185.
18 A county detention facility that houses juveniles committed to the
19 department under RCW 13.40.185 pursuant to a contract with the
20 department is not a community facility;

21 (c) "Crisis residential center" means an agency which is a
22 temporary protective residential facility operated to perform the
23 duties specified in chapter 13.32A RCW, in the manner provided in RCW
24 74.13.032 through 74.13.036;

25 (d) "Emergency respite center" is an agency that may be commonly
26 known as a crisis nursery, that provides emergency and crisis care for
27 up to seventy-two hours to children who have been admitted by their
28 parents or guardians to prevent abuse or neglect. Emergency respite
29 centers may operate for up to twenty-four hours a day, and for up to
30 seven days a week. Emergency respite centers may provide care for
31 children ages birth through seventeen, and for persons eighteen through
32 twenty with developmental disabilities who are admitted with a sibling
33 or siblings through age seventeen. Emergency respite centers may not
34 substitute for crisis residential centers or HOPE centers, or any other
35 services defined under this section, and may not substitute for
36 services which are required under chapter 13.32A or 13.34 RCW;

37 (e) "Foster-family home" means an agency which regularly provides
38 care on a twenty-four hour basis to one or more children, expectant

1 mothers, or persons with developmental disabilities in the family abode
2 of the person or persons under whose direct care and supervision the
3 child, expectant mother, or person with a developmental disability is
4 placed;

5 (f) "Group-care facility" means an agency, other than a foster-
6 family home, which is maintained and operated for the care of a group
7 of children on a twenty-four hour basis;

8 (g) "HOPE center" means an agency licensed by the secretary to
9 provide temporary residential placement and other services to street
10 youth. A street youth may remain in a HOPE center for thirty days
11 while services are arranged and permanent placement is coordinated. No
12 street youth may stay longer than thirty days unless approved by the
13 department and any additional days approved by the department must be
14 based on the unavailability of a long-term placement option. A street
15 youth whose parent wants him or her returned to home may remain in a
16 HOPE center until his or her parent arranges return of the youth, not
17 longer. All other street youth must have court approval under chapter
18 13.34 or 13.32A RCW to remain in a HOPE center up to thirty days;

19 (h) "Maternity service" means an agency which provides or arranges
20 for care or services to expectant mothers, before or during
21 confinement, or which provides care as needed to mothers and their
22 infants after confinement;

23 (i) "Responsible living skills program" means an agency licensed by
24 the secretary that provides residential and transitional living
25 services to persons ages sixteen to eighteen who are dependent under
26 chapter 13.34 RCW and who have been unable to live in his or her
27 legally authorized residence and, as a result, the minor lived outdoors
28 or in another unsafe location not intended for occupancy by the minor.
29 Dependent minors ages fourteen and fifteen may be eligible if no other
30 placement alternative is available and the department approves the
31 placement;

32 (j) "Service provider" means the entity that operates a community
33 facility.

34 (2) "Agency" shall not include the following:

35 (a) Persons related to the child, expectant mother, or person with
36 developmental disability in the following ways:

37 (i) Any blood relative, including those of half-blood, and

1 including first cousins, second cousins, nephews or nieces, and persons
2 of preceding generations as denoted by prefixes of grand, great, or
3 great-great;

4 (ii) Stepfather, stepmother, stepbrother, and stepsister;

5 (iii) A person who legally adopts a child or the child's parent as
6 well as the natural and other legally adopted children of such persons,
7 and other relatives of the adoptive parents in accordance with state
8 law;

9 (iv) Spouses of any persons named in (i), (ii), or (iii) of this
10 subsection (2)(a), even after the marriage is terminated;

11 (v) Relatives, as named in (i), (ii), (iii), or (iv) of this
12 subsection (2)(a), of any half sibling of the child; or

13 (vi) Extended family members, as defined by the law or custom of
14 the Indian child's tribe or, in the absence of such law or custom, a
15 person who has reached the age of eighteen and who is the Indian
16 child's grandparent, aunt or uncle, brother or sister, brother-in-law
17 or sister-in-law, niece or nephew, first or second cousin, or
18 stepparent who provides care in the family abode on a twenty-four-hour
19 basis to an Indian child as defined in 25 U.S.C. Sec. 1903(4);

20 (b) Persons who are legal guardians of the child, expectant mother,
21 or persons with developmental disabilities;

22 (c) Persons who care for a neighbor's or friend's child or
23 children, with or without compensation, where the parent and person
24 providing care on a twenty-four-hour basis have agreed to the placement
25 in writing and the state is not providing any payment for the care;

26 (d) A person, partnership, corporation, or other entity that
27 provides placement or similar services to exchange students or
28 international student exchange visitors or persons who have the care of
29 an exchange student in their home;

30 (e) A person, partnership, corporation, or other entity that
31 provides placement or similar services to international children who
32 have entered the country by obtaining visas that meet the criteria for
33 medical care as established by the United States citizenship and
34 immigration (~~(and naturalization)~~) services, or persons who have the
35 care of such an international child in their home;

36 (f) Schools, including boarding schools, which are engaged
37 primarily in education, operate on a definite school year schedule,

1 follow a stated academic curriculum, accept only school-age children
2 and do not accept custody of children;

3 (g) Hospitals licensed pursuant to chapter 70.41 RCW when
4 performing functions defined in chapter 70.41 RCW, nursing homes
5 licensed under chapter 18.51 RCW and boarding homes licensed under
6 chapter 18.20 RCW;

7 (h) Licensed physicians or lawyers;

8 (i) Facilities approved and certified under chapter 71A.22 RCW;

9 (j) Any agency having been in operation in this state ten years
10 prior to June 8, 1967, and not seeking or accepting moneys or
11 assistance from any state or federal agency, and is supported in part
12 by an endowment or trust fund;

13 (k) Persons who have a child in their home for purposes of
14 adoption, if the child was placed in such home by a licensed child-
15 placing agency, an authorized public or tribal agency or court or if a
16 replacement report has been filed under chapter 26.33 RCW and the
17 placement has been approved by the court;

28 sister, adoptive brother, adoptive sister, half-brother, or half-
29 sister, or as defined by the law or custom of the Indian child's tribe
30 for an Indian child as defined in 25 U.S.C. Sec. 1903(4).

31 (~~(15)~~) (16) "Social study" means a written evaluation of matters
32 relevant to the disposition of the case and shall contain the following
33 information:

34 (a) A statement of the specific harm or harms to the child that
35 intervention is designed to alleviate;

36 (b) A description of the specific services and activities, for both
37 the parents and child, that are needed in order to prevent serious harm
38 to the child; the reasons why such services and activities are likely

20 child and the child's siblings if appropriate; and

21 (f) Behavior that will be expected before determination that
22 supervision of the family or placement is no longer necessary.

23 (17) "Supervising agency" means an agency licensed by the state
24 under RCW 74.15.090 or an Indian tribe under RCW 74.15.190 with whom
25 the department has entered into a performance-based contract to provide
26 child welfare services as defined in RCW 74.13.020. "Supervising
27 agency" also includes the department under section 3(4) of this act.

30 (1)(a) When a child is taken into custody, the court shall hold a
31 shelter care hearing within seventy-two hours, excluding Saturdays,

20 maintaining parent-child relationships and making it possible for
21 parents and children to safely reunify. The supervising agency shall
22 encourage the maximum parent and child and sibling contact possible,
23 when it is in the best interest of the child, including regular
24 visitation and participation by the parents in the care of the child
25 while the child is in placement. Visitation shall not be limited as a
26 sanction for a parent's failure to comply with court orders or services
27 where the health, safety, or welfare of the child is not at risk as a
28 result of the visitation. Visitation may be limited or denied only if
29 the court determines that such limitation or denial is necessary to
30 protect the child's health, safety, or welfare. The court and the
31 supervising agency should rely upon community resources, relatives,
32 foster parents, and other appropriate persons to provide transportation
33 and supervision for visitation to the extent that such resources are
34 available, and appropriate, and the child's safety would not be
35 compromised.

36 (iii) A child shall be placed as close to the child's home as
37 possible, preferably in the child's own neighborhood, unless the court

1 finds that placement at a greater distance is necessary to promote the
2 child's or parents' well-being.

3 (iv) The plan shall state whether both in-state and, where
4 appropriate, out-of-state placement options have been considered by the
5 (~~department~~) supervising agency.

6 (v) Unless it is not in the best interests of the child, whenever
7 practical, the plan should ensure the child remains enrolled in the
8 school the child was attending at the time the child entered foster
9 care.

10 (vi) The supervising agency (~~(charged with supervising a child in~~
11 ~~placement)~~) shall provide all reasonable services that are available
12 within the supervising agency, or within the community, or those
13 services which the department has existing contracts to purchase. It
14 shall report to the court if it is unable to provide such services; and

15 (c) If the court has ordered, pursuant to RCW 13.34.130(5), that a
16 termination petition be filed, a specific plan as to where the child
17 will be placed, what steps will be taken to achieve permanency for the
18 child, services to be offered or provided to the child, and, if
19 visitation would be in the best interests of the child, a
20 recommendation to the court regarding visitation between parent and
21 child pending a fact-finding hearing on the termination petition. The
22 supervising agency shall not be required to develop a plan of services
23 for the parents or provide services to the parents if the court orders
24 a termination petition be filed. However, reasonable efforts to ensure
25 visitation and contact between siblings shall be made unless there is
26 reasonable cause to believe the best interests of the child or siblings
27 would be jeopardized.

28 (3) Permanency planning goals should be achieved at the earliest
29 possible date. If the child has been in out-of-home care for fifteen
30 of the most recent twenty-two months, the court shall require the
31 (~~department~~) supervising agency to file a petition seeking
32 termination of parental rights in accordance with RCW
33 13.34.145(3)(b)(vi). In cases where parental rights have been
34 terminated, the child is legally free for adoption, and adoption has
35 been identified as the primary permanency planning goal, it shall be a
36 goal to complete the adoption within six months following entry of the

1 (4) If the court determines that the continuation of reasonable
2 efforts to prevent or eliminate the need to remove the child from his
3 or her home or to safely return the child home should not be part of
4 the permanency plan of care for the child, reasonable efforts shall be
5 made to place the child in a timely manner and to complete whatever
6 steps are necessary to finalize the permanent placement of the child.

7 (5) The identified outcomes and goals of the permanency plan may
8 change over time based upon the circumstances of the particular case.

9 (6) The court shall consider the child's relationships with the
10 child's siblings in accordance with RCW 13.34.130(3).

11 (7) For purposes related to permanency planning:

12 (a) "Guardianship" means a dependency guardianship or a legal
13 guardianship pursuant to chapter 11.88 RCW or equivalent laws of
14 another state or a federally recognized Indian tribe.

15 (b) "Permanent custody order" means a custody order entered
16 pursuant to chapter 26.10 RCW.

17 (c) "Permanent legal custody" means legal custody pursuant to
18 chapter 26.10 RCW or equivalent laws of another state or a federally
19 recognized Indian tribe.

20 **Sec. 26.** RCW 13.34.138 and 2007 c 413 s 8 and 2007 c 410 s 1 are
21 each reenacted and amended to read as follows:

22 (1) Except for children whose cases are reviewed by a citizen
23 review board under chapter 13.70 RCW, the status of all children found
24 to be dependent shall be reviewed by the court at least every six
25 months from the beginning date of the placement episode or the date
26 dependency is established, whichever is first. The purpose of the
27 hearing shall be to review the progress of the parties and determine
28 whether court supervision should continue.

29 (a) The initial review hearing shall be an in-court review and
30 shall be set six months from the beginning date of the placement
31 episode or no more than ninety days from the entry of the disposition
32 order, whichever comes first. The requirements for the initial review
33 hearing, including the in-court review requirement, shall be

27 placements have been considered;

28 (ix) Whether the parents have visited the child and any reasons why
29 visitation has not occurred or has been infrequent;

30 (x) Whether terms of visitation need to be modified;

31 (xi) Whether the court-approved long-term permanent plan for the
32 child remains the best plan for the child;

33 (xii) Whether any additional court orders need to be made to move
34 the case toward permanency; and

35 (xiii) The projected date by which the child will be returned home
36 or other permanent plan of care will be implemented.

37 (d) The court at the review hearing may order that a petition
38 seeking termination of the parent and child relationship be filed.

1 (3)(a) In any case in which the court orders that a dependent child
2 may be returned to or remain in the child's home, the in-home placement
3 shall be contingent upon the following:

4 (i) The compliance of the parents with court orders related to the
5 care and supervision of the child, including compliance with ~~((an))~~ the
6 supervising agency's case plan; and

7 (ii) The continued participation of the parents, if applicable, in
8 available substance abuse or mental health treatment if substance abuse
9 or mental illness was a contributing factor to the removal of the
10 child.

11 (b) The following may be grounds for removal of the child from the

13 (i) Noncompliance by the parents with the supervising agency's case

25 from the home, the court shall hold a review hearing within thirty days

27 should be changed, a termination petition should be filed, or other
28 action is warranted. The best interests of the child shall be the
29 court's primary consideration in the review hearing.

30 (4) The court's ability to order housing assistance under RCW
31 13.34.130 and this section is: (a) Limited to cases in which
32 homelessness or the lack of adequate and safe housing is the primary
33 reason for an out-of-home placement; and (b) subject to the
34 availability of funds appropriated for this specific purpose.

35 (5) The court shall consider the child's relationship with siblings
36 in accordance with RCW 13.34.130(3).

1 **Sec. 27.** RCW 13.34.145 and 2008 c 152 s 3 are each amended to read
2 as follows:

3 (1) The purpose of a permanency planning hearing is to review the
4 permanency plan for the child, inquire into the welfare of the child
5 and progress of the case, and reach decisions regarding the permanent
6 placement of the child.

7 (a) A permanency planning hearing shall be held in all cases where
8 the child has remained in out-of-home care for at least nine months and
9 an adoption decree, guardianship order, or permanent custody order has
10 not previously been entered. The hearing shall take place no later
11 than twelve months following commencement of the current placement
12 episode.

13 (b) Whenever a child is removed from the home of a dependency
14 guardian or long-term relative or foster care provider, and the child

13 (1) The provisions of this section shall apply when a court orders
14 a party to undergo an alcohol or substance abuse diagnostic

19 appropriate. If its findings and recommendations support treatment, it

31 arise unless the petitioner makes a showing that all necessary services
32 reasonably capable of correcting the parental deficiencies within the
33 foreseeable future have been clearly offered or provided. In
34 determining whether the conditions will be remedied the court may
35 consider, but is not limited to, the following factors:

36 (i) Use of intoxicating or controlled substances so as to render
37 the parent incapable of providing proper care for the child for

1 extended periods of time or for periods of time that present a risk of
2 imminent harm to the child, and documented unwillingness of the parent
3 to receive and complete treatment or documented multiple failed
4 treatment attempts; or

5 (ii) Psychological incapacity or mental deficiency of the parent
6 that is so severe and chronic as to render the parent incapable of
7 providing proper care for the child for extended periods of time or for
8 periods of time that present a risk of imminent harm to the child, and
9 documented unwillingness of the parent to receive and complete
10 treatment or documentation that there is no treatment that can render
11 the parent capable of providing proper care for the child in the near
12 future; and

13 (f) That continuation of the parent and child relationship clearly
14 diminishes the child's prospects for early integration into a stable
15 and permanent home.

16 (2) In lieu of the allegations in subsection (1) of this section,
17 the petition may allege that the child was found under such
18 circumstances that the whereabouts of the child's parent are unknown
19 and no person has acknowledged paternity or maternity and requested
20 custody of the child within two months after the child was found.

21 (3) In lieu of the allegations in subsection (1)(b) through (f) of
22 this section, the petition may allege that the parent has been
23 convicted of:

24 (a) Murder in the first degree, murder in the second degree, or
25 homicide by abuse as defined in chapter 9A.32 RCW against another child
26 of the parent;

27 (b) Manslaughter in the first degree or manslaughter in the second
28 degree, as defined in chapter 9A.32 RCW against another child of the
29 parent;

30 (c) Attempting, conspiring, or soliciting another to commit one or
31 more of the crimes listed in (a) or (b) of this subsection; or

32 (d) Assault in the first or second degree, as defined in chapter
33 9A.36 RCW, against the surviving child or another child of the parent.

34 (4) Notice of rights shall be served upon the parent, guardian, or
35 legal custodian with the petition and shall be in substantially the
36 following form:

37 "NOTICE

38 A petition for termination of parental rights has been filed

1 against you. You have important legal rights and you must take
2 steps to protect your interests. This petition could result in
3 permanent loss of your parental rights.

4 1. You have the right to a fact-finding hearing before
5 a judge.

6 2. You have the right to have a lawyer represent you at
7 the hearing. A lawyer can look at the files in your case, talk
8 to the (~~(department of social and health services)~~) supervising
9 agency and other agencies, tell you about the
10 law, help you understand your rights, and help
11 you at hearings. If you cannot afford a lawyer,
12 the court will appoint one to represent you. To
13 get a court-appointed lawyer you must contact:
14 (explain local procedure).

15 3. At the hearing, you have the right to speak on your
16 own behalf, to introduce evidence, to examine witnesses, and to
17 receive a decision based solely on the evidence presented to
18 the judge.

19 You should be present at this hearing.

20 You may call (insert agency) for more information
21 about your child. The agency's name and telephone number are
22 (insert name and telephone number)."

23 **Sec. 32.** RCW 13.34.210 and 2003 c 227 s 8 are each amended to read
24 as follows:

25 If, upon entering an order terminating the parental rights of a
26 parent, there remains no parent having parental rights, the court shall
27 commit the child to the custody of (~~(the department or to)~~) a
28 (~~(licensed child placing)~~) supervising agency willing to accept custody
29 for the purpose of placing the child for adoption. If an adoptive home
30 has not been identified, the (~~(department or)~~) supervising agency shall
31 place the child in a licensed foster home, or take other suitable
32 measures for the care and welfare of the child. The custodian shall
33 have authority to consent to the adoption of the child consistent with
34 chapter 26.33 RCW, the marriage of the child, the enlistment of the
35 child in the armed forces of the United States, necessary surgical and
36 other medical treatment for the child, and to consent to such other
37 matters as might normally be required of the parent of the child.

1 If a child has not been adopted within six months after the date of
2 the order and a guardianship of the child under RCW 13.34.231 or

13 (1) A child may petition the juvenile court to reinstate the

29 and reunification is now appropriate.

32 regardless of the date parental rights were terminated.

33 (14) The state, the department, the supervising agency, and its
34 employees are not liable for civil damages resulting from any act or
35 omission in the provision of services under this section, unless the
36 act or omission constitutes gross negligence. This section does not
37 create any duty and shall not be construed to create a duty where none

1 exists. This section does not create a cause of action against the
2 state, the department, the supervising agency, or its employees
3 concerning the original termination.

4 **Sec. 34.** RCW 13.34.230 and 1981 c 195 s 1 are each amended to read
5 as follows:

6 Any party to a dependency proceeding, including the supervising
7 agency, may file a petition in juvenile court requesting that
8 guardianship be created as to a dependent child. The department (~~of~~
9 ~~social and health services~~) or supervising agency shall receive notice
10 of any guardianship proceedings and have the right to intervene in the
11 proceedings.

12 **Sec. 35.** RCW 13.34.233 and 2000 c 122 s 30 are each amended to

37 order visitation with a relative under the dependency statutes.

5 based. The documentation may include the progress report, evaluation,
