1 AN ACT Relating to petitions for administrative review of railroad
2 crossing closures; and amending RCW 81.53.060.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 81.53.060 and 1984 c 7 s 374 are each amended to read
5 as follows:

6 The mayor and city council, or other governing body of any city or
7 town, or the legislative authority of any county within which there
8 exists any under-crossing, over-crossing, or grade crossing, or where
9 any street or highway is proposed to be located or established across
10 any railroad, or any railroad company whose road is crossed by any
11 highway, may file with the commission their or its petition in writing,
12 alleging that the public safety requires the establishment of an under-
13 crossing or over-crossing, or an alteration in the method and manner of
14 an existing crossing and its approaches, or in the style and nature of
15 construction of an existing over-crossing, under-crossing, or grade
16 crossing, or a change in the location of an existing highway or
17 crossing, the closing or discontinuance of an existing highway
18 crossing, and the diversion of travel thereon to another highway or
19 crossing, or if not practicable, to change the crossing from grade or

1 to close and discontinue the crossing, the opening of an additional
2 crossing for the partial diversion of travel, and praying that this
3 relief may be ordered. If the existing or proposed crossing is on a
4 state road, highway, or parkway, the petition may be filed by the
5 secretary of transportation or the state parks and recreation
6 commission. If the existing crossing is adjacent to a project funded
7 in part or in full by the state of Washington and managed by the
8 department of transportation, and closure of the crossing is part of
9 the project, the petition may be filed by the secretary of
10 transportation or the secretary's designee, or if the petition is filed
11 by another entity, the secretary of transportation or the secretary's
12 designee shall intervene as a party in any hearing at which the closure
13 of the crossing is contested. If the department of transportation is
14 not a lead agency under chapter 43.21C RCW, a lead agency shall also
15 intervene as a party in any hearing at which the closure of the
16 crossing is contested. Upon the petition being filed, the commission
17 shall fix a time and place for hearing the petition and shall give not
18 less than twenty days' notice to the petitioner, the railroad company,
19 and the municipality or county in which the crossing is situated. If
20 the highway involved is a state highway or parkway, or if the crossing
21 is adjacent to a project funded in part or in full by the state of
22 Washington and managed by the department of transportation and closure
23 of the crossing is part of the project, like notice shall be given to
24 the secretary of transportation or the state parks and recreation
25 commission. If the change petitioned for requires that private lands,
26 property, or property rights be taken, damaged, or injuriously affected
27 to open up a new route for the highway, or requires that any portion of
28 any existing highway be vacated and abandoned, twenty days' notice of
29 the hearing shall be given to the owner or owners of the private lands,
30 property, and property rights which it is necessary to take, damage, or
31 injuriously affect, and to the owner or owners of the private lands,
32 property, or property rights that will be affected by the proposed
33 vacation and abandonment of the existing highway. The commission shall
34 also cause notice of the hearing to be published once in a newspaper of
35 general circulation in the community where the crossing is situated,
36 which publication shall appear at least two days before the date of
37 hearing. At the time and place fixed in the notice, all persons and
38 parties interested are entitled to be heard and introduce evidence. In

1 the case of a petition for closure of a grade crossing the commission
2 may order the grade crossing closed without hearing where: (1) Notice
3 of the filing of the petition is posted at, or as near as practical to,
4 the crossing; (2) notice of the filing of the petition is published
5 once in a newspaper of general circulation in the community or area
6 where the crossing is situated, which publication shall appear within
7 the same week that the notice referred to in subsection (1) of this
8 section is posted; and (3) no objections are received by the commission
9 within twenty days from the date of the publication of the notice.
