1 AN ACT Relating to veterinary technician licenses; amending RCW
2 18.92.128 and 18.92.128; and providing an effective date.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 18.92.128 and 2007 c 235 s 2 are each amended to read
5 as follows:

6 (1) The board shall issue a veterinary technician license to an
7 individual who has:

8 (a) Successfully (~~passed an~~) completed required examinations
9 administered or approved by the board; and

10 (b)(i) Successfully completed a posthigh school course approved by
11 the board in the care and treatment of animals; or

12 (ii) (~~Had~~) Completed, before July 1, 2015, five years' practical
13 experience, acceptable to the board, with a licensed veterinarian.

14 (2) The board shall adopt rules under chapter 34.05 RCW identifying
15 standard tasks and procedures that must be included in the experience
16 of a person who qualifies to take the veterinarian technician
17 examination through the period of practical experience required in
18 subsection (1)(b)(ii) of this section, and requirements for the

1 supervising veterinarian's attestation to completion of the practical
2 experience and that training included the required tasks and
3 procedures.

4 **Sec. 2.** RCW 18.92.128 and 2010 c . . . s 1 (section 1 of this act)
5 are each amended to read as follows:

6 ~~((1))~~ The board shall issue a veterinary technician license to an
