

**SB 6714 - DIGEST**

Closes use tax and real estate excise tax loopholes and provides the department of revenue with enhanced tools to invalidate abusive tax avoidance transactions.

Requires the department of revenue to assess a penalty of thirty-five percent of an additional tax found to be due, when the department finds the deficiency resulted from engaging in an abusive tax avoidance transaction.
