- 11 The Washington state heritage center account is created in the
- 12 custody of the state treasurer. All moneys received under RCW
- 13 $((\frac{36.18.010(11)}{\text{and}}))$ 43.07.128 must be deposited in the account.
- 14 Expenditures from the account may be made only for the following
- 15 purposes:
- 16 (1) Payment of the certificate of participation issued for the
- 17 Washington state heritage center;
- 18 (2) Capital maintenance of the Washington state heritage center;
- 19 and
- 20 (3) Program operations that serve the public, relate to the
- 21 collections and exhibits housed in the Washington state heritage
- 22 center, or fulfill the missions of the state archives, state library,
- 23 and capital museum.
- 24 Only the secretary of state or the secretary of state's designee
- 25 may authorize expenditures from the account. An appropriation is not
- 26 required for expenditures, but the account is subject to allotment

- 2 heritage center account for the purposes of state arts, historical,

- 7 The Washington state legacy project, state library, and archives
- 8 account is created in the custody of the state treasurer. All moneys
- 9 received under RCW 43.07.370 and 36.18.010(11) must be deposited in
- 10 the account. Expenditures from the account may be made only for the
- 11 purposes of the Washington state legacy project under RCW 43.07.363,
- 12 archives program under RCW 40.14.020, and the state library program
- 13 under chapter 27.04 RCW. Only the secretary of state or the secretary
- 14 of state's designee may authorize expenditures from the account. Ar
- 15 appropriation is not required for expenditures, but the account is
- 16 subject to allotment procedures under chapter 43.88 RCW."
