5 (1) ((No later than two years after full implementation of the б provisions of Title II of P.L. 109-13, improved security for driver's 7 licenses and personal identification cards (Real ID), as passed by 8 Congress May 10, 2005,)) The department ((shall)) may implement a ((voluntary biometric)) facial recognition matching 9 system for ((driver's)) drivers' licenses, permits, and 10 identicards. ( ( <del>A</del> biometric)) Any facial recognition matching system ((shall)) selected 11 by the department must be used only to verify the identity of an 12 applicant for or holder of a ((renewal or duplicate)) driver's license, 13 permit, or identicard ((by matching a biometric identifier submitted by 14 the applicant against the biometric identifier submitted when the 15 license was last issued. This project requires a full review by the 16 17 information services board using the criteria for projects of the 18 highest visibility and risk)) to determine whether the person has been issued a driver's license, permit, or identicard under a different name 19 20 or names.

21 (2) Any ((biometric)) facial recognition matching system selected by the department ((shall)) must be capable of highly accurate 22 ((shall)) <u>must</u> be compliant with ((biometric)) 23 matching, and 24 appropriate standards established by the American association of motor vehicle administrators that exist on the effective date of this 25 section, or such subsequent date as may be provided by the department 26 by rule, consistent with the purposes of this section. 27

(3) ((The biometric matching system selected by the department must incorporate a process that allows the owner of a driver's license or identicard to present a personal identification number or other code

along with the driver's license or identicard before the information 1

may be verified by a third party, including a governmental entity. (4) Upon the establishment of a biometric driver's license and 3 identicard system as described in this section, the department shall 4 allow every person applying for an original, renewal, or duplicate 5 б driver's license or identicard to voluntarily submit a biometric 7 identifier. Each applicant shall be informed of all ways in which the biometric identifier may be used, all parties to whom the identifier 8 may be disclosed and the conditions of disclosure, the expected error 9 rates for the biometric matching system which shall be regularly 10 11 updated as the technology changes or empirical data is collected, and the potential consequences of those errors. The department shall adopt 12 13 rules to allow applicants to verify the accuracy of the system at the time that biometric information is submitted, including the use of at 14

15 least two separate devices.

(5) The department may not disclose biometric information to the 16 17 public or any governmental entity except when authorized by court order. 18

19 (6)) The department shall post notices in conspicuous locations at all department driver licensing offices, make written information 20 21 available to all applicants at department driver licensing offices, and provide information on the department's web site regarding the facial 22 recognition matching system. The notices, written information, and 23 information on the web site must address how the facial recognition 24 matching system works, all ways in which the department may use results 25 from the facial recognition matching system, how an investigation based 26 on results from the facial recognition matching system would be 27 conducted, and a person's right to appeal any determinations made under 28 29 this chapter.

5 (5) All ((biometric)) personally identifying information ((shall)) 6 derived from the facial recognition matching system must be stored with 7 appropriate security safeguards((, including but not limited to 8 encryption)). The office of the chief information officer shall 9 develop the appropriate security standards for the department's use of 10 the facial recognition matching system, subject to approval and 11 oversight by the technology services board.

12 ((<del>(7)</del>)) <u>(6)</u> The department shall develop procedures to handle 13 instances in which the ((<del>biometric</del>)) <u>facial recognition</u> matching system 14 fails to verify the identity of an applicant for a renewal or duplicate 15 driver's license, <u>permit</u>, or identicard. These procedures ((<del>shall</del>)) 16 <u>must</u> allow an applicant to prove identity without using ((<del>a biometric</del> 17 <del>identifier</del>.

18 (8) Any person who has voluntarily submitted a biometric identifier 19 may choose to discontinue participation in the biometric matching 20 program at any time, provided that the department utilizes a secure 21 procedure to prevent fraudulent requests for a renewal or duplicate 22 driver's license or identicard. When the person discontinues 23 participation, any previously collected biometric information shall be 24 destroyed.

28 <u>NEW SECTION.</u> Sec. 2. A new section is added to chapter 46.20 RCW 29 to read as follows:

(1) The department shall report to the governor and the legislature 30 by October 1st of each year, beginning October 1, 2012, on the 31 following numbers during the previous fiscal year: The number of 32 investigations initiated by the department based on results from the 33 34 facial recognition matching system; the number of determinations made 35 that a person has committed one of the prohibited practices in RCW 36 46.20.0921 after the completion of an investigation; the number of determinations that were confirmed by a hearings examiner and the 37

number that were overturned by a hearings examiner; the number of cases 1 2 where a person declined a hearing or did not attend a scheduled hearing; and the number of determinations that were referred to law 3 4 enforcement.

5 (2) This section expires June 30, 2017.

б NEW SECTION. Sec. 3. A new section is added to chapter 46.04 RCW 7 to read as follows:

"Facial recognition matching system" means a system that compares 8 9 the biometric template derived from an image of an applicant or holder of a driver's license, permit, or identicard with the biometric 10 11 templates derived from the images in the department's negative file.

(1) **Driver's instruction permit**. The department may issue a 16 driver's instruction permit with or without a photograph to an 17 applicant who has successfully passed all parts of the examination 18 19 other than the driving test, provided the information required by RCW 20 46.20.091, paid  $\left(\left(\frac{a}{b}\right)\right)$  an application fee of twenty-five dollars, and 21 meets the following requirements:

(c) An approved instructor, or a licensed driver with at least fiveyears of driving experience, occupies the seat beside the driver.

16 valid for one year from the date of issue.

(a) The department may issue one additional one-year permit.

(b) The department may issue a third driver's permit if it finds after an investigation that the permittee is diligently seeking to improve driving proficiency.

(c) A person applying ((to renew)) for an additional instruction
 permit must submit the application to the department in person and pay
 an application fee of twenty-five dollars for each issuance.

24 **Sec. 6.** RCW 46.20.117 and 2005 c 314 s 305 are each amended to 25 read as follows:

(1) Issuance. The department shall issue an identicard, containinga picture, if the applicant:

28 29 (a) Does not hold a valid Washington driver's license;

(b) Proves his or her identity as required by RCW 46.20.035; and

(2) A person may renew his or her license on or before the
expiration date by submitting an application as prescribed by the
department and paying a fee of ((twenty-five)) forty-five dollars from
October 1, 2012, to June 30, 2013, and fifty-four dollars after June

(c) If the driver submits to the test and the test is administered, 16 17 the driver's license, permit, or privilege to drive will be suspended, revoked, or denied for at least ninety days if the driver is age 18 twenty-one or over and the test indicates the alcohol concentration of 19 the driver's breath or blood is 0.08 or more, or if the driver is under 20 age twenty-one and the test indicates the alcohol concentration of the 21 22 driver's breath or blood is 0.02 or more, or if the driver is under age 23 twenty-one and the driver is in violation of RCW 46.61.502 or 24 46.61.504; and

(ii) That after receipt of the warnings required by subsection (2) of this section the person refused to submit to a test of his or her blood or breath, or a test was administered and the results indicated that the alcohol concentration of the person's breath or blood was 0.08 or more if the person is age twenty-one or over, or was 0.02 or more if the person is under the age of twenty-one; and

(iii) Any other information that the director may require by rule.

(7) The department of licensing, upon the receipt of a sworn report 18 or report under a declaration authorized by RCW 9A.72.085 under 19 subsection (6)(e) of this section, shall suspend, revoke, or deny the 20 21 person's license, permit, or privilege to drive or any nonresident 22 operating privilege, as provided in RCW 46.20.3101, such suspension, 23 revocation, or denial to be effective beginning sixty days from the 24 date of arrest or from the date notice has been given in the event notice is given by the department following a blood test, or when 25 26 sustained at a hearing pursuant to subsection (8) of this section, 27 whichever occurs first.

(8) A person receiving notification under subsection (6)(b) of this 28 section may, within twenty days after the notice has been given, 29 30 request in writing a formal hearing before the department. The person shall pay a fee of ((two)) three hundred seventy-five dollars as part 31 of the request. If the request is mailed, it must be postmarked within 32 twenty days after receipt of the notification. Upon timely receipt of 33 such a request for a formal hearing, including receipt of the required 34 35 ((two)) three hundred seventy-five dollar fee, the department shall 36 afford the person an opportunity for a hearing. The department may 37 waive the required ((two)) three hundred seventy-five dollar fee if the person is an indigent as defined in RCW 10.101.010. Except as 38

otherwise provided in this section, the hearing is subject to and shall 1 2 be scheduled and conducted in accordance with RCW 46.20.329 and 46.20.332. The hearing shall be conducted in the county of the arrest, 3 4 except that all or part of the hearing may, at the discretion of the department, be conducted by telephone or other electronic means. 5 The 6 hearing shall be held within sixty days following the arrest or 7 following the date notice has been given in the event notice is given 8 by the department following a blood test, unless otherwise agreed to by 9 the department and the person, in which case the action by the department shall be stayed, and any valid temporary license marked 10 under subsection (6)(c) of this section extended, if the person is 11 12 otherwise eligible for licensing. For the purposes of this section, 13 the scope of the hearing shall cover the issues of whether a law enforcement officer had reasonable grounds to believe the person had 14 been driving or was in actual physical control of a motor vehicle 15 within this state while under the influence of intoxicating liquor or 16 17 any drug or had been driving or was in actual physical control of a motor vehicle within this state while having alcohol in his or her 18 system in a concentration of 0.02 or more if the person was under the 19 age of twenty-one, whether the person was placed under arrest, and (a) 20 21 whether the person refused to submit to the test or tests upon request 22 of the officer after having been informed that such refusal would 23 result in the revocation of the person's license, permit, or privilege to drive, or (b) if a test or tests were administered, whether the 24 applicable requirements of this section were satisfied before the 25 26 administration of the test or tests, whether the person submitted to 27 the test or tests, or whether a test was administered without express consent as permitted under this section, and whether the test or tests 28 indicated that the alcohol concentration of the person's breath or 29 30 blood was 0.08 or more if the person was age twenty-one or over at the time of the arrest, or 0.02 or more if the person was under the age of 31 twenty-one at the time of the arrest. The sworn report or report under 32 a declaration authorized by RCW 9A.72.085 submitted by a 33 law enforcement officer is prima facie evidence that the officer had 34 35 reasonable grounds to believe the person had been driving or was in 36 actual physical control of a motor vehicle within this state while 37 under the influence of intoxicating liquor or drugs, or both, or the person had been driving or was in actual physical control of a motor 38

vehicle within this state while having alcohol in his or her system in a concentration of 0.02 or more and was under the age of twenty-one and that the officer complied with the requirements of this section.

4 A hearing officer shall conduct the hearing, may issue subpoenas for the attendance of witnesses and the production of documents, and 5 shall administer oaths to witnesses. The hearing officer shall not б issue a subpoena for the attendance of a witness at the request of the 7 8 person unless the request is accompanied by the fee required by RCW 9 5.56.010 for a witness in district court. The sworn report or report 10 under a declaration authorized by RCW 9A.72.085 of the law enforcement 11 officer and any other evidence accompanying the report shall be 12 admissible without further evidentiary foundation and the certifications authorized by the criminal rules for courts of limited 13 shall admissible 14 jurisdiction be without further evidentiary foundation. The person may be represented by counsel, may question 15 witnesses, may present evidence, and may testify. The department shall 16 17 order that the suspension, revocation, or denial either be rescinded or 18 sustained.

(9) If the suspension, revocation, or denial is sustained after 19 such a hearing, the person whose license, privilege, or permit is 20 21 suspended, revoked, or denied has the right to file a petition in the 22 superior court of the county of arrest to review the final order of 23 revocation by the department in the same manner as an appeal from a 24 decision of a court of limited jurisdiction. Notice of appeal must be filed within thirty days after the date the final order is served or 25 26 the right to appeal is waived. Notwithstanding RCW 46.20.334, RALJ 27 1.1, or other statutes or rules referencing de novo review, the appeal shall be limited to a review of the record of the administrative 28 29 The appellant must pay the costs associated with obtaining hearing. 30 the record of the hearing before the hearing officer. The filing of the appeal does not stay the effective date of the suspension, 31 32 revocation, or denial. A petition filed under this subsection must include the petitioner's grounds for requesting review. Upon granting 33 petitioner's request for review, 34 the court shall review the 35 department's final order of suspension, revocation, or denial as 36 expeditiously as possible. The review must be limited to a 37 determination of whether the department has committed any errors of The superior court shall accept those factual determinations 38 law.

supported by substantial evidence in the record: (a) That were 1 2 expressly made by the department; or (b) that may reasonably be inferred from the final order of the department. (10)(a) If a person whose driver's license, permit, or privilege to 14 15 drive has been or will be suspended, revoked, or denied under subsection (7) of this section, other than as a result of a breath or 16 blood test refusal, and who has not committed an offense for which he 17 or she was granted a deferred prosecution under chapter 10.05 RCW, 18 19 petitions a court for a deferred prosecution on criminal charges 20 arising out of the arrest for which action has been or will be taken 21 under subsection (7) of this section, or notifies the department of 22 licensing of the intent to seek such a deferred prosecution, then the 23 license suspension or revocation shall be stayed pending entry of the 24 deferred prosecution. The stay shall not be longer than one hundred fifty days after the date charges are filed, or two years after the 25 26 date of the arrest, whichever time period is shorter. If the court 27 stays the suspension, revocation, or denial, it may impose conditions on such stay. If the person is otherwise eligible for licensing, the 28 29 department shall issue a temporary license, or extend any valid 30 temporary license marked under subsection (6) of this section, for the period of the stay. If a deferred prosecution treatment plan is not 31 recommended in the report made under RCW 10.05.050, or if treatment is 32 33 rejected by the court, or if the person declines to accept an offered treatment plan, or if the person violates any condition imposed by the 34 35 court, then the court shall immediately direct the department to cancel 36 the stay and any temporary marked license or extension of a temporary 37 license issued under this subsection.

(b) A suspension, revocation, or denial imposed under this section, 1 2 other than as a result of a breath or blood test refusal, shall be stayed if the person is accepted for deferred prosecution as provided 3 4 in chapter 10.05 RCW for the incident upon which the suspension, revocation, or denial is based. If the deferred prosecution is 5 terminated, the stay shall be lifted and the suspension, revocation, or б denial reinstated. If the deferred prosecution is completed, the stay 7 8 shall be lifted and the suspension, revocation, or denial canceled.

9 (c) The provisions of (b) of this subsection relating to a stay of 10 a suspension, revocation, or denial and the cancellation of any 11 suspension, revocation, or denial do not apply to the suspension, 12 revocation, denial, or disqualification of a person's commercial 13 driver's license or privilege to operate a commercial motor vehicle.

(11) When it has been finally determined under the procedures of this section that a nonresident's privilege to operate a motor vehicle in this state has been suspended, revoked, or denied, the department shall give information in writing of the action taken to the motor vehicle administrator of the state of the person's residence and of any state in which he or she has a license.

20 **Sec. 13.** RCW 46.20.505 and 2007 c 97 s 1 are each amended to read 21 as follows:

22 Every person applying for a special endorsement of a driver's 23 license authorizing such person to drive a two or three-wheeled motorcycle or a motor-driven cycle shall pay a fee of five dollars, 24 25 which is not refundable. In addition, the endorsement fee for the 26 initial motorcycle endorsement shall not exceed ((ten)) twelve dollars((, and)), unless the endorsement is issued for a period other 27 than six years, in which case the endorsement fee shall not exceed two 28 dollars for each year the initial motorcycle endorsement is issued. 29 The subsequent renewal endorsement fee shall not exceed ((twenty-five)) 30 thirty dollars, unless the endorsement is renewed or extended for a 31 period other than ((five)) six years, in which case the subsequent 32 renewal endorsement fee shall not exceed five dollars for each year 33 34 that the endorsement is renewed or extended. Fees collected under this 35 section shall be deposited in the motorcycle safety education account 36 of the highway safety fund.
