Background: Mental Health First Aid (MHFA) is a public education program originally developed in Melbourne, Australia, that helps the public identify, understand, and respond to signs of mental illness and substance abuse disorders. MHFA is offered in the form of a 12-hour course that presents an overview of mental illness and substance abuse disorders, introduces participants to risk factors and warning signs of mental health problems, builds an understanding of their impact, and overviews common treatments. MHFA teaches a five-step strategy that can be used to support an individual in crisis and help them connect with appropriate professional, peer, social, and self-help care.

In 2008, the Legislature provided \$80,000 in the operating budget by proviso for a train-the-trainer MHFA course.

This analysis was prepared by non-partisan legislative staff for the use of legislative members in their deliberations. This analysis is not a part of the legislation nor does it constitute a statement of legislative intent.

Senate Bill Report -1 - SB 5333

Summary of Bill (Recommended Substitute): The Department of Social and Health Services (DSHS) must provide funds for MHFA training targeted at teachers and educational staff. DSHS must collaborate with the Office of Superintendent of Public Instruction to identify sites and modes of instruction that leverage local resources to the full extent possible for the purpose of making MHFA training broadly available.

This bill is subject to a null and void clause.

EFFECT OF CHANGES MADE BY HUMAN SERVICES & CORRECTIONS COMMITTEE (Recommended Substitute): A null and void clause was added and the appropriation clause was removed.

Appropriation: None.

Fiscal Note: Requested on January 28, 2013.

Committee/Commission/Task Force Created: No.

Effective Date: Ninety days after adjournment of session in which bill is passed.

Staff Summary of Public Testimony on Original Bill (Human Services & Corrections): PRO: Mental health should not be treated as separate from health care. The MHFA program is a good way to bring mental health to the forefront in a whole health approach. It provides a way to reduce stigma and engage young people and their families. In Washington, 2300 people have taken this course. Mental illnesses often become evident when a person is a teenager. MHFA is an evidence-based program that has been tested and found to be helpful. We wholly support all efforts aimed at early identification and early intervention. There has not been funding since 2008 to support a continuing public education effort in this area. The mental health needs of children in this country are severely under addressed.
