1 AN ACT Relating to changing the crime of riot to the crime of 2 criminal mischief; amending RCW 9A.84.010 and 13.40.0357; prescribing 3 penalties; and providing an effective date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 Sec. 1. RCW 9A.84.010 and 2003 c 53 s 91 are each amended to read 6 as follows:

7 (1) A person is guilty of the crime of ((riot)) criminal mischief
8 if, acting with three or more other persons, he or she knowingly and
9 unlawfully uses or threatens to use force, or in any way participates
10 in the use of such force, against any other person or against property.

11 (2)(a) Except as provided in (b) of this subsection, the crime of 12 ((riot)) criminal mischief is a gross misdemeanor.

13 (b) The crime of ((riot)) <u>criminal mischief</u> is a class C felony if 14 the actor is armed with a deadly weapon.

16 NOTE: References in the grid to days or weeks mean periods of 17 confinement. "LS" means "local sanctions" as defined in RCW 13.40.020. 18 (1) The vertical axis of the grid is the current offense category. 19 The current offense category is determined by the offense of 20 adjudication.

(2) The horizontal axis of the grid is the number of prior adjudications included in the juvenile's criminal history. Each prior felony adjudication shall count as one point. Each prior violation, misdemeanor, and gross misdemeanor adjudication shall count as 1/4 point. Fractional points shall be rounded down.

(3) The standard range disposition for each offense is determined
by the intersection of the column defined by the prior adjudications
and the row defined by the current offense category.

(4) RCW 13.40.180 applies if the offender is being sentenced formore than one offense.

31 (5) A current offense that is a violation is equivalent to an 32 offense category of E. However, a disposition for a violation shall 33 not include confinement.

(1) If the offender is subject to a standard range disposition 1 2 involving confinement by the department, the court may impose the 3 standard range and suspend the disposition on condition that the 4 offender comply with one or more local sanctions and any educational or treatment requirement. The treatment programs provided to the offender 5 6 must be either research-based best practice programs as identified by 7 the Washington state institute for public policy or the joint 8 legislative audit and review committee, or for chemical dependency 9 treatment programs or services, they must be evidence-based or research-based best practice programs. For the purposes of this 10 11 subsection:

12 (a) "Evidence-based" means a program or practice that has had 13 multiple site random controlled trials across heterogeneous populations 14 demonstrating that the program or practice is effective for the 15 population; and

16 (b) "Research-based" means a program or practice that has some 17 research demonstrating effectiveness, but that does not yet meet the 18 standard of evidence-based practices.

(2) If the offender fails to comply with the suspended disposition,
the court may impose sanctions pursuant to RCW 13.40.200 or may revoke
the suspended disposition and order the disposition's execution.

(3) An offender is ineligible for the suspended disposition optionunder this section if the offender is:

(b) Fourteen years of age or older and is adjudicated of one or more of the following offenses:

(i) A class A offense, or an attempt, conspiracy, or solicitation
to commit a class A offense;
