SENATE BILL 6152

State of Washington 63rd Legislature 2014 Regular Session

By Senators Litzow and McAuliffe; by request of Professional Educator Standards Board

Read first time 01/16/14. Referred to Committee on Early Learning & K-12 Education.

1 AN ACT Relating to changing explicit alternative routes to teacher 2 certification program requirements to expectations for program 3 outcomes; amending RCW 28A.660.020 and 28A.660.035; and repealing RCW 4 28A.660.040.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 **Sec. 1.** RCW 28A.660.020 and 2010 c 235 s 503 are each amended to 7 read as follows:

(1) The professional educator standards board shall transition the 8 9 alternative route partnership grant program from a separate competitive 10 grant program to a preparation program model to be expanded among 11 approved preparation program providers. Alternative routes are partnerships between professional educator standards board-approved 12 13 preparation programs, Washington school districts, and other partners Program design of alternative route programs shall 14 as appropriate. continue to evolve over time to reflect innovations and improvements in 15 16 educator preparation.

17 (2) ((Each prospective teacher preparation program provider, in
 18 cooperation with a Washington school district or consortia of school

1 districts applying to operate [an] alternative route certification
2 program shall include in its proposal to the Washington professional

- 3 educator standards board:
- 4 (a) The route or routes the partnership program intends to offer
 5 and a detailed description of how the routes will be structured and
 6 operated by the partnership;
- 7 (b) The estimated number of candidates that will be enrolled per 8 route;
- 9 (c) An identification, indication of commitment, and description of 10 the role of approved teacher preparation programs and partnering 11 district or consortia of districts;
- 12 (d) An assurance that the district or approved preparation program 13 provider will provide adequate training for mentor teachers specific to 14 the mentoring of alternative route candidates;
- 15 (e) An assurance that significant time will be provided for mentor 16 teachers to spend with the alternative route teacher candidates 17 throughout the internship. Partnerships must provide each candidate 18 with intensive classroom mentoring until such time as the candidate 19 demonstrates the competency necessary to manage the classroom with less 20 intensive supervision and guidance from a mentor;
- 21 (f) A description of the rigorous screening process for applicants 22 to alternative route programs, including entry requirements specific to 23 each route, as provided in RCW 28A.660.040;
- 24 (g) A summary of procedures that provide flexible completion
 25 opportunities for candidates to achieve a residency certificate; and

26 (h) The design and use of a teacher development plan for each 27 candidate. The plan shall specify the alternative route coursework and 28 training required of each candidate and shall be developed by comparing 29 the candidate's prior experience and coursework with the state's new 30 performance-based standards for residency certification and adjusting 31 any requirements accordingly. The plan may include the following 32 components:

(i) A minimum of one-half of a school year, and an additional significant amount of time if necessary, of intensive mentorship during field experience, starting with full-time mentoring and progressing to increasingly less intensive monitoring and assistance as the intern demonstrates the skills necessary to take over the classroom with less intensive support. Before the supervision is diminished, the mentor of

1 the teacher candidate at the school and the supervisor of the teacher 2 candidate from the teacher preparation program must both agree that the teacher candidate is ready to manage the classroom with less intensive 3 4 supervision; (ii) Identification of performance indicators based on the 5 б knowledge and skills standards required for residency certification by 7 the Washington professional educator standards board; (iii) Identification of benchmarks that will indicate when the 8 9 standard is met for all performance indicators; (iv) A description of strategies for assessing candidate 10 11 performance on the benchmarks; (v) Identification of one or more tools to be used to assess a 12 13 candidate's performance once the candidate has been in the classroom for about one-half of a school year; 14 15 (vi) A description of the criteria that would result in residency certification after about one-half of a school year but before the end 16 of the program; and 17 18 (vii) A description of how the district intends for the alternative 19 route program to support its workforce development plan and how the 20 presence of alternative route interns will advance its school 21 improvement plans. 22 (3)) As provided in RCW 28A.410.210, it is the duty of the professional educator standards board to establish policies for the 23 24 approval of nontraditional preparation programs and to provide oversight and accountability related to the quality of these programs. 25 26 In establishing and amending rules for alternative route programs, the professional educator standards board shall: 27 (a) Uphold criteria for alternative route program design that is 28 innovative and reflects evidence-based practice; 29 30 (b) Continue to prioritize program designs tailored to the needs of experienced paraeducators and candidates of high academic attainment in 31 the subject area they intend to teach, of which partnering districts 32 have demonstrated need; 33 (c) Expand access and opportunity for individuals to become 34 35 teachers statewide; and 36 (d) Give preference in admissions to applicants for alternative route programs who are eligible veterans or national guard members and 37

38 who meet the entry requirements for the alternative route program.

1 (3) Beginning December 1, 2014, and each even-numbered year 2 thereafter, the professional educator standards board shall report to 3 the education committees of the house of representatives and the senate 4 the following outcomes as indicators that alternative route programs 5 are meeting legislative intent through the regulation and oversight of 6 the professional educator standards board:

7 (a) The percentage of alternative route completers hired versus all 8 preparation program completers;

9 <u>(b) The percentage of alternative route completers from</u> 10 <u>underrepresented populations compared to all preparation program</u> 11 <u>completers;</u>

12 (c) Three-year and five-year retention rates of alternative route 13 completers compared to all preparation program completers;

14 (d) The average hiring dates of alternative route completers
15 compared to all preparation program completers; and

16 (e) The percentage of alternative route completers hired in 17 districts where their alternative route program was completed compared 18 to where student teaching was completed by candidates in all other 19 preparation programs.

20 <u>(4)</u> To the extent funds are appropriated for this purpose, 21 alternative route programs may apply for program funds to pay stipends 22 to trained mentor teachers of interns during the mentored internship. 23 The per intern amount of mentor stipend provided by state funds shall 24 not exceed five hundred dollars.

25 **Sec. 2.** RCW 28A.660.035 and 2009 c 468 s 6 are each amended to 26 read as follows:

The office of the superintendent of public instruction shall 27 identify school districts that have the most significant achievement 28 29 gaps among subgroups of students and for large numbers of those students, and districts that should receive priority for assistance in 30 31 advancing cultural competency skills in their workforce. The 32 professional educator standards board shall provide assistance to the identified school districts to develop partnership grant programs 33 34 between the districts and teacher preparation programs to provide ((one 35 or more of the four)) alternative route programs under RCW 36 ((28A.660.040)) 28A.660.020 and to recruit paraeducators and other 37 individuals in the local community to become certified as teachers.

1 ((A)) <u>An alternative route</u> partnership ((grant)) program proposed by an 2 identified school district shall receive priority eligibility for 3 partnership grants under RCW 28A.660.020. To the maximum extent 4 possible, the board shall coordinate the recruiting Washington teachers 5 program under RCW 28A.415.370 with the alternative route programs under 6 this section.

 and 2010 c 235 s 504 are each repealed.
