Increases the penal sum of a surety bond, from twentyfive thousand dollars to one hundred thousand dollars, required to be maintained by an appraisal management company. Allows the director of the department of licensing, if he or she determines that surety bonds are not readily available to appraisal management companies, to accept a cash bond or other security in lieu of the surety bond.

Gives the department of commerce certain duties relating to the program.

Creates the Yakima integrated plan implementation account, the Yakima integrated plan implementation taxable bond account, and the Yakima integrated plan implementation revenue recovery account.

Authorizes qualifying utilities serving retail customers to use eligible renewable resources located within the western electricity coordinating council area to comply with the energy independence act.

Eliminates the termination and repeal of the veteran lottery raffle and the veterans innovations program under the sunset act.

Adjusts the functions of the state lottery account.

SB 5293 by Senators Cleveland, Rivers, King, Hobbs, Harper, Billig, Ericksen, Ranker, Eide, Fain, Keiser, and Tom

Extending the expiration dates of the local infrastructure financing tool program.

Delays the expiration of the local infrastructure financing tool program.

Revises the energy independence act by recognizing hydroelectricity as an eligible renewable resource.

SB 5295 by Senators Ericksen and Schoesler

Addressing appeal and permit procedures under the shoreline management act.

Revises the shoreline management act to reduce the burden on permit applicants when the part of a project within shoreline jurisdiction is appealed to the shorelines hearings board.

SB 5296 by Senators Ericksen, Baumgartner, Rivers, Bailey, Delvin, and Honeyford

Concerning the model toxics control act.

Prioritizes the spending of revenues under the model toxics control act, on cleaning up the most toxic sites, while also providing jobs in communities around the state.

Requires the state treasurer, for the biennium ending June 30, 2015, to transfer twenty-five million dollars from the state toxics control account and seventy-five million dollars from the local toxics control account to the special category E account.

Creates the special category E account.

SB 5298 by Senators Braun and Ericksen

Regarding coal transition power.

Modifies the energy independence act by revising the definition of "load" and adding a definition for "coal transition power."

SB 5299 by Senators Ranker and Rolfes

Concerning the creation of a special license plate dedicated to raising revenue to fund preventative wolf management efforts at the department of fish and wildlife.

Creates Washington's wolves special license plates.

Jan 25 First reading, referred to Transportation.

SB 5300 by Senators Ranker, Rolfes, Hargrove, and Frockt

Enhancing wolf management efforts through the promotion of cooperative agreements.

Requires the department of fish and wildlife to develop and maintain a process to offer, negotiate, and enter into cooperative agreements with livestock owners to prevent or minimize damage to livestock caused by wolves.

Prohibits owners of commercial livestock from receiving compensation for damage to commercial livestock caused by wolves unless they have a cooperative agreement with the department of fish and wildlife in effect at the time the damage occurred.

Authorizes the fish and wildlife commission, the director of the department of fish and wildlife, and the department of natural resources to, under certain circumstances, enter into a lease, renew a lease, or otherwise permit the use of department-managed real property within the estimated range of a confirmed wolf pack for grazing or other commercial livestock purposes.

SB 5301 by Senators Rolfes, Litzow, McAuliffe, Dammeier, Mullet, Rivers, Billig, and Keiser

Regarding student suspension and expulsion.

Implements accessibility, disaggregation, and review requirements for student suspension and expulsion data collected by the K-12 data governance group.

Requires the K-12 data governance group to examine the data collected under the behavior infraction subgroup and create at least four additional behavior infraction codes including defiance, disruption, cell phone violations, and gang activity.

Requires the superintendent of public instruction and the state school directors' association to meet with a group of stakeholders to develop a handbook and model policy for school districts to implement changes to suspension and expulsion policies.
