(3) Identify a private entity that operates PACE program sites in the state to provide the required training at no cost to the state.

Authorizes the department of fish and wildlife to: (1) Pay up to fifty thousand dollars per fiscal year from the state wildlife account for claims and assessment costs for injury or loss of livestock due to wolf predation; and

(2) Accept and expend money from other sources to address losses or damage to livestock or other property.

Requires the value of livestock killed or injured by a gray wolf to be set at the market value of the lost livestock.

Creates Washington's wolves special license plates.

Creates the wolf interaction conflict account.

Requires the department of fish and wildlife to transfer to the account the balance of unexpended state funds authorized to be used for livestock claims and assessment costs and appropriated for mitigation, claims, and assessment costs for injury to or loss of livestock.

Revises the definition of "neglect" by including an act or omission by a person or entity with a duty of care that demonstrates a serious disregard of consequences of such a magnitude as to constitute a clear and present danger to a vulnerable adult's health, welfare, or safety.

Requires the department of social and health services or law enforcement, in conducting an investigation of abandonment, abuse, financial exploitation, self-neglect, or

neglect, to, upon request, have access to all relevant records related to a vulnerable adult that are in the possession of mandated reporters and their employees.

Authorizes the department of social and health services, the certified professional guardian board, and the office of public guardianship to share information contained in reports and investigations of the abuse, abandonment, neglect, self-neglect, and financial exploitation of vulnerable adults.

(2) Allowing an adult adoptee to obtain uncertified copies of his or her original birth certificate under certain circumstances; and

(3) The expiration of affidavits of nondisclosure.

Requires the office of the superintendent of public instruction to contract with a northwest educational research organization to conduct an evaluation of the pilot project to identify successful practices in improving enrollment of underrepresented students in the running start program.

Expires August 1, 2021.

Concerning residential habilitation center residents' transition to the community.

Authorizes the department of social and health services to ensure, within sixty days of admission to a residential habilitation center, that each resident's individual habilitation plan includes a plan for discharge to the community.

Prohibits the secretary of the department of social and health services from redetermining the eligibility of a current eligible adult person, except where a comprehensive assessment of the person shows a significant increase in the functional abilities of the person such that he or she will no longer benefit from certain developmental disabilities services.

Prohibits a tenant screening service provider from disclosing: (1) A tenant's, applicant's, or household member's status as a victim of domestic violence, sexual assault, or stalking; or

(2) That a tenant or applicant has previously terminated a rental agreement.
