Provides for an August 1, 2023, expiration of the working group.

Removes the contingent expiration of the authority to impose high occupancy vehicle tolls for the state route 167 high occupancy toll pilot project.

Requires the liquor control board to issue an endorsement as a cigar lounge and as a retail tobacconist shop to a business that meets certain requirements.

Requires funds from the special license endorsement application fees to be deposited into the liquor revolving fund and the tobacco prevention and control account.

Allows the use or smoking of tobacco products in certain public places and places of employment.

Requires the department of social and health services to establish the spoken language interpreter advisory group to advise the departments of social and health services, labor and industries, and enterprise services and the state health care authority on the certification and authorization of spoken language interpreters.

Requires the director of the department of enterprise services to develop and implement a model for providing interpreter services.

Requires a scrap metal license to engage in the business of scrap metal processor or scrap metal recycler.

Requires a scrap metal licensee to obtain a special set of license plates for vehicles used by the business.

Creates the scrap metal license account.

(3) Affirm the support of the commission form of governance; and

(4) Provide for additional improvements in the funding and operation of state parks and recreation.

Requires producers of mercury-containing lights sold in this state to pay a registration fee and an administration fee to the department of ecology for reimbursement of documented costs for recycling and transportation of unwanted product from covered entities and for administration and enforcement costs.

Creates the mercury-containing light recycling account.
