House Bills

HB 1707-S by House Committee on Technology & Economic Development (originally sponsored by Representatives Springer, Warnick, Parker, Liias, Manweller, and Lytton)

Concerning the taxation of large airplanes.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Exempts large private airplanes from: (1) Registration requirements with the department of transportation if in the state for certain purposes; and

(2) Sales and use taxes if also exempt from the registration requirements.

Narrows the exemption from the aircraft excise tax for certain aircraft.

Requires the joint legislative audit and review committee to review the performance of the tax preferences to determine whether the tax preferences are achieving their intended purpose of promoting economic development.

Requires the department of revenue, the employment security department, and certain sellers making tax exempt sales to cooperate with the joint legislative audit and review committee by providing any data requested.

HB 1954-S by House Committee on Transportation (originally sponsored by Representatives Clibborn, Moscoso, Fey, Ryu, Riccelli, Farrell, Liias, Pollet, Ormsby, Tarleton, Roberts, Wylie, Morris, Bergquist, and Moeller)

Concerning transportation revenue.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Imposes, increases, and/or changes certain fuel tax rates and motor vehicle related fees to increase revenue for the state's transportation system. Establishes an electric vehicle infrastructure bank to provide financial assistance for the installation of publicly accessible electric vehicle charging stations.

Creates the connecting Washington account and the pedestrian, bicycle, and safe routes to school account.

Concerning additive transportation funding.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Adopts additive transportation funding. Makes appropriations.

HB 2029-S by House Committee on Appropriations (originally sponsored by Representatives Morris and Hudgins)

Eliminating economic development-related agencies, boards, and commissions.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Eliminates the Washington state economic development commission, the Washington tourism commission, and the microenterprise development program.

Abolishes innovate Washington and transfers its missions, powers, duties, and functions to the department of commerce.

Creates the innovate Washington program in the department of commerce.

Changes requirements with regard to administration of the Washington global health technologies and product development competitiveness program.

HB 2038-S by House Committee on Finance (originally sponsored by Representatives Carlyle, Hunter, Ormsby, Tharinger, Reykdal, and Pollet)

Investing in the education legacy trust account for K-12 basic education and higher education by narrowing or eliminating tax preferences and extending taxes set to expire.

(AS OF HOUSE 2ND READING 4/24/13)

Invests in the education legacy trust account for K-12 basic education and higher education by: (1) Eliminating the preferential business and occupation tax rate for travel agents;

- (2) Eliminating the sales and use tax exemption for bottled water;
- (3) Converting the nonresident sales tax exemption into a refund process for state and local sales taxes;
- (4) Modifying tax preferences for high-tech research and development;
- (5) Eliminating the public utility tax deduction on interstate hauls;
- (6) Narrowing business and occupation tax exemptions and sales and use tax exemptions for import commerce;
- (7) Repealing the preferential business and occupation tax rate for sellers of prescription drugs; and
- (8) Narrowing the use tax exemption for extracted fuel to biomass fuel.

Extends, permanently, the business and occupation surfax

Requires the department of revenue to: (1) Estimate the increase in state general fund revenues from the changes made in certain parts of the act; and

(2) Notify the state treasurer of the increase.

Requires the state treasurer to transfer the aforementioned amount from the general fund to the education legacy trust account.

Excludes the general state revenues transferred to the education legacy trust account from the calculation of general state revenues.

HB 2050-S by House Committee on Appropriations (originally sponsored by Representatives Hunter, Ormsby, and Roberts)

Achieving correctional savings related to certification of jail time served.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the administrator of a county jail facility, if an offender is transferred from a county jail to the department of corrections, to certify to the department the amount of time spent in custody at the facility and the number of days of early release credits lost or not earned.

Requires the department of corrections to: (1) Adjust an offender's rate of early release listed on a jail certification to be consistent with the rate applicable to offenders in the department's facilities; and

(2) Recalculate the earned release date for an offender currently serving a term in a facility or institution either operated by the state or utilized under contract.

Implementing basic education expenditures.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Declares an intent to enact a plan of incremental implementation of basic education expenditures.

HB 2057 by Representatives Hayes, Hurst, Klippert, Holy, Van De Wege, and Hope

Modifying arrest without warrant provisions.

Allows a police officer to arrest a person without a warrant for committing a misdemeanor or gross misdemeanor when the offense is committed in the presence of any officer.

HB 2058 by Representatives Hawkins, Riccelli, and Bergquist

Requiring transparency in enacted state capital and transportation budget appropriations and expenditures.

(DIGEST AS PASSED LEGISLATURE)

Requires the office of the legislative evaluation and accountability program committee to update the state expenditure information web site so the public can search for capital budget and transportation projects by selecting from an online geographical map.

Requires current and future capital project and transportation project investments to be coded with geographic information sufficient so the public can search and identify appropriation and expenditure data at the parent and subproject level to the extent available by state legislative district, county, and agency project identifier.

HB 2059 by Representative Morris

Concerning the voluntary purchase of eligible renewable resources by customers of electric utilities.

Requires the utilities and transportation commission, upon request of an electric customer of an investor-owned utility, to create a tariff schedule that allows the customer to purchase voluntarily eligible renewable resources in five hundred kilowatt units.

Requires the governing board of a consumer-owned utility, upon request of an electric customer of a consumer-owned utility, to create a tariff schedule or contract that allows the customer to purchase voluntarily eligible renewable resources in five hundred kilowatt units.

Modifying snowmobile license fees.

Increases initial and renewal vehicle license fees for snowmobiles.

(AS OF SENATE 2ND READING 4/22/13)

Delays implementation of the family and medical leave insurance act.

Creates a joint legislative task force on family and medical leave insurance funding to make legislative recommendations for financing the benefits and administrative costs of the family and medical leave insurance act.

Repeals the family and medical leave insurance act if it is not funded by December 31, 2015.

Requires the state health care authority to submit a waiver request to the federal centers for medicare and medicaid to implement a targeted premium assistance program for certain adults, and children covered in the children's health insurance program, with a goal of providing seamless coverage through the health benefit exchange and improving opportunities for families to be covered in the same health plan.

SB 5924 by Senator Benton

Concerning voter-approved local transportation funding options.

Authorizes certain counties to impose a local motor vehicle excise tax of up to one and one-half percent annually on the value of every motor vehicle registered to a person residing within the county with the approval of a majority of the voters of the county voting on the proposition.

(2) Make it a top level priority to conduct a worldwide search to attract public and private investment in aerospacerelated workforce, plant, and technology in the state.
