House Bills

HB 2748-S by House Committee on Appropriations Subcommittee on General Government & Information Technology (originally sponsored by Representative Hudgins)

Concerning fees assessed by the department of agriculture. (AS OF HOUSE 2ND READING 3/03/14)

Increases fees in the food safety and animal health programs within the department of agriculture.

Requires the department of agriculture to convene and facilitate a sub-work group to review fee categories under the food safety program in order to determine which entities may require additional resources for compliance under the federal food safety modernization act.

HB 2762-S by House Committee on Transportation (originally sponsored by Representatives Clibborn, Fey, and Gregerson; by request of Governor Inslee)

Making 2013-2015 supplemental transportation appropriations.

Makes 2013-2015 supplemental transportation appropriations.

HB 2792-S by House Committee on Appropriations (originally sponsored by Representatives Sullivan, Hunter, Freeman, Morrell, Walkinshaw, Ryu, Tarleton, Appleton, Jinkins, Lytton, Tharinger, Fey, Bergquist, Pollet, Reykdal, Van De Wege, Roberts, S. Hunt, and Carlyle)

Implementing the state's education funding obligation by increasing allocations to school districts, which include materials, supplies, and operating costs, all-day kindergarten, and class size reduction in kindergarten through third grade.
(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Increases allocations to school districts to implement the state's education funding obligation.

Creates a joint task force on local education financing reform.

Mar 1 APP - Majority; 1st substitute bill be substituted, do pass. Minority; do not pass.

Public hearing and executive action taken in the House Committee on Appropriations at 9:00 AM.

Mar 3 Passed to Rules Committee for second reading.

Senate Bills

SB 6581 by Senators Bailey and Kohl-Welles

Concerning nonresident vessel permits and taxation.

Requires application for a nonresident vessel permit by an applicant who is not a natural person to be made by mail.

Prohibits the department of licensing from issuing more than twenty nonresident vessel permits annually per calendar year to applicants who are not natural persons.
