

SB 5312-S.E - DIGEST

(AS OF SENATE 2ND READING 2/20/13)

Establishes the small consumer installment loan act.
Authorizes licensed longer term loans with a maximum authorized interest rate of thirty-six percent per year.
Provides that if any portion of the act is vetoed by the governor, the entire act is null and void.
