SB 5806 By Senators Smith, Rolfes, Pearson and Hargrove Repealing an obsolete provision for a credit against property taxes paid on timber on public land. Referred to Committee on WAYS & MEANS. **SB** 5807 By Senator Litzow Encouraging qualifying utilities to invest in and own distributed solar energy systems by reducing the cost of such systems by allowing qualifying utilities to use the investment cost recovery incentive program, by improving the economic value of solar energy systems relative to utility scale wind generation under the energy independence act, and by giving electrical companies regulatory certainty with respect to their investment in cost-effective distributed solar energy systems. SB 5810 By Senators Darneille and Carrell; by request of Department of Corrections Allowing the department of corrections to exempt information contained in the internal database on security threat group data from dissemination under the public records act.
