Requires health benefit plans (including plans offered to public employees) to adjust cost-sharing for a drug subject to coinsurance or with a copayment that is dispensed for less than the standard refill amount for the purpose of synchronizing the medications. Permits health benefit plans to meet the adjusted copayment requirement by: (1) discounting the copayment rate by 50 percent; (2) discounting the copayment rate based on 15-day increments; or (3) any other method that meets the intent of the law and that is
