- 13 (1) The governor after proclaiming a state of emergency and
- 14 prior to terminating such, may, in the area described by the
- 15 proclamation issue an order prohibiting:
- 16 (a) Any person being on the public streets, or in the public
- 17 parks, or at any other public place during the hours declared by the
- 18 governor to be a period of curfew;
- 19 (b) Any number of persons, as designated by the governor, from
- 20 assembling or gathering on the public streets, parks, or other open
- 21 areas of this state, either public or private;
- (c) The manufacture, transfer, use, possession or transportation
- 23 of a molotov cocktail or any other device, instrument or object
- 24 designed to explode or produce uncontained combustion;
- 25 (d) The transporting, possessing or using of gasoline, kerosene,
- 26 or combustible, flammable, or explosive liquids or materials in a
- 27 glass or uncapped container of any kind except in connection with

- 1 the normal operation of motor vehicles, normal home use or
- 2 legitimate commercial use;
- 3 (e) ((The possession of firearms or any other deadly weapon by a
- 4 person (other than a law enforcement officer) in a place other than

EFFECT: Amends the Continuity of Government Act to prohibit the Legislature, the Governor, and any governmental entity or political subdivision of the state from imposing additional restrictions related to firearms, ammunition, or dangerous weapons during periods of emergency resulting from catastrophic incidents. Provides that neither the Governor, nor any governmental entity or political subdivision, may impose additional restrictions related to firearms, ammunition, and dangerous weapons during a proclaimed emergency.
