EFFECT: Removes the requirement for a Discover Pass, Vehicle Access Pass, or Day Use Pass to access state recreational lands during the 2017-19 biennium. Provides state general fund support to the State Parks and Recreation Commission, Department of Fish and Wildlife, and Department of Natural Resources (DNR) that is equivalent to the projected Discover Pass revenue during FY 2019. Makes corresponding reductions to the dedicated accounts that receive Discover Pass revenue (except for the Park Land Trust Revolving Account administered by DNR, which is non-appropriated).

FISCAL IMPACT:

Increases General Fund - State by \$24,963,000. Decreases Other Funds by \$22,966,000
