11 fiscal year 2018 and $5000 of the general fund--state appropriation
12 for fiscal year 2019 are provided solely for the department to

15 develop a child safety policy in accordance with the guidelines

EFFECT: (1) Requires the Department of Health (DOH), with a
nongovernmental entity, to develop minimum standards for a child

safety policy for organizations that provide recreational programming for youth. The policy shall be posted on the DOH's website by December 1, 2017.

- (2) Requires the DOH, by December 1, 2017, to select two contiguous counties for a pilot program to provide training regarding the child safety policy and to ensure that the local governments within the two counties that provide recreational programming for youth have established and implemented the policy.
- (3) Requires the DOH to report to the Legislature regarding the policy, recommendations for statewide implementation, and recommendations for modifications for application of the policy to child care providers.

Increases General Fund - State by \$48,000.
