EFFECT: Makes the following changes related to the I-405 tolling corridor:

(1) Provides \$80,000 in additional funding for the I-405 tolling traffic study to be overseen by the Joint Transportation Committee to include an assessment of traffic performance measures in the corridor, recommended strategies for improving traffic performance in the corridor, and a report to the Transportation Committees of the Legislature;

(2) Modifies the entity with which the Joint Transportation Committee (JTC) is directed to contract from the Center for Transportation Studies at the University of Minnesota to the Humphrey School of Public Affairs at the University of Minnesota; and

(3) Holds \$9,030,000 of the Interstate 405 Express Toll Lanes Operations Account--State appropriation in unallotted status and specifies that the Office of Financial Management may only release the funds upon passage of a 2018 Supplemental Transportation Budget.

Reduces Motor Vehicle Acct - State by \$80,000.
