1 On page 3, line 19 of the amendment, after "performance
2 standards" insert ", or other parts of this section,"

3 On page 3, line 21 of the amendment, after "electronic products"
4 insert "that resulted in significant harm to the environment or human
5 health"

6 On page 6, after line 31 of the amendment, insert the following:

7 "**Sec. 6.** RCW 70.95N.140 and 2013 c 305 s 6 and 2013 c 292 s 1
8 are each reenacted and amended to read as follows:

9 (1) By March 1st of the second program year and each program year
10 thereafter, the authority and each authorized party shall file with
11 the department an annual report for the preceding program year.

12 (2) The annual report must include the following information:

13 (a) The total weight in pounds of each type of covered electronic
14 products collected and recycled, by county, during the preceding
15 program year including documentation verifying collection and
16 processing of that material. The total weight in pounds includes
17 orphan products. The report must also indicate and document the
18 weight in pounds received from each nonprofit charitable organization
19 primarily engaged in the business of reuse and resale used by the
20 plan. The report must document the weight in pounds that were
21 received in large quantities from small businesses, small
22 governments, charities and school districts as described in RCW
23 70.95N.090(5);

24 (b) The collection services provided in each county and for each
25 city with a population over ten thousand including a list of all
26 collection sites and services operating in the state in the prior
27 program year and the parties who operated them;

28 (c)(i) A list of processors used, the weight of covered
29 electronic products processed by each direct processor, and a
30 description of the processes and methods used to recycle the covered
31 electronic products including a description of the processing and

1 facility locations. The report must also include a list of
2 subcontractors who further processed or recycled unwanted covered
3 electronic products or electronic components, including facility
4 locations.

5 (ii) An estimate of the weight of each type of material recovered
6 as a result of the processing of recycled covered electronic
7 products. Recovered materials catalogued under this subsection must
8 include, at a minimum: Cathode ray tube glass, circuit boards,
9 batteries, mercury-containing devices, plastics, and metals.

10 (iii) An estimate of the percentage, by weight, of all collected
11 products that ultimately are reused, recycled, or end up as residual
12 waste that is disposed of in another manner;

13 (d) Educational and promotional efforts that were undertaken;

14 (e) For program years 2009 through 2014, the results of sampling
15 and sorting as required in RCW 70.95N.110, including a list of the
16 brand names of covered electronic products by product type, the
17 number of covered electronic products by product type, the weight of
18 covered electronic products that are identified for each brand name
19 or that lack a manufacturer's brand, and the total weight of the
20 sample by product type;

21 (f) The list of manufacturers that are participating in the
22 standard plan;

23 (g) A description of program revenues and costs, including: (i)
24 The total cost of the program; and (ii) the average cost of the
25 program per pound of covered electronic product collected;

26 (h) A detailed accounting of the following costs of the program:

27 (i) Program delivery, including: (A) Education and promotional
28 efforts; (B) collection; (C) transportation; and (D) processing and
29 labor; and (ii) program administration;

30 (i) A description of the methods used by the program to collect,
31 transport, recycle, and process covered electronic products; (~~and~~)

32 (j) The contracted rates for services and allocated volumes for
33 each transporter and processor, and a description of the methodology
34 and rationale by which transporter and processor volumes were
35 allocated; and

36 (k) Any other information deemed necessary by the department.

37 (3) The department shall review each report within ninety days of
38 its submission and shall notify the authority or authorized party of
39 any need for additional information or documentation, or any
40 deficiency in its program.

1 (4) The department shall annually review the information
2 submitted in subsection (2)(j) of this section with a view to
3 ensuring that the plan is using competitive processes that promote
4 cost-effective and environmentally sound transport and processing of
5 covered electronic products.

6 (5) All reports submitted to the department must be available to
7 the general public through the internet. Proprietary information
8 submitted to the department under this chapter is exempt from public
9 disclosure under RCW 42.56.270."
