3 "NEW SECTION. Sec. 919. A new section is added to 2017 3rd
4 sp.s. c 1 (uncodified) to read as follows:

5 (1) A joint legislative task force is created to develop
6 strategies for identification and intervention against potential
7 perpetrators of mass shootings and to report on recommendations for
8 their prevention.

9 (2) The task force is composed of members as provided in this
10 subsection.

11 (a) The president of the senate shall appoint one member from
12 each of the two largest caucuses of the senate.

13 (b) The speaker of the house of representatives shall appoint
14 one member from each of the two largest caucuses of the house of
15 representatives.

16 (c) The president of the senate and the speaker of the house of
17 representatives jointly shall appoint members representing:

18 (i) The Washington association of sheriffs and police chiefs;

19 (ii) The Washington state patrol;

20 (iii) The superintendent of public instruction;

21 (iv) The Washington association of prosecuting attorneys;

22 (v) The Washington association of criminal defense attorneys or
23 the Washington defender association;

24 (vi) The Washington state association of counties;

25 (vii) The office of the attorney general;

26 (viii) The American civil liberties union of Washington;

27 (ix) Two colleges or universities in Washington state;

1 (x) The superior court judges' association; and
2 (xii) The administrative office for the courts.
3 (d) No less than two family members of victims of mass shootings
4 must be invited to sit on the task force.
5 (3) The task force shall assess and make recommendations
6 regarding:
7 (a) Strategies to identify persons who may commit mass shootings
8 associated with K-12 schools and colleges and universities;
9 (b) A survey of services around the state available for those
10 experiencing a mental health crisis;
11 (c) A survey of state and federal laws related to intervening
12 against potential perpetrators or confiscating their firearms; and
13 (d) Strategies used by other states or recommended nationally to
14 address the problem of mass shootings.
15 (4) The legislative membership shall convene the initial meeting
16 of the task force no later than June 2018.
17 (5) The task force shall submit a report, which may include
18 findings, recommendations, and proposed legislation, to the
19 appropriate committees of the legislature by December 1, 2018. The
20 report shall consider the following strategies:
21 (a) Promoting to the public the availability of extreme risk
22 protection orders as a means of avoiding mass shootings;
23 (b) A rapid response interdisciplinary team comprised of law
24 enforcement, mental health experts, and other appropriate parties
25 who could be mobilized to intervene and prevent a potential crisis
26 at a school or institution of higher learning; and
27 (c) Whether reasonable restrictions should be imposed on the
28 access to firearms by those suffering from a mental illness that are
29 consistent with the individual right to bear arms.
30 (6) Staff support for the task force must be provided by the
31 senate committee services and the house of representatives office of
32 program research.
33 (7) Legislative members of the task force are reimbursed for
34 travel expenses in accordance with RCW 44.04.120. Nonlegislative

1 members are not entitled to be reimbursed for travel expenses if
2 they are elected officials or are participating on behalf of an
3 employer, governmental entity, or other organization. Any
4 reimbursement for other nonlegislative members is subject to chapter
5 43.03 RCW.

6 (8) The expenses of the task force shall be paid jointly by the
7 senate and the house of representatives. Task force expenditures are
8 subject to approval by the senate facilities and operations
9 committee and the house of representatives executive rules
10 committee, or their successor committees.

11 (9) This section expires July 1, 2019."
