Strike everything after the enacting clause and insert the following:

3 "Sec. 1. RCW 28B.95.020 and 2016 c 69 s 2 are each amended to 4 read as follows:

5 The definitions in this section apply throughout this chapter, 6 unless the context clearly requires otherwise.

7 (1) "Academic year" means the regular nine-month, three-quarter,
8 or two-semester period annually occurring between August 1st and July
9 31st.

"Account" means the Washington advanced college tuition 10 (2) payment program account established for the deposit of all money 11 received by the office from eligible purchasers and interest earnings 12 13 on investments of funds in the account, as well as for all 14 expenditures on behalf of eligible beneficiaries for the redemption of tuition units and for the development of any authorized college 15 savings program pursuant to RCW 28B.95.150. 16

17 (3) "Advisor sold" means a channel through which a broker dealer, 18 investment advisor, or other financial intermediary recommends the 19 Washington college savings program established pursuant to RCW 20 28B.95.010 to eligible investors and assists with the opening and 21 servicing of individual college savings program accounts.

(4) "College savings program account" means the Washington college savings program account established pursuant to RCW ((28B.95.010)) 28B.95.085.

(5) "Committee on advanced tuition payment and college savings" or "committee" means a committee of the following members: The state treasurer, the director of the office of financial management, the director of the office, or their designees, and two members to be appointed by the governor, one representing program participants and one private business representative with marketing, public relations, or financial expertise.

1 (6) "Contractual obligation" means a legally binding contract of 2 the state with the purchaser and the beneficiary establishing that 3 purchases of tuition units in the advanced college tuition payment 4 program will be worth the same number of tuition units at the time of 5 redemption as they were worth at the time of the purchase, except as 6 provided in RCW 28B.95.030 (7) and (8).

7 (7) "Dual credit fees" means any fees charged to a student for 8 participation in college in the high school under RCW 28A.600.290 or 9 running start under RCW 28A.600.310.

10 (8) "Eligible beneficiary" means the person designated as the 11 individual whose education expenses are to be paid from the advanced 12 college tuition payment program or the college savings program. 13 Qualified organizations, as allowed under section 529 of the federal 14 internal revenue code, purchasing tuition unit contracts as future 15 scholarships need not designate a beneficiary at the time of 16 purchase.

17 (9) "Eligible contributor" means an individual or organization 18 that contributes money for the purchase of tuition units, and for an 19 individual college savings program account established pursuant to 20 this chapter for an eligible beneficiary.

(10) "Eligible purchaser" means an individual or organization 21 that has entered into a tuition unit contract with the governing body 22 for the purchase of tuition units in the advanced college tuition 23 payment program for an eligible beneficiary, or that has entered into 24 25 a participant college savings program account contract for an 26 eligible beneficiary. The state of Washington may be an eligible purchaser for purposes of purchasing tuition units to be held for 27 granting Washington college bound scholarships. 28

(11) "Full-time tuition charges" means resident tuition charges
 at a state institution of higher education for enrollments between
 ten credits and eighteen credit hours per academic term.

32 (12) "Governing body" means the committee empowered by the 33 legislature to administer the Washington advanced college tuition 34 payment program and the Washington college savings program.

35 (13) "Individual college savings program account" means the 36 formal record of transactions relating to a Washington college 37 savings program beneficiary.

38 (14) "Institution of higher education" means an institution that 39 offers education beyond the secondary level and is recognized by the

1 internal revenue service under chapter 529 of the internal revenue 2 code.

3 (15) "Investment board" means the state investment board as4 defined in chapter 43.33A RCW.

5 (16) "Investment manager" means the state investment board, 6 another state, or any other entity as selected by the governing body, 7 including another college savings plan established pursuant to 8 section 529 of the internal revenue code.

9 (17) "Office" means the office of student financial assistance as 10 defined in chapter 28B.76 RCW.

11 (18) "Owner" means the eligible purchaser or the purchaser's 12 successor in interest who shall have the exclusive authority to make 13 decisions with respect to the tuition unit contract or the individual 14 college savings program contract. The owner has exclusive authority 15 and responsibility to establish and change the asset investment 16 options for a beneficiaries' individual college savings program 17 account.

18 (19) "Participant college savings program account contract" means 19 a contract to participate in the Washington college savings program 20 between an eligible purchaser and the office.

21 (20) "State institution of higher education" means institutions 22 of higher education as defined in RCW 28B.10.016.

(21) "Tuition and fees" means undergraduate tuition and services and activities fees as defined in RCW 28B.15.020 and 28B.15.041 rounded to the nearest whole dollar. For purposes of this chapter, services and activities fees do not include fees charged for the payment of bonds heretofore or hereafter issued for, or other indebtedness incurred to pay, all or part of the cost of acquiring, constructing, or installing any lands, buildings, or facilities.

30 (22) "Tuition unit contract" means a contract between an eligible 31 purchaser and the governing body, or a successor agency appointed for 32 administration of this chapter, for the purchase of tuition units in 33 the advanced college tuition payment program for a specified 34 beneficiary that may be redeemed at a later date for an equal number 35 of tuition units, except as provided in RCW 28B.95.030 (7) <u>and (8)</u>.

36 (23) <u>"Unit cash value price" means the total value of assets</u>
37 <u>under management in the advanced college tuition payment program on a</u>
38 <u>date to be determined by the committee, divided by the total number</u>
39 of outstanding credits purchased by eligible purchasers before July

<u>1</u>, 2015, and any outstanding credits accrued by eligible purchasers
 as a result of the July 2017 unit rebase.

(24) "Unit purchase price" means the minimum cost to purchase one 3 tuition unit in the advanced college tuition payment program for an 4 eligible beneficiary. Generally, the minimum purchase price is one 5 б percent of the undergraduate tuition and fees for the current year, 7 rounded to the nearest whole dollar, adjusted for the costs of administration and adjusted to ensure the actuarial soundness of the 8 9 account. The analysis for price setting shall also include, but not be limited to consideration of past and projected patterns of tuition 10 11 increases, program liability, past and projected investment returns, and the need for a prudent stabilization reserve. 12

13 **Sec. 2.** RCW 28B.95.030 and 2016 c 69 s 4 are each amended to 14 read as follows:

(1) The Washington advanced college tuition payment program shall be administered by the committee on advanced tuition payment which shall be chaired by the director of the office. The committee shall be supported by staff of the office.

19 (2)(a) The Washington advanced college tuition payment program 20 shall consist of the sale of tuition units, which may be redeemed by 21 the beneficiary at a future date for an equal number of tuition units 22 regardless of any increase in the price of tuition, that may have 23 occurred in the interval, except as provided in subsections (7) and 24 (8) of this section.

(b) Each purchase shall be worth a specific number of or fraction of tuition units at each state institution of higher education as determined by the governing body, except as provided in subsection<u>s</u> (7) <u>and (8)</u> of this section.

(c) The number of tuition units necessary to pay for a full year's, full-time undergraduate tuition and fee charges at a state institution of higher education shall be set by the governing body at the time a purchaser enters into a tuition unit contract, except as provided in subsections (7) and (8) of this section.

(d) The governing body may limit the number of tuition units purchased by any one purchaser or on behalf of any one beneficiary, however, no limit may be imposed that is less than that necessary to achieve four years of full-time, undergraduate tuition charges at a state institution of higher education. The governing body also may,

1 at its discretion, limit the number of participants, if needed, to ensure the actuarial soundness and integrity of the program. 2

(e) While the Washington advanced college tuition payment program 3 is designed to help all citizens of the state of Washington, the 4 governing body may determine residency requirements for eligible 5 б purchasers and eligible beneficiaries to ensure the actuarial soundness and integrity of the program. 7

(3)(a) No tuition unit may be redeemed until two years after the 8 purchase of the unit. 9

(b) Units may be redeemed for enrollment at any institution of 10 11 higher education that is recognized by the internal revenue service 12 under chapter 529 of the internal revenue code. Units may also be redeemed to pay for dual credit fees. 13

(c) Units redeemed at a nonstate institution of higher education 14 or for graduate enrollment shall be redeemed at the rate for state 15 public institutions in effect at the time of redemption. 16

17 (4) The governing body shall determine the conditions under which the tuition benefit may be transferred to another family member. In 18 permitting such transfers, the governing body may not allow the 19 tuition benefit to be bought, sold, bartered, or otherwise exchanged 20 21 for goods and services by either the beneficiary or the purchaser.

(5) The governing body shall administer the Washington advanced 22 college tuition payment program in a manner reasonably designed to be 23 24 actuarially sound, such that the assets of the trust will be 25 sufficient to defray the obligations of the trust including the costs of administration. The governing body may, at its discretion, 26 discount the minimum purchase price for certain kinds of purchases 27 such as those from families with young children, as long as the 28 29 actuarial soundness of the account is not jeopardized.

(6) The governing body shall annually determine current value of 30 31 a tuition unit.

(7) For the 2015-16 and 2016-17 academic years only, the 32 governing body shall set the payout value for units redeemed during 33 that academic year only at one hundred seventeen dollars and eighty-34 two cents per unit. For academic years after the 2016-17 academic 35 36 year, the governing body shall make program adjustments it deems necessary and appropriate to ensure that the total payout value of 37 each account on October 9, 2015, is not decreased or diluted as a 38 result of the initial application of any changes in tuition under 39 section 3, chapter 36, Laws of 2015 3rd sp. sess. committee or governing body provides additional units under chapter 1 36, Laws of 2015 3rd sp. sess., the committee and governing body 2 shall also increase the maximum number of units that can be redeemed 3 in any year to mitigate the reduction in available account value 4 during any year as a result of chapter 36, Laws of 2015 3rd sp. sess. 5 б The governing body must notify holders of tuition units after the adjustment in this subsection is made and must include a statement 7 concerning the adjustment. 8

9 (8) The governing body shall allow account owners who purchased 10 units before July 1, 2015, to redeem such units at the unit cash 11 value price provided that all the redeemed funds are deposited 12 immediately into an eligible Washington college savings program 13 account established by the governing body. Within ninety days of the 14 effective date of this section, the committee, in consultation with 15 the state actuary and state investment board, shall:

16 (a) Establish a period that is not less than ninety days during 17 which eligible purchasers may redeem units at the unit cash value 18 price for the purposes of this subsection; and

19 (b) Establish the unit cash value price. The committee, in 20 consultation with the state actuary and the state investment board, 21 may revalue the unit cash value price established in this subsection 22 (8)(b) up to three times during the ninety-day period in which 23 eligible purchasers may redeem units for the unit cash value price.

(9) The governing body shall promote, advertise, and publicize 24 25 the Washington advanced college tuition payment program. Materials and online publications advertising the Washington advanced college 26 tuition payment program shall include a disclaimer that the 27 28 Washington advanced college tuition payment program's guarantee is that one hundred tuition units will equal one year of full-time, 29 resident, undergraduate tuition at the most expensive 30 state institution of higher education, and that if resident, undergraduate 31 32 tuition is reduced, a tuition unit may lose monetary value.

33 (((-9))) (10) In addition to any other powers conferred by this 34 chapter, the governing body may:

(a) Impose reasonable limits on the number of tuition units orunits that may be used in any one year;

37 (b) Determine and set any time limits, if necessary, for the use38 of benefits under this chapter;

39 (c) Impose and collect administrative fees and charges in 40 connection with any transaction under this chapter;

(d) Appoint and use advisory committees and the state actuary as
 needed to provide program direction and guidance;

3 (e) Formulate and adopt all other policies and rules necessary4 for the efficient administration of the program;

(f) Consider the addition of an advanced payment program for room
and board contracts and also consider a college savings program;

7 (g) Purchase insurance from insurers licensed to do business in 8 the state, to provide for coverage against any loss in connection 9 with the account's property, assets, or activities or to further 10 insure the value of the tuition units;

(h) Make, execute, and deliver contracts, conveyances, and other instruments necessary to the exercise and discharge of its powers and duties under this chapter;

(i) Contract for the provision for all or part of the services
necessary for the management and operation of the program with other
state or nonstate entities authorized to do business in the state;

(j) Contract for other services or for goods needed by the governing body in the conduct of its business under this chapter;

19 (k) Contract with financial consultants, actuaries, auditors, and 20 other consultants as necessary to carry out its responsibilities 21 under this chapter;

(1) Solicit and accept cash donations and grants from any person,governmental agency, private business, or organization; and

(m) Perform all acts necessary and proper to carry out the dutiesand responsibilities of this program under this chapter.

26 **Sec. 3.** RCW 28B.95.045 and 2016 c 69 s 6 are each amended to 27 read as follows:

(1) The committee shall create an expedited process by which owners can complete a direct rollover <u>or investment change</u> of a 529 account from <u>a:</u>

31 (a) ((a)) <u>State-sponsored</u> prepaid tuition plan to a state-32 sponsored college savings  $plan((\tau))$ 

33 (b) ((a)) <u>State-sponsored</u> college savings plan to a state-34 sponsored prepaid tuition  $plan((\tau))$  or

35 (c) ((a)) <u>State-sponsored</u> prepaid tuition plan or a state-36 sponsored college savings plan to an out-of-state eligible 529 plan.

37 (2) The committee shall report annually to the governor and the 38 appropriate committees of the legislature on (a) the number of 39 accounts that have been rolled into the Washington college savings Code Rev/PW:jcm 7 S-4881.1/18 1 program from out of state and (b) the number of accounts rolled out 2 of the Washington college savings program to 529 plans into other 3 states.

<u>NEW SECTION.</u> Sec. 4. This act is necessary for the immediate preservation of the public peace, health, or safety, or support of the state government and its existing public institutions, and takes effect April 15, 2018."

8 On page 1, line 2 of the title, after "programs;" strike the 9 remainder of the title and insert "amending RCW 28B.95.020, 10 28B.95.030, and 28B.95.045; providing an effective date; and 11 declaring an emergency."

<u>EFFECT:</u> Requires the committee on advanced tuition payment, in consultation with the state actuary and state investment board, to establish the unit cash value price. The unit cash value price includes the number of outstanding credits purchased before July 1, 2015, and outstanding credits accrued through the July 2017 unit rebase. Provides a ninety-day window to be set by the committee for withdrawal at the unit cash value price. Modifies effective date of the act to April 15, 2018, and declares an emergency.
