5 An irrigation district must make the following information
6 available upon the request of its customers or taxpayers within its
7 boundaries: An itemized listing of all rates and charges, including
8 the amount of state and local taxes collected and paid by the
9 district, and whether taxes are collected on behalf of other
10 political subdivisions.

11 NEW SECTION. **Sec. 2.** A new section is added to chapter 35.58
12 RCW to read as follows:

13 A metropolitan municipal corporation must make the following
14 information available upon the request of its customers or taxpayers
15 within its boundaries: An itemized listing of all rates and charges,
16 including the amount of state and local taxes collected and paid by
17 the corporation, and whether taxes are collected on behalf of other
18 political subdivisions.

19 NEW SECTION. **Sec. 3.** A new section is added to chapter 54.04
20 RCW to read as follows:

21 A public utility district must make the following information
22 available upon the request of its customers or taxpayers within its
23 boundaries: An itemized listing of all rates and charges, including
24 the amount of state and local taxes collected and paid by the
25 district, and whether taxes are collected on behalf of other
26 political subdivisions.

27 NEW SECTION. **Sec. 4.** A new section is added to chapter 85.08
28 RCW to read as follows:

29 Diking, drainage, and sewerage improvement districts must make
30 the following information available upon the request of its customers

1 or taxpayers within its boundaries: An itemized listing of all rates
2 and charges, including the amount of state and local taxes collected
3 and paid by the districts, and whether taxes are collected on behalf
4 of other political subdivisions.

5 NEW SECTION. **Sec. 5.** A new section is added to chapter 36.58A
6 RCW to read as follows:

7 Solid waste collection districts must make the following
8 information available upon the request of its customers or taxpayers
9 within its boundaries: An itemized listing of all rates and charges,
10 including the amount of state and local taxes collected and paid by
11 the districts, and whether taxes are collected on behalf of other
12 political subdivisions.

13 NEW SECTION. **Sec. 6.** A new section is added to chapter 36.58
14 RCW to read as follows:

15 Solid waste disposal districts must make the following
16 information available upon the request of its customers or taxpayers
17 within its boundaries: An itemized listing of all rates and charges,
18 including the amount of state and local taxes collected and paid by
19 the districts, and whether taxes are collected on behalf of other
20 political subdivisions.

21 NEW SECTION. **Sec. 7.** A new section is added to chapter 36.95
22 RCW to read as follows:

23 Television reception improvement districts must make the
24 following information available upon the request of its customers or
25 taxpayers within its boundaries: An itemized listing of all rates and
26 charges, including the amount of state and local taxes collected and
27 paid by the districts, and whether taxes are collected on behalf of
28 other political subdivisions.

29 NEW SECTION. **Sec. 8.** A new section is added to chapter 57.02
30 RCW to read as follows:

31 Water-sewer districts must make the following information
32 available upon the request of its customers or taxpayers within its
33 boundaries: An itemized listing of all rates and charges, including
34 the amount of state and local taxes collected and paid by the
35 districts, and whether taxes are collected on behalf of other
36 political subdivisions.

1 NEW SECTION. **Sec. 9.** A new section is added to chapter 35.92
2 RCW to read as follows:

3 A city or town operating as a municipal utility under this
4 chapter must make the following information available upon the
5 request of its customers or taxpayers within its boundaries: An
6 itemized listing of all rates and charges, including the amount of
7 state and local taxes collected and paid by the city or town, and
8 whether taxes are collected on behalf of other political
9 subdivisions."

10 On page 1, line 1 of the title, after "districts;" strike the
11 remainder of the title and insert "adding a new section to chapter
12 87.03 RCW; adding a new section to chapter 35.58 RCW; adding a new
13 section to chapter 54.04 RCW; adding a new section to chapter 85.08
14 RCW; adding a new section to chapter 36.58A RCW; adding a new section
15 to chapter 36.58 RCW; adding a new section to chapter 36.95 RCW;
16 adding a new section to chapter 57.02 RCW; and adding a new section
17 to chapter 35.92 RCW."

EFFECT: Requires the above-listed districts to have rate and
charge information available upon request by its customers and
taxpayers within its boundaries, but does not require that
information to be on all billing statements.
