Brief Summary of Bill

• Removes the authority of the state director of Fire Protection to use of the Fire Protection Contractor License Fund to pay for costs associated with hospital fire protection inspections.

Background: <u>Hospital Fire Protection Inspections</u>. The chief of the Washington State Patrol, through the director of Fire Protection (Director), sets and enforces standards for fire protection as they relate to hospitals. Upon receipt of an application for a license to establish, maintain, or conduct a hospital, the Department of Health (DOH) submits a request for an inspection to the Director. The Director then inspects the premises, coinciding with the licensing inspection conducted by the DOH. When a premises does not comply with the required safety standards and fire regulations, the applicant or licensee is required to submit corrections to comply with the standards and regulations. The Director may reinspect a

premises if extensive and serious corrections are required. When a premises meets the required standards and regulations, the Director must submit a written report approving the hospital with respect to fire protection before the hospital can be issued a full license. The Director must inspect licensed hospitals on average at least once every 18 months.

<u>Fire Protection Contractor License Fund.</u> The Director administers licensing and certification requirements, and sets license and certificate fees, for licensed fire protection sprinkler system contractors and fire sprinkler certificate of competency holders. All receipts from license and certificate fees are deposited into the Fire Protection Contractor License Fund. Expenditures from the fund may only be used for:

- costs associated with meeting standards for fire protection and its enforcement, with respect to hospital fire protection inspections;
- providing assistance in identifying fire sprinkler system components subject to recalls or voluntary replacement programs; and
- developing and publishing educational materials related to the effectiveness of residential fire sprinklers.

Summary of Bill: The Director may not use the Fire Protection Contractor License Fund to pay for costs associated with hospital fire protection inspections.

Appropriation: None.

Effective Date: Ninety days after adjournment of session in which bill is passed.

Staff Summary of Public Testimony: PRO: This is an attempt to stop the Legislature from raiding the fund. The fund is paid for solely by licensees. The law was changed to allow the payment of fund for hospital inspections. Before that the fund was robust. After the change, the fund became almost insolvent. We have worked on this with others and it seems like it has been fixed. This will stop this from happening again.
