- 1 AN ACT Relating to employers making gifts based on marital
- 2 status; and amending RCW 49.60.180.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 49.60.180 and 2007 c 187 s 9 are each amended to 5 read as follows:
- 6 It is an unfair practice for any employer:
- 7 (1) To refuse to hire any person because of age, sex, marital status, sexual orientation, race, creed, color, national origin, 8 honorably discharged veteran or military status, or the presence of 9 10 any sensory, mental, or physical disability or the use of a trained 11 dog guide or service animal by a person with a disability, unless based upon a bona fide occupational qualification: PROVIDED, That the 12 prohibition against discrimination because of such disability shall 13 14 apply if the particular disability prevents the proper performance of the particular worker involved: PROVIDED, That this 15 16 section shall not be construed to require an employer to establish 17 employment goals or quotas based on sexual orientation.
- 18 (2) To discharge or bar any person from employment because of 19 age, sex, marital status, sexual orientation, race, creed, color, 20 national origin, honorably discharged veteran or military status, or 21 the presence of any sensory, mental, or physical disability or the

- (3) To discriminate against any person in compensation or in other terms or conditions of employment because of age, sex, marital status, sexual orientation, race, creed, color, national origin, honorably discharged veteran or military status, or the presence of any sensory, mental, or physical disability or the use of a trained dog guide or service animal by a person with a disability: PROVIDED, That it shall not be an unfair practice for an employer to segregate washrooms or locker facilities on the basis of sex, or to base other terms and conditions of employment on the sex of employees where the commission by regulation or ruling in a particular instance has found employment practice to be appropriate for the practical realization of equality of opportunity between the sexes. However, it is not an unfair practice for an employer to provide gifts to employees based on marital status, as long as no individual employee receives a gift valued at more than one thousand dollars in any one calendar year.
- (4) To print, or circulate, or cause to be printed or circulated any statement, advertisement, or publication, or to use any form of application for employment, or to make any inquiry in connection with employment, which expresses any specification, or discrimination as to age, sex, marital status, sexual orientation, race, creed, color, national origin, honorably discharged veteran or military status, or the presence of any sensory, mental, or physical disability or the use of a trained dog guide or service animal by a person with a disability, or any intent to make any such limitation, specification, or discrimination, unless based upon a bona fide occupational qualification: PROVIDED, Nothing contained ((herein shall)) in this subsection prohibits advertising in a foreign language.
