- AN ACT Relating to the creation of a work group to study and make 1 2 recommendations disaster on natural mitigation and resiliency
- 3 activities; and adding new sections to chapter 48.02 RCW.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 NEW SECTION. **Sec. 1.** A new section is added to chapter 48.02 6 RCW to read as follows:
- 7 Residents of this state have been impacted by natural disasters such as floods, landslides, wildfires, and earthquakes and continue 8 9 to be at risk from these and other natural disasters. In 2016, 10 insured losses from natural disasters in the United States totaled 11 almost twenty-four billion dollars. In 2015, this state's wildfire 12 season was the largest in Washington state history, burning more than 13 one million acres and costing more than two hundred fifty-three 14 million dollars. In 2016, almost two hundred ninety-four thousand acres burned in Washington state and there were more than four 15 16 hundred thirty national flood insurance program (nfip) claims filed, 17 totaling over seven million dollars. It is critical that more be done to better prepare this state for disasters and to put in place 18 strategies to mitigate the impacts of the disasters. To address this 19 critical need, the legislature is creating a work group that will 20 21 review disaster mitigation and preparation projects in other states

- 6 RCW to read as follows:
- 7 A working group to study and make recommendations on natural
- 8 disaster and resiliency activities is hereby created. The working
- 9 group membership shall be composed of:
- 10 (1) The insurance commissioner or his or her designee, who shall
- 11 be the chair of the working group;
- 12 (2) One member from each of the four major caucuses of the
- 13 legislature;
- 14 (3) A representative from the governor's resilient Washington
- work group;
- 16 (4) A representative from the Washington state association of
- 17 counties;
- 18 (5) A representative from the association of Washington cities;
- 19 (6) A representative from the state building code council;
- 20 (7) The supervisor of the department of natural resources or his
- 21 or her designee;
- 22 (8) The director of the Washington state military department or
- 23 his or her designee;
- 24 (9) The superintendent of public instruction or his or her
- 25 designee;
- 26 (10) The director of the department of ecology or his or her
- 27 designee;
- 28 (11) The director of the department of commerce or his or her
- 29 designee;
- 30 (12) A representative from the Washington association of building
- 31 officials;
- 32 (13) Two representatives from the property and casualty insurance
- 33 industry, to be selected by the insurance commissioner or his or her
- designee, through an application process; and
- 35 (14) Other state agency representatives or stakeholder group
- 36 representatives, at the discretion of the working group, for the
- 37 purpose of participating in specific topic discussions or
- 38 subcommittees.

- 1 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 48.02 2 RCW to read as follows:
 - (1) The working group will engage in the following activities:
- (a) Review disaster mitigation and resiliency activities being 4 done in this state by public and private entities;
- 6 (b) Review disaster mitigation and resiliency activities being done in other states and at the federal level; 7
- (c) Review information on uptake in this state for disaster-8 related insurance, such as flood and earthquake; 9
- (d) Review information on how other states are coordinating 10 11 disaster mitigation and resiliency work and the work of entities such 12 as the California earthquake authority;
- (e) Review how other states and the federal government fund their 13 14 disaster mitigation and resiliency activities and programs;
- (f) Make recommendations to the legislature and the office of the 15 16 insurance commissioner on:
- (i) Whether this state should create an ongoing disaster 17 resiliency program; 18
 - (ii) What activities the program should engage in;
- 20 (iii) How the program should coordinate with state agencies and 21 other entities engaged in disaster mitigation and resiliency work;
 - (iv) Where the program should be housed; and
- (v) How the program should be funded. 23
