- 1 AN ACT Relating to the definition of veterans of armed conflicts;
- and reenacting and amending RCW 41.04.005.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 **Sec. 1.** RCW 41.04.005 and 2005 c 255 s 1 and 2005 c 247 s 1 are 5 each reenacted and amended to read as follows:
- 6 (1) As used in RCW 41.04.005, 41.16.220, 41.20.050, <u>and</u> 7 41.40.170((, and 28B.15.380)) "veteran" includes every person, who at
- 8 the time he or she seeks the benefits of RCW 41.04.005, 41.16.220,
- 9 41.20.050, or 41.40.170((, or 28B.15.380)) has received an honorable
- 10 discharge, is actively serving honorably, or received a discharge for
- 11 physical reasons with an honorable record and who meets at least one
- 12 of the following criteria:
- 13 (a) The person has served between World War I and World War II or
- 14 during any period of war, as defined in subsection (2) of this
- 15 section, as either:
- 16 (i) A member in any branch of the armed forces of the United
 17 States;
- 18 (ii) A member of the women's air forces service pilots;
- 19 (iii) A U.S. documented merchant mariner with service aboard an
- 20 oceangoing vessel operated by the war shipping administration, the

- office of defense transportation, or their agents, from December 7, 1 1941, through December 31, 1946; or 2
- (iv) A civil service crewmember with service aboard a U.S. army 3 transport service or U.S. naval transportation service vessel in 4 oceangoing service from December 7, 1941, through December 31, 1946; 6 or
- 7 (b) The person has received the armed forces expeditionary medal, or marine corps and navy expeditionary medal, for opposed action on 8 9 foreign soil, for service:
- (i) In any branch of the armed forces of the United States; or 10
- 11 (ii) As a member of the women's air forces service pilots.
- (2) A "period of war" includes: 12
- (a) World War I; 13

- 14 (b) World War II;
- (c) The Korean conflict; 15
- (d) The Vietnam era, which means: 16
- 17 (i) The period beginning on February 28, 1961, and ending on May
- 7, 1975, in the case of a veteran who served in the Republic of 18
- Vietnam during that period; 19
- 20 (ii) The period beginning August 5, 1964, and ending on May 7, 21 1975;
- (e) The Persian Gulf War, which was the period beginning August 22
- 2, 1990, and ending on ((the date prescribed by presidential 23
- proclamation or law)) November 30, 1995; 24
- 25 (f) The War on Terrorism, which means the period between
- September 11, 2001, and ending on the date prescribed by presidential 26
- 27 proclamation or law;
- 28 (g) The period beginning on the date of any future declaration of 29 war by the congress and ending on the date prescribed by presidential proclamation or concurrent resolution of the congress; and 30
- 31 $((\frac{g}{g}))$ (h) The following armed conflicts, if the participant was awarded the respective campaign badge or medal: ((The crisis in 32
- Lebanon; the invasion of Grenada)) Lebanon, the 1958 crisis, 33

- 1984; Dominican Republic, Operation Power Pack; Grenada, Operation 35
