- 1 AN ACT Relating to behavioral rehabilitation services; amending
- 2 RCW 43.88C.010; adding a new section to chapter 43.88 RCW; creating
- 3 new sections; and providing an expiration date.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 NEW SECTION. Sec. 1. The legislature finds that dependent 6 children with high acuity behavioral and mental health needs require robust and consistent behavioral rehabilitation services in order to 7 address their needs and ensure stable, permanent outcomes. 8 legislature also finds that a reliable network of providers 9 10 critical to ensuring our highest needs children receive prompt and 11 appropriate services. Therefore, it is the intent of the legislature that behavioral rehabilitation services rates are established that 12 13 are sufficient to assure there is enough provider capacity to serve 14 the highest needs children.
- NEW SECTION. Sec. 2. (1) The children and families services program, of the department of social and health services through June 30, 2018, and of the department of children, youth, and families effective July 1, 2018, shall facilitate a stakeholder work group in a collaborative effort to design a behavioral rehabilitation services rate payment methodology that is based on actual provider costs of

- 1 care. The work group may consider the findings of a contracted rate
- 2 analysis in designing the methodology. By November 30, 2018, and in
- 3 compliance with RCW 43.01.036, the department of children, youth, and
- 4 families must submit a report with the final work group findings to
- 5 the appropriate legislative committees.

- 6 (2) This section expires December 31, 2018.
- **Sec. 3.** RCW 43.88C.010 and 2015 c 128 s 2 are each amended to 8 read as follows:
 - (1) The caseload forecast council is hereby created. The council shall consist of two individuals appointed by the governor and four individuals, one of whom is appointed by the chairperson of each of the two largest political caucuses in the senate and house of representatives. The chair of the council shall be selected from among the four caucus appointees. The council may select such other officers as the members deem necessary.
 - (2) The council shall employ a caseload forecast supervisor to supervise the preparation of all caseload forecasts. As used in this chapter, "supervisor" means the caseload forecast supervisor.
 - (3) Approval by an affirmative vote of at least five members of the council is required for any decisions regarding employment of the supervisor. Employment of the supervisor shall terminate after each term of three years. At the end of the first year of each three-year term the council shall consider extension of the supervisor's term by one year. The council may fix the compensation of the supervisor. The supervisor shall employ staff sufficient to accomplish the purposes of this section.
 - (4) The caseload forecast council shall oversee the preparation of and approve, by an affirmative vote of at least four members, the official state caseload forecasts prepared under RCW 43.88C.020. If the council is unable to approve a forecast before a date required in RCW 43.88C.020, the supervisor shall submit the forecast without approval and the forecast shall have the same effect as if approved by the council.
 - (5) A councilmember who does not cast an affirmative vote for approval of the official caseload forecast may request, and the supervisor shall provide, an alternative forecast based on assumptions specified by the member.

- (7) "Caseload," as used in this chapter, means: 5
- 6 The number of persons expected to meet entitlement 7 requirements and require the services of public assistance programs, state correctional institutions, state correctional noninstitutional 8 supervision, state institutions for juvenile offenders, the common 9
- school system, long-term care, medical assistance, foster care, and 10
- 11 adoption support;

- 12 (b) The number of students who are eligible for the Washington 13 college bound scholarship program and are expected to attend an institution of higher education as defined in RCW 28B.92.030; 14
- (c) The number of children who are eligible, as defined in RCW 15 16 ((43.215.405)) 43.216.505, to participate in, and the number of 17 children actually served by, the early childhood education and 18 assistance program.
 - (8) The caseload forecast council shall forecast the temporary assistance for needy families and the working connections child care programs as a courtesy.
- The caseload forecast council shall 22 (9) forecast participating in the extended foster care program pursuant to RCW 24 74.13.031 separately from other children who are residing in foster 25 care and who are under eighteen years of age.
- 26 (10) The caseload forecast council shall forecast the number of youth expected to receive behavioral rehabilitation services while 27 involved in the foster care system. 28
- 29 (11) Unless the context clearly requires otherwise, the definitions provided in RCW 43.88.020 apply to this chapter. 30
- NEW SECTION. Sec. 4. A new section is added to chapter 43.88 31 RCW to read as follows: 32
- For the purposes of this chapter, expenditures for behavioral 33 34 rehabilitation services placements must be forecasted and budgeted as
